The Authority after detailed discussion and deliberation decided the following:

- Serial No.1: PP has submitted objections that his representation to relist the proposal
  was rejected by SEIAA without having being afforded an opportunity of being heard.
  The authority decided to examine the objection in further detail and thereafter to call
  the PP for personal hearing before taking a final decision in the matter.
