Annually 2000 cu.m. sand is approved for mining. The proponent shall have to strictly follow all other conditions laid down in the approved mining plan.

The Divisional Forest Officer. Karbi Anglong East Division will ensure due monitoring on the mining operation to avoid occurrence of irregularities during the mining period. The Divisional Forest Officer, Karbi Anglong East Division is requested to redesign the aforesaid mining area for future mining activities as from the current maps etc. it appears that the location is not very practicable for such mining.

Considering the urgency of the Govt. works quoted by the Executive Engineer, PWRD, Brahmaputra Bridge Construction Division the committee recommended for approval of the proposal to extract 83220 cu.m river clay silt from the proposed location with in two years subject to the condition that the proponent shall have to submit detail transport plan for the mined-out materials to the Divisional Forest Officer. Kamrup East Division before starting the actual mining activities. Since the proposed site falls within the limit of the city so all precautionary measures are to be adopted by the proponent while transporting the mining materials to avoid air and other such pollution. In the meeting it is also approved to extract 41610 cu.m. river clay/silt per year strictly following all the terms and condition laid down in the approved mining plan.

The Divisional Forest Officer. Kamrup East Division is requested to approve the transport plan which is to be furnished by the proponent before starting the actual mining activities ensuring to reduce the scope of pollution. He will also ensure due surveillance to avoid occurrences of irregularities during the mining period. Further, he will arrange to mark the proposed site on the ground prior to actual mining activities.

Further, it appears that proposed area taken covering the entire width of the river violating the rule 39(ii) of AMMCR,2013 (which has also mentioned at point 4 on page No. 11 of the approved mining plan). Considering all the aspects discussed above and after detail discussion the committee resolved to ask the proponent to furnish fresh KML file indicating the proposed site as per GPS coordinates and following the rule 39(ii) of AMMCR,2013 in the form of CD to the office of the SEIAA, Assam at the earliest for reconsideration of the project proposal.

It is even noticed that mine closure plan prepared for Fishery Pond in the gravel bed keeping 2.7 mtr. mining depth. Such method appears impracticable and which are to be made practicable on the basis of reality and scientific study.

The above issues have thoroughly been discussed in the SEAC meeting and it is unanimously decided to make a comprehensive report addressing the issues discussed in the foregone para. The Committee resolved to constitute a sub-committee with the following Hon'ble Members of SEAC, Assam to study the issues stated above and submit report suggestingcorrectivemeasures/adviseto communicate to all the RQP's in preparing realistic Mining Plan for river bed mining.
