Resolve of the SEIAA:-

No. 241, dated 15.12.2021) in its Annexure - 'A'.

Proposal discussed in SEIAA: -

In the earlier meeting dated 12.08.2021, the SEIAA decided to Project Proponent, has not submitted an acknowledgment copy of the bank guarantee to SEIAA, Bihar. Two (02) letters have been sent to Project Proponent regarding the submission of the bank guarantee. The Project Proponent has not responded to date. The SEIAA decided to delist/reject the proposal and also to inform the concerned department RERA, Patna to take necessary action in this regard.

Request of Project Proponent: -

The Project Proponent requested on 26th October 2021 "extension of submission of bank guarantee of a total of Rs.110 lakhs under ecological remediation, natural & community resource augmentation" the aforesaid bank guarantee as per the below-stated timeline.

- a) 25 Lakhs by December 2021
- b) 30 Lakhs by February 2022
- c) 55 Lakhs by April 2022.

The Project Proponent also requested on 06th December 2021 to allow the permission for submission of the bank guarantee of Rs. 25 lakhs for the month of December 2021.

Resolve of the SEIAA: -

The Project proponent was allowed to submit a bank guarantee of a total of Rs.110 lakhs by 28th February 2022 SEIAA may withdraw the rejection/delisting of the proposal and issue the Environmental Clearance after submission of bank guarantee.
