The Authority after detailed discussion and deliberation decided the following:

1. **Serial No. 1:** The Authority was of the view that a deeper understanding of this proposal is required specifically there is a confusion in the proposal regarding parking, ECU and 2-wheeler parking are mixed up. Hence, the Authority decided to defer this proposal and decided to call the PP/Consultant for Personal Hearing.
2. **Serial No. 2, 53:** The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to these proposals with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
3. **Serial No. 3, 4, 5, 6, 7, 8, 9, 11, 12, 26, 36, 57, 58:** The Authority accepted the recommendations and decided to grant ToR to these proposals with the additional conditions of SEAC.
4. **Serial No. 10:** In this proposal, crusher of 1500 TPD is being proposed but while examination it was found that no EMP has been given for the same. Hence, the Authority decided to defer this proposal for additional information.
5. **Serial No. 13, 14, 15, 16, 18, 19, 20, 21, 25, 27, 28, 42, 45, 46, 47, 49, 55, 56, 59:** The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.
6. **Serial No. 17, 31, 40:** The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
7. **Serial No. 22 & 23:** In these proposals, Auto-ToR has already been issued. Hence, the Authority decided to close & delist these proposals.
8. **Serial No. 24:** The Authority was of the view that a deeper understanding of this proposal is required specifically there is lack of clarity regarding waste water management in context of the building regulations. Hence, the Authority decided to defer this proposal and decided to call the PP/Consultant for Personal Hearing.
9. **Serial No. 29:** The Authority was of the view that a deeper understanding of this proposal is required specifically with respect to the details of certified Compliance Report of EC. Hence, the Authority decided to defer this proposal and decided to call the PP/Consultant for Presentation.
10. **Serial No. 30:** The Authority accepted the recommendations of SEAC and decided to approve EIA/EMP and grant EC to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and with the condition that the Lol condition regarding kachha rasta shall be adhered to.
11. **Serial No. 32:** The proposal is for Granite Mineral but the DSR is submitted for marble mineral. Hence, The Authority decided to defer this proposal for additional information.



12. **Serial No. 33, 39:** The Authority accepted the recommendations of SEAC and **decided to grant EC to these proposals with the condition that the LoI condition regarding kachha rasta shall be adhered to.**
13. **Serial No. 34:** The Authority accepted the recommendations & additional conditions of SEAC and decided to **grant ToR to this proposal under violation.**
14. **Serial No. 35:** The project was considered in 5.38th meeting of the Authority and was referred back to SEAC for following shortcomings:
- Form 1 online submitted copy
 - Form 2 online submitted copy
 - Calculation of penalty for violation case
 - Project cost is different in presentation and file
- SEAC reconsidered the case in its 5B.35 meeting and after deliberation proposed a Bank Guarantee of Rs. 35,78,483/- and Penalty of Rs. 7, 99,116/- and Rs. 1,00,240/-. But no proper reply was received for other points. Hence, the Authority decided to defer this proposal and directed that PP/Consultant be present for personal hearing/presentation.
15. **Serial No. 37:** After deliberation, the Authority decided to **refer back this proposal to SEAC** on following grounds:
- In ToR letter, Total capacity is **106030 TPA** (Quartz-20,824 T, Feldspar-5180 T, Mica-26 T and Granite- 80,000 T) but EIA, Form 2 & PPT submitted for **143209 TPA** [Quartz- 20824 T & Feldspar – 5180 T, Mica 26 T (waste-1446.5 T & SG- 1446.5 T) and Granite – 114286 T (Granite – 80,000 T & W- 34286 T)]
 - CCR is more than one year old.
 - In abstract, Public Hearing Details are of some other project of Pali.
16. **Serial No. 38:** The Authority accepted the recommendations of SEAC and decided to **approve EIA/EMP and grant EC** to this proposal with the condition that all the lease holders of the cluster shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects and ***with the direction to comply with all the conditions as mentioned in DCF Certificate.***
17. **Serial No. 41, 44, 50, 54:** In these proposals Certified Compliance report of EC is more than one year old from the date of inspection. Hence, the Authority decided to **defer these proposals for additional information.**
18. **Serial No. 43, 48:** The Authority accepted the recommendations of SEAC and **decided to grant EC to this proposal with the direction to comply with all the conditions as mentioned in WRD Certificate.**
19. **Serial No. 51 & 52:** These proposals were listed in 5A.39 SEAC-1 meeting, in which it was recommended by SEAC to reject the proposals due to the reasons mentioned in

SEAC 5A.39 meeting minutes. However, the Authority was of the view that it is appropriate to afford an opportunity of representation/Personal Hearing to PP to explain as to why the recommendations of SEAC may not be accepted. Hence, the Authority decided to defer these proposals.

20. **Serial No. 60:** In this proposal, it has come to the notice that production has been exceeded from the granted capacity as mentioned in EC. Hence, the Authority decided to grant Transfer of EC to this proposal with a direction to project proponent to apply for ToR under violation within next 30 days failing which action shall be initiated against the project proponent.
21. **Serial No. 61, 63, 66:** The Authority accepted the recommendations of SEAC and decided to grant Transfer of EC to these proposals.
22. **Serial No. 62:** In this proposal, it has come to the notice that past production certificate has not been submitted and copy of EC is not legible. Hence, the authority decided to defer this proposal for additional information.
23. **Serial No. 64 & 65:** In these proposals, it has come to the notice that production has been exceeded from the base year. Hence, the authority decided to grant Transfer of EC to this proposal and directed the PP to apply for ToR under violation within next 30 days failing which action shall be initiated against the PP.
24. **Serial No. 67:** This proposal was considered in 5.56 Meeting of SEIAA and was deferred on account of "*The proposal is for Granite Mineral but the DSR submitted for Sandstone Mineral*". PP has submitted the DSR of Granite. therefore, the Authority decided to accept the recommendation of SEAC and grant EC to this proposal.
25. **Serial No. 68:** This proposal was considered in 5.54 Meeting of SEIAA and was deferred on account of "*Revised Cluster Certificate*". PP has submitted the revised cluster certificate dated 06/01/2023 (area: 26.3772 ha). therefore, the Authority decided to accept the recommendation of SEAC and grant EC to this proposal.
26. **Serial No. 69:** This proposal was considered in 5.55 Meeting of SEIAA and was deferred, as the "*LoI of the applied area had expired*". Now, the PP has submitted the copy of Lease Agreement dated 20/10/2022. Hence, the Authority decided to grant EC to this proposal.
27. **Serial No 70:** This proposal was considered in 5.55 Meeting of SEIAA and was rejected stating that "*In this proposal, PF is at a distance of 27 m. The Authority was of the view that such closeness to forest area is detrimental to environment*".

PP submitted the chronology of lease and requested the Authority to re-consider the proposal. Considering his request, the Authority once again re-considered the proposal in presence of PP. After deliberation, the Authority was of the view that this is an existing lease since 1988 and hence a legal right of the project proponent has been created.




The PP submitted during the personal hearing that the renewal of the mining lease was rejected in November, 2000 against which an appeal was filed and the lease was renewed in 2019. Subsequent to which he applied for EC. Hence, the Authority keeping in view of the submission made by the project proponent and recommendation made by the SEAC decided to **grant EC to this proposal with the condition to construct a pucca wall throughout the lease boundary for separation of mining lease area from the forest. Also, the PP must ensure that corner pillars be constructed along the whole plot for mining and transportation for mining will not be allowed in the forest area.**

28. Serial No. 71: This proposal was considered in 5.56 Meeting of SEIAA and was deferred, as the "CCR was more than one year old". Now, the PP has submitted the copy of recent certified compliance report. Hence, the Authority decided to **grant EC to this proposal.**

29. Serial No: 72: This proposal was considered in 5.55 Meeting of SEIAA and was rejected stating that *"In this proposal, Pillar A & B of the lease area is attached to forest area, pillar C is at a distance of 1 m and Pillar D is at a distance of 6 m from the forest land. The Authority was of the view that such closeness to forest area is detrimental to environment"*.


PP submitted the Lease documents and requested the Authority to re-consider the case. Considering his request, the Authority once again re-considered the case in presence of PP. After deliberation, the Authority was of the view that the mining lease area partially infringed in the forest area and that such closeness to forest area is detrimental to environment. Hence, the Authority decided to **uphold its decision taken in its 5.55th meeting.**
