The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in 5.93 meeting of SEIAA since "PP has not submitted any documentary proof regarding submission of BG earlier. Considering the fact, the Authority is if the view that the earlier case in which EC was issued in August, 2022 needs to be examined that why the penalty was not imposed under violation. The same may be done and all details in this regard may be put up in the meeting".
Now, PP has submitted an application vide letter dated 09/10/2023 stating that earlier they have not submitted the BG of 3.15 Lac and assured to deposit the BG and penalty

now at the earliest.

Hence, the Authority decided to grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 63,646 /- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 3.15 lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.

Serial No. 2, 9, 10, 13, 14, 15, 16, 17, 18, 19, 20, 21, 24, 25, 26, 29, 31, 32, 33, 34, 35, 36, 37, 39, 40, 41, 42, 43, 44, 45, 46: The Authority accepted the recommendations of SEAC and decided to grant EC to these proposals.





- 3. Serial No. 3, 23: The Authority decided to close & delist these proposals.
- 4. Serial No. 4: This proposal involves offices and shops for which no parking provisions has been provided. Also, Conceptual plan mentions that the proposal will involve construction of a single block but in building maps provided, two towers are marked. Hence, the Authority decided to call PP for personal hearing to explain parking provisions for offices and shops in the complex and also to explain the reason for proposing one block as mentioned in Form 1 and two towers as shown in maps.
- 5. Serial No. 5, 6: In these proposals, size of flats has not been furnished for calculation of parking provisions. Hence, PP may be called to explain the parking provisions in light of the order issued by SEIAA dated 15.9.2023.
- 6. Serial No. 7: The Authority decided to defer this proposal to seek clarification on following discrepancies, within 45 days:
  - i. PP/ Consultant in this proposal has mentioned construction of single block with B+S+6+11 floors at S. No. 18 in Form-1 whereas in the same Form at S. No. 5, it is mentioned that construction of 4 blocks will be done.
  - Permission has been provided to construct B+S+9 floors as per the approved building plan letter dated 16.2.2022 whereas the proposal is for construction of B+S+G+11 floors.
  - iii. As per the certificate of DCF Wildlife Mukundra National Park dated 25.3.22, Project is located within the ESZ of Chambal hariyal WLS at a distance of 4.5 km from Wildlife Sanctuary. It further mentions necessary permission is required to be obtained with respect to ESZ.

Since the proposed project is located within the ESZ of Chambal Ghariyal WLS, hence PP/ Consultant is required to obtain permission from NBWL as per OM dated 17.5.2022 of MoEF&CC.

- Serial No. 8: The Authority accepted the recommendations of SEAC and decided to grant of EC for expansion and revision of group housing project.
- Serial No. 11, 12: The Authority accepted the recommendations of SEAC and decided to grant ToR under violation to this proposal.
- 9. Serial No. 22: Certified Compliance Report dated 12.4.22 submitted in this proposal is more than a year old. Mining Plan of this proposal has also expired. Hence, the Authority decided to defer this proposal for submission of latest certified compliance report, approved and valid mining plan within 45 days.

- 10. Serial No. 27, 28, 30: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with a direction that PP shall adhere to his commitment submitted with the proposal to plant 10 trees in place of 1 tree whenever it is uprooted in unavoidable situation.
- 11. Serial No. 38: The Authority accepted the recommendations of SEAC and decided to grant EC to this proposal subject to submission of receipt of conservation plan submitted to the concerned DFO Office.
- 12. Serial No. 47: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal with the condition to include planting of Khejri in the development of Green Belt.
