▶ Resolve of the SEIAA:-

In view of the consideration of SEAC and its recommendation to grant of Extension of Environmental Clearance (EC), the SEIAA resolved to grant Extension of EC till the time specified with the conditions that the sand mining shall be limited to one meter only for the above listed sand ghats. The other specific and general conditions, except the mining depth, as contained in the original Environmental Clearance shall be applicable to this Environmental Clearance extension, apart from the extant guidelines and court orders. The Project Proponent must ensure that no mining activity is carried out in the active channels and stabilized islands of the river. And, if the concerned sand ghat is located in the Eco-Sensitive Zone of any Protected Area (Wildlife Sanctuary / National Park / Tiger Reserve, etc.), no mining should be carried out. The project proponent must take all necessary measures to check illegal sand mining. The sand mining should be carried out in strict compliance of all the relevant extant guidelines of the Government, applicable Acts / Rules and the order of the Hon'ble Courts / Tribunals, for the protection of environment. No mining should be carried out beyond the limits of the concerned sand ghats which are included in the District Survey Report of the concerned District. The grant of Extension of Environmental Clearance is in light of the order passed by the Hon'ble Supreme Court of India on 15.12.2022 in I.A. No. 197500 of 2022 in Civil Appeal No. 3661-3662/2020.
