The Authority after detailed discussion and deliberation decided the following:

- Serial No. 1: Proposal was deferred in 5.66th meeting of SEIAA for "DSR submitted by PP/ Consultant in this proposal is for Marble in instead of proposed mineral and uploaded KML is not accessible". Now, PP has submitted the correct DSR and KML. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- Serial No. 2 & 3: Proposals were deferred in 5.66th meeting of SEIAA for "Cluster certificates provided by PP/ Consultant is more than a year old". Now, the PP has again submitted the same copy of Cluster certificate dated 07/09/2021, which is not acceptable. Hence, the Authority decided to reject these proposals.
- Serial No. 4: The proposal was close & delisted in 5.43<sup>rd</sup> meeting of SEIAA and was
  relisted on the request letter dated 27.02.2023 by PP. Now, the Authority decided to
  refer back this proposal for re-examination.
- Serial No. 5, 21, 26, 40: The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
- 5. Serial No. 6, 7, 17, 38, 39: The Authority accepted the recommendations & additional conditions of SEAC and <u>decided to approve EIA/ EMP and grant EC</u> to these proposal with the condition that the issues raised in public hearing are to be implemented by all the lease holders of the cluster and they shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects
- Serial No. 8, 9, 10, 11, 12, 13, 14, 15, 16, 18, 19, 20, 22, 23, 24, 27, 28, 29, 30, 32, 33, 34, 37, 41, 45, 46: The Authority accepted the recommendations as well as the additional conditions of SEAC and decided to grant EC to these proposals.
- Serial No. 25: The Authority accepted the recommendations of SEAC and <u>decided to grant ToR to this proposal</u> with the condition to submit revised DCF certificate and Cluster Certificate at the time of EC.
- Serial No. 31: The Authority, after detailed deliberation <u>decided to refer back</u> this proposal to SEAC on account of the following points:
  - SEAC has mentioned that it is a case of violation as production increased from granted capacity. However, no penalty and BG has been proposed and recommended by SEAC for approval of EIA/EMP and EC.
  - 2. No authenticated production figures are given for 2022-23.
  - 3. Past production figures from 2018 to 2022 are not duly authenticated; instead, Annual E-Return has been submitted.

4. Compliance report letter is more than a year old.

Meanwhile, PP has also submitted revised Remediation Plan, Annual E-Return (2018-2022) & CA certificates to SEIAA, which may also be forwarded to SEAC with the proposal.

Hence, the Authority directs SEAC to re-examine the proposal on technical grounds and submit its recommendations specifically in respect of the observations of SEAC.

- Serial No. 35: In this proposal, Modified Mining Scheme has expired. Hence, the Authority decided to <u>defer this proposal for additional information to be submitted</u> within 45 days.
- 10. Serial No. 36: The Authority, after detailed deliberation decided to refer back this proposal to SEAC on account of the following points:
  - In submitted Form I area is mentioned as 3.0024 ha. and in other documents it is 1.51 ha.
  - In DCF BHILWARA certificate dated: 18/04/2022, Plot no. 220 is mentioned in place of 221 and area is mentioned as 04.1029 ha. in place of 1.51 ha.

In fact, SEAC is expected to examine these aspects during the examination detailed scrutiny and examination of the proposal and get the shortcomings rectified within a finite time, before sending the file to SEIAA for final decision.

11. Serial No. 42: Since this mine falls in Aravalli Hills, SEAC had sought opinion from SEIAA. SEIAA in its 5.49th meeting held on 02/11/2022 had considered the facts of the case in detail and sent back the case back to SEAC with its reasoned opinion, in light of previous decisions of the Authority in similar kinds of cases, that there seems no apparent reason to deny grant of ToR to this Proposal. However, SEAC without any application of mind, and in complete disregard to the Authority's opinion, has recommended this case for Close & Delist on the feeble plea that the mine falls in Aravalli hills.

The Authority <u>rejects the recommendations of SEAC</u>, for reasons stated above, and decides to grant ToR to this proposal under violation.

- 12. Serial No. 43: The Authority, after detailed deliberation, <u>decided to refer back</u> this proposal to SEAC on account of the following points:
  - 1. No certified production certificate for year 2021-2022 have been provided.
  - Penalty calculation changed in assessment report and revised CA certificate, without any justification.
  - 3. Two different CA certificates given for penalty calculation.

PP has submitted revised CA Certificate, revised NV Report, revised Mining Plan & revised WRD Certificate to SEIAA, subsequent to examination of the case by SEAC. The Authority decided to refer back the proposal to SEAC to re-examine the proposal on technical grounds and send to SEIAA with its specific recommendations after reexamination.

- 13. Serial No. 44: SEAC has recommended this proposal for Close & Delist on the basis of reasons stated in the ecommendations, mainly on account of its contention that the mine falls in Aravalli Hills. The Competent Authority i.e., Mining Department, Government of Rajasthan, has issued certificate that the lease area is not in violation of the order of Hon'ble SC. The facts of the case are also similar to certain other similar cases wherein the Authority has accorded such permissions. Accordingly, the Authority rejects the recommendations of SEAC, which has been provided without due application of mind, and decides to grant ToR to this proposal.
- 14. Serial No. 47, 49, 50, 51: The Authority decided to grant Transfer of EC to these proposals.
- 15. Serial No. 48: In this proposal, it has come to the notice that production has exceeded from the base year. Hence, the authority decided to grant Transfer of EC to this proposal and directs the PP to apply for ToR under violation within next 30 days, under intimation to RSPCB, failing which action shall be initiated against the PP.
