1. **Case No:- 5884/2019** Prior Environmental Clearance for **Dundi Laterite and Ochre Deposit** (opencast mechanized method) in an area of 26.00 Ha. (1,91,707.2 TPA) at khasra no. 34, at Village- Dundi, Tehsil - Dhimarkheda, Dist. - Katni (MP) by Shri Priyank Agrawal, Kamania, Gate Gali, Malviyaganj ward, Murwara, Dist. - Katni, MP – 483501.
 - (1) This is a project pertaining to mining of **Dundi Laterite and Ochre Deposit** in MLA of 26.00 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project. It was submitted that this is a proposed mine having valid lease for 30 years with production capacity of Laterite-1,62,792 TPA & Ochre-28915.20 TPA.
 - (2) It was reported by the PP that the lease was granted in favor of Shri Priyank Agrawal for 05 years.
 - (3) SEAC in its 407th meeting dtd. 26.11.2019 has recommended the case with 34 special conditions for issuance of EC.
 - (4) The case was then discussed in 589th SEIAA meeting dtd. **13.12.2019** and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
 - (5) The proposed plantation program was examined and it was found that total 43,550 saplings of tree species covering an area of 15838 sqm shall be planted at the end of conceptual stage.
 - (6) Initially, dense plantation shall be developed along the site boundary (in three rows) to provide additional protection in one year only as recommended by SEAC.
 - (7) It was noted that the water requirement is 13.0 KLD (2.0 KLD for drinking & domestic purpose +11.0 KLD for mining purpose - 8.0 KLD for mining & allied + 3.0 KLD for afforestation will meet from nearby villages as well as mine sump along with collected rain water in the working pit.
 - (8) It was also noted that the Public Hearing was carried out on 16.10.2019 at mine site, Village- Dundi, Tehsil - Dhimarkheda, Dist. - Katni (MP) under chairmanship of Collector, Katni.

- (9) Based on the recommendation of 407th SEAC meeting dtd. 26.11.2019, presentation made by the PP in SEIAA & SEAC, **it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**

- I. Before commencing any mining activity, fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- III. PP shall not start mining activity before execution of lease agreement.
- IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- V. Plantation shall be carried out as per the plantation programme. Total 43,5500 plants will be planted including suitable tree species i.e. Neem, Mango, Pipal, Bargad, Gulmohar, Shisham, Kachnar, etc along transportation route, BF + dump area & Green Belt area **shall be ensured by PP on priority.**
- VI. Haul road shall be compacted on regular interval and transportation road will be made pucca (tar road) and shall be constructed prior to operation of mine.
- VII. For dust suppression, regular sprinkling of water should be undertaken.
- VIII. No blasting shall be carried out.
- IX. PP shall ensure to construct garland drain & settling tanks as recommended by SEAC.
- X. Transportation of minerals shall not be carried out through forest area.
- XI. No mine water shall be discharged outside of the lease and zero liquid discharge shall be maintained.
- XII. No intermediate stacking is permitted at the mine site.
- XIII. No dump shall be stacked outside the lease area.
- XIV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.
- XV. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVI. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVII. PP must ensure the implementation of following activities with separate budget provision of total Rs. 1,50,000/- for 5 years under CER:
 1. ❖ Under the instruction of district collector, need base contributions for

social welfare for at least 3 to 4 nearby villages as construction and repairing of community toilet, filtered drinking water arrangement, repairing of school rooms, distribution of benches, contribution for the development of infrastructure for village health center.

❖ Every year will arrange traffic awareness training camp.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Gram Panchayat.

- XVIII.** PP should ensure to submit half yearly compliance report, Plantation and CER activity report along with photographs of all activities in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.

(51414 cum per annum) (Khasra No. 18 Part), Village - Navegaon, Tehsil - Chhindwara, Dist. - Chhindwara (MP) by Shri Rishi Mishra, A-Block, 3/5 Dutt Arcade, Civil Lines, Jabalpur, MP- 482001.
- (1) This is a project pertaining to mining of **Navegaon Stone Quarry** in MLA of 8.0 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. and more than 250 m from the forest boundary. Thus it is not attracted by the general conditions and falls under category '1 (a)' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environmental clearance for the project. It was submitted that this is a proposed mine having valid lease for 10 years with production capacity of 51,414 cum per annum stone.
 - (2) It was reported by the PP that the lease was granted in favor of Shri Rishi Mishra for 10 years.
 - (3) SEAC in its 407th meeting dtd. 26.11.2019 has recommended the case with 33 special conditions for issuance of EC.
 - (4) The case was then discussed in 589th SEIAA meeting dtd. **13.12.2019** and PP/Consultant was invited for presentation. Thereafter, PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
 - (5) The proposed plantation program was examined and it was found that total 8,100 saplings of tree species shall be planted during the lease period.

- (6) Initially, dense plantation shall be developed along the site boundary (in three rows) to provide additional protection in one year only as recommended by SEAC.
- (7) It was noted that the water requirement is 7.0 KLD (1.5 KLD for drinking & domestic purpose + 4.0 KLD for mining & allied purpose and 1.5 KLD for green belt development) will meet from nearby villages. Besides this, rain water will be collected in the working pit which will be used for dust suppression & plantation purpose.
- (8) It was also noted that the Public Hearing was carried out on 12.10.2019 at mine site, Village - Navegaon, Tehsil - Chhindwara, Dist. - Chhindwara (MP) under chairmanship of Additional Collector, Chhindwara.

 - II. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
 - III. PP shall not start mining activity before execution of lease agreement.
 - IV. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
 - V. Plantation shall be carried out as per the plantation programme.  - IX. PP shall ensure to construct garland drain & settling tanks as recommended by SEAC.
 - X. Transportation of minerals shall not be carried out through forest area.
 - XI. No mine water shall be discharged outside of the lease and zero liquid discharge shall be maintained.

- XIII. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XIV. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XV. PP must ensure the implementation of following activities with separate budget provision of total Rs. 2,00,000/- under CER:
 - 1. **1st year:** Overhead water tanker of 1 KLD with 0.5 HP water pump at primary school of Navegaon for drinking water facility.
 - 2. **2nd year:** Maintenance of school boundary & toilets.
 - 3. **3rd year:** Making plaster & earth work of primary school of Navegaon.
 - 4. **4th year:** Maintenance work of PHC of nearby village Navegaon.
 - 5. **5th year:** Arrangement of table chair in 1 classroom of primary school for 30 students of village Navegaon.

Every year will arrange Traffic Awareness Training.

The modification to the above activities can be made with the permission of the district administration and need based activity for the development of nearby villages shall be implemented by PP in consultation with the District Collector and Gram Panchayat.

- XVI. PP should ensure to submit half yearly compliance report, Plantation and CER activity report along with photographs of all activities in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.
