The Authority after detailed discussion and deliberation decided the following:

1. Serial No. 1: Proposal was deferred in 5.95th meeting of SEIAA, held on 15.9.23, "to seek clarification from Chief Wildlife Warden, whether in view of various rulings of Hon'ble Supreme Court, Hon'ble NGT and notifications issued by MoEF&CC, this project can be permitted to carry out mining operations in GIB Arc area. Meanwhile, PP may be asked to submit the past production figures from 2018 to till date, duly certified by the Mining Department."
Now, PP has submitted the requisite details/documents. Hence, The Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP and grant EC subject to the outcome of D.B Civil (PIL) Writ Petition No. 11086/2023 pending in the Hon'ble High Court, Jodhpur

and PP must ensure the compliance of conditions imposed by Hon'ble Supreme Court (I.A. No. 85618/2020 in Writ Petition (civil) No. 838/2019), NGT New Delhi (O.A. No. 385/2019) and NGT Bhopal (O.A. No. 63/2016) along with the condition that PP shall also ensure to raise a dense plantation in the

7.5m green belt around the lease area to mitigate the pollution effects.

2. Serial No. 2: Proposal was deferred in the 5.87th meeting of the Authority held on 14.7.2023 for obtaining enquiry report and certificate duly authenticated by CCF, Bikaner. Since, "In this proposal, DCF, Churu has issued two certificates vide letter dated 19/10/2022 and 13/01/2023 with two different distances for the nearest forest from the lease boundary i.e., 40 m and 52 m, respectively".

Now, PP has submitted the requisite details/documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

3. Serial No. 3: Proposal was deferred in the 5.105th meeting of SEIAA as "PP was directed to submit revised parking plan to incorporate the 200 ECUs parking provisions, as stated in the proposal. Moreover, PP has not submitted the desired certificate from WRD as sought by SEIAA".

Now, PP has submitted the requisite details/documents. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to **grant EC** to this proposal.

4. Serial No. 4: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>approve DSRs for mineral Bajri Mining of Dausa</u>, Bhilwara, Udaipur, Jaipur, Sirohi and Dholpur district.

- Serial No. 5, 7, 30, 42, 43: The Authority decided to <u>defer</u> these proposals till the final outcome of the stay order imposed by Hon'ble Supreme Court in W.P (C) No. 1394/2023 titled Vanashakti vs. Union of India dated 02.01.2024.
- Serial No. 6, 8, 9, 11, 16, 17, 18, 22, 23, 24, 25, 26, 27, 28, 29, 31, 33, 34, 35, 36, 37, 38: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals.
- Serial No. 10, 12, 14, 15, 19, 44, 45, 46, 47: The Authority accepted the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- Serial No. 13: The Authority accepted the recommendations of SEAC and decided to grant TOR to this proposal.

 - In cluster MP, production capacity is 7,17,397 TPA (ROM) but proposed capacity is 7,23,992 TPA (ROM) [Proposed capacity is higher than the capacity granted in approved cluster Mining plan]
 - The Cluster area in granted TOR & Cluster certificate is 7.2335 ha but EIA has been carried on 7.0936 ha, area

Now, PP has submitted the clarification/document. Hence, the Authority decided to approve EIA/EMP for 7,17,397 TPA (ROM) as per Approved Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also

- ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 13. Serial No. 49, 50, 51, 52: The Authority decided to grant Transfer EC to these proposals.
- 14. Serial No. 53, 54: The Authority decided to grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days, subject to the outcome of W.P (C) No. 1394/2023 titled Vanashakti vs. Union of India. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- 15. Serial No. 55 to 74: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
