The representative of the project proponent Sri K. Sathi Reddy and Sri G.V. Reddy of M/s. Team Labs & Consultants, Hyderabad attended and made a presentation before the SEAC.

The proponent informed that earlier the lease was granted on 08.09.2011 in favour of the proponent for a period of 15 years. It may be noted that the Mine Lease was granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 3.0 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village Badeshaguda (V) exists at a distance 0.51 km from the proposed site; nearest water body (Cheruvu) exists at 1.49 km (NW); Nearest RF i.e., Kesaragutta RF exists at 1.70 km from the boundary of the site.

It is proposed to mine 2,12,884 m<sup>3</sup>/annum of Rough Stone & Road Metal and the life of mine is reported as 5.3 years.

The total cost of the project is Rs. 30.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 4.15 lakhs and recurring cost: Rs. 2.41 Lakhs/annum.

The proponent informed that earlier the lease was granted on 27.08.2004 in favour of the proponent for a period of 20 years (i.e., upto 12.10.2024). It may be noted that the Mine Lease was granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 2.0 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The representative of the project proponent Sri M. Pavan Kumar and Sri Chandrasekhar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

The project is proposed with in 10 km radius of Himayat Sagar and Osman Sagar Lakes. But, Kokapet (V) is not included in the list of 84 villages in the 10km catchment of above lakes as mentioned in the G.O.Ms. No: 111, MA, dt. 08.03.1996.

Earlier, the SEIAA, TS issued EC vide order dt. 01.02.2020 for Commercial Office Building Construction project with total Built-up area 1,22,721.70 Sq.m. Subsequently, the SEIAA issued Amendment to EC vide order dt. 24.04.2021 with total Built-up area 1,29,962.08 Sq.m..

Now, the proponent informed that due to changes in project proposal, the total built up area is increasing from 1,29,962.08 Sq.m. to 1,66,052.00 Sq.m.(4B + G + 30 Upper Floors + Terrace Floor). It is noted that construction is under excavation stage. It was requested to issue new EC for revised proposal in place of old EC.

The SEAC noted that earlier the SEIAA issued TORs (Auto generated) dt.02.06.2022 for preparation of EIA Report. Accordingly, the proponent prepared the EIA report and uploaded online.

The SEAC noted that total plot area is 13,047 Sq.m., Net Plot area is 11,063.0 Sq.m.; Out of which green area is 1,109.0 Sq.m. (10.02%)

**Minutes of the SEAC Meeting held on 18.07.2022**

It was informed that the total built up area of the project is 1,66,052.0 Sq.m. The project consists of Commercial / Office Space Building Construction Project. Maximum No. of floors proposed in the project are 4B + G + 30 Floors + Terrace.

It is also noted that Parking area to be provided is 43,087.0 Sq.m., (33.89% against required 22%).

During presentation, the SEAC observed that the site is adjacent to waterbody. In this regard, the proponent submitted a copy of letter dt. 14.08.2020 of the SE, Irrigation Circle, I&CAD dept. It is also observed from the document that out of total extent of applicants land (Ac. 03-09 Gts) the applicant's land to an extent of Ac. 0-09.5 Gts in Sy. No. 101/U/2 is affected in the buffer zone area of 9.00m of the Nala. The balance land to an extent of Ac. 02-39.5 Gts in Sy. No. 101/U/2 & 101/A (Part), Kokapet (V), Gandipet (M), Rangareddy District is not affected in any water body/Nala/Channel and it is free from the water body as per the norms stipulated in the G.O.Ms.No.168, dt.07.04.2012 of MA&UD Dept. Accordingly, the proponent proposed layout of the project.

During presentation, the proponent submitted copy of NOC dt. 24.05.2022 for height clearance from Airports Authority of India w.r.t. the proposed project and submitted copies of the same. It is observed from the NOC that the site elevation is 542.9 mts AMSL, and the permissible top elevation is restricted to 702.9 mts. The SEAC noted that the height of the buildings is within the permissible top elevation restricted by the AAI. The proponent submitted the Risk Assessment report & Disaster Management Plan.

The total cost of the project is Rs.167.0 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 273.0 Lakhs and recurring cost: Rs. 74.0 Lakhs.

After detailed discussions, the SEAC recommended for issue of EC.

During the presentation, it was observed that nala is passing adjacent to the site. The proponent submitted a copy of letter dt. 18.05.2022 of the EE, North Tanks Division, Hyderabad, I&CAD dept. It is also observed from the document that the land in Sy. Nos. 59/A, 59/AA, 59/EE, 82 and 83/A admeasuring 10873 Sq.yards situated at Khajaguda (V), Serilingampally (M), Rangareddy District is not affected by FTL & Buffer of Yellamma Cheruvu as same is 82 mts away from FTL of tank i.e., 52 mts away from buffer of tank, however site is partly affected in buffer zone of inlet of Yellamma Cheruvu to an extent of 125 Sq.yrds. accordingly, the project proponent proposed layout of the project.
