*The representative project proponent has attended the meeting. The project proponent has applied for EC for Dolomite mine -12,39,602.4 TPA. However the proponent requested for the Environmental Clearance for the production quantities 32,500 TPA, as per the approved mining plan.*

*The Committee noted that this is a existing mine and the mine was executed in the year 1997 and noticed that the production quantities are within the permitted capacities. The approved quantity as per the mining plan is 32,500 TPA. The mine lease and mining plan will be valid up to 17.02.2017 only.*

*The project proponent presented the final EIA before the Committee and requested for the EC for the University with total Built up area 1,61,498 Sq.m.*

*After detailed discussions, the Committee recommended for **issue of Environmental Clearance** to M/s. K.L. University for the total Built up area 1,61,498 Sq.m (existing constructed built up area and proposed construction built up area 21,868 Sq.m ) by stipulating the standard conditions and the solid waste management as per the MSW Rules, 2016, applicable for Township and Area Development projects.*

**Decision of SEIAA:** The MoEF&CC vide O.M. dated 9<sup>th</sup> June 2015, clarified that the Notification No. S.O. 3252 (E) dated 22.12.2014 provides exemption to buildings of educational institutions including universities from obtaining prior Environment Clearance under the provisions of the EIA Notification, 2006 subject to sustainable environmental Management. In case of medical universities/institutes the component of Hospitals will continue to require prior Environment Clearance. The total water consumption is 8 KLD, i.e., for dust suppression – 2 KLD, green belt development – 2 KLD and Domestic consumption – 4 KLD. The domestic wastewater generation is 3.6 KLD.*

At no time, the particulate emissions should exceed 50 mg/Nm<sup>3</sup>. The DG sets of capacity 1 x 750 KVA shall be provided with adequate stack height, as per CPCB norms".*

*Specific Condition No. (b) (i). "The source of water is Bore well. Total water requirement is 8.0 KLD and the domestic effluents shall be disposed into septic tank followed by soak pit."*

*The Committee noted that this issue was earlier discussed in the 74<sup>th</sup> SEAC, A.P. meeting held on 18.03.2015 and recommended that the Project Proponent shall submit application for EC for total extent of leases with the approved comprehensive mining plan by combining all 5 (five) Road Metal & Building Stone units duly incorporating the dump yards. But they have not submitted the common application for EC.*

*Out of 5 above proposals, one of these mines having lease area less than 5 Ha (i.e., 4.838 Ha), comes under the purview of DEIAA as per the MoEF&CC Notification, dated 15.01.2016.*

*The EC compliance reports for 3 mines (23.868 Ha., 13.881 Ha., & 24.423 Ha) received from the Regional Office, Chennai, MoEF&CC vide lrs dated 10<sup>th</sup> November, 2016. The Committee re-appraised this project proposal and observed that there are no major violations on production levels except small omissions which can be communicated as directions to the project proponent i.e., duly incorporating as special conditions in the EC order.*

*Hence the Committee recommended for issue of **transfer of EC** for the said 3 Road metal mines i.e., 23.868 Ha., 13.881 Ha., & 24.423 Ha duly stipulating the necessary conditions noticed by MoEF&CC, Regional Office, Chennai. For the 4<sup>th</sup> Road metal mine – 7.287 Ha., the project proponent shall furnish the certificate of compliance from the MoEF, Regional Office, Chennai and for the 5<sup>th</sup> road metal mine -4.838 Ha, the project proponent shall approach the DEIAA for further processing.*
