- 8. Serial No. 25: In this proposal, EC has not been obtained till date and the PP has exceeded production from the base year. While SEAC has stated that it is not a case a violation, the Authority is of the view that production had not started prior to EIA Notification 2006 and, therefore this may be a case of violation. Hence, the Authority decided to <u>defer</u> this proposal in light of the O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 and to await further instructions from MoEFF&CC in this regard.
- 9. Serial No. 26, 28, 32, 71, 76: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>approve EIA/EMP and grant EC</u> to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.

No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF&CC regarding stay imposed by Hon'ble Supreme Court in W.P.(C) No. 1394/2023 titled Vanshakti vs. Union of India, with reference to the SOP dated 7th July 2021 and OM dated 28th January 2022.
- 13. Serial no. 80: The Authority accepted the recommendations of SEAC to grant EC to the project with the change that the proviso suggested by SEAC for air quality monitoring that "PP shall install 24x7 CAQMS as soon as the existing plant exceeds the threshold of 200 TPD" not be incorporated since PP himself has applied for permission for 300 TPD plant.
- 14. Serial no. 81: The Authority decided to <u>defer</u> this proposal and decided to call PP for personal hearing to get detailed presentation on parking provisions as well as Solid Waste Management of the project.

15. Hon'ble Supreme court, in W.P.(C) No. 1394/2023 titled Vanshakti vs. Union of India, has stayed the OMs dated 07.07.2021 and 28-01-2022 issued by MoEF&CC wherein provisions of penalty and remediation plan were provided to regularizeviolation cases. In view of the direction of the Hon'ble SC and O.M. No. IA3-3/4/2024-IA.III [E 230791] dated 08.01.2024 issued by MoEF&CC in this regard, all such violation cases are being deferred by SEIAA till further orders are received in this regard.

In the PIL filed before the Hon'ble Supreme court, the issue raised is that if prior EC is required, and work is done without it, why should there be regularization of violation cases. In view of the matter being sub judice it is important that in all such violation cases wherein SEIAA has deferred them till further orders, on account of aforementioned directions, PP shall not be permitted to continue with the activities in respect of such violation on the plea that EC has been applied for, since it defeats the very purpose for which the PIL has been filed i.e., "Prior EC" under the provisions of EIA Notification, 2006.

Therefore, in all above category Building & Constructions projects, directions be issued to RSPCB to ensure that construction is halted at its current stage of violation. Similarly, for mining and other projects, the project activities are restricted to the production capacity and other conditions as specified in the EC issued earlier. In all projects where no EC has been issued, project activities be halted completely at its present stage.

A list of all such cases in which SEIAA has deferred the cases on account of violation be sent to RSPCB and case wise compliance be obtained within next 15 days. The same may be done in future for all such deferred cases.
