#### Resolve of the SEIAA:-

In view of the consideration of SEAC and its recommendation to grant of Environmental Clearance (EC), the SEIAA resolved to grant EC with standard conditions in addition to special conditions (as imposed by the SEAC in its MoM (Ref. No. 317, dated 11.07.2022) i.e. in addition, provide modalities for Rainwater harvesting (100%) which could be used for sprinkler system, install sprinklers for cooling the tank, establish manual fire alarm system apart from the automatic alarm system, conduct mock alarm drill at every six months and latest report should be submitted to SEAC, Few important mobile numbers/contact numbers needed in case of emergency should be displayed at the entry gate and corners of the industry, there should be fire control system, enough number of First-Aid Box as emergency medicines, stretcher, Mask, Sanitizer etc. away from the plant area at the entry and exit gates, there should be emergency exit in the premises, sand bags should also be placed at appropriate places, Formaldehyde carrying pipes to the storage tank should be checked on weekly interval, Faunal study (Birds, Reptiles and Mammalian diversity) should be carried out at every year and a consolidated report should be submitted along with the environmental statement by the industry to SEIAA, Bihar, B.S.P.C.B. and Regional office

MoEF&CC, GoI, Insect (Butterfly) park should be developed within the campus in an area of 50 feet x 50 feet, Automatic Sprinkler system must be installed near storage tank and operational unit. It should start working immediately/automatically in case of any leakage or increase in temperature In addition, provide modalities for Rainwater harvesting (100%) which could be used for sprinkler system, Coal handling plant must be improved /upgraded as per rule and must not be done in open place to check fugitive emission.
