- (1) This is a project pertaining to mining of Limestone, Laterite & Reject Stone Mine in MLA of 4.047 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary/Biosphere Reserve etc. thus it is not attracted by the general conditions and falls under category 'B-1' by virtue of its location and mining lease area. There is no forest boundary within 250 m. from ML area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period upto 05.06.2052 with production capacity of 50,000 TPA of limestone, laterite & reject stone mine.
- (1) The lease was initially granted for 20 years from 06.06.2002 to 05.06.2022 and the lease area comes under Govt. land over an area of 4.047 Ha. This is a case of new mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM Vide Letter No. - MP/Satna/Limestone/RMP -76/2018-19 5160 dated 10.06.2019. Laterite Scheme of Mining 10342 has been approved on 01.08.19.
- (2) PP has produced an order of the Mineral Resources Deptt. GoMP dtd. 03.09.2015 in which after hearing the case the State Govt. has established that action be taken according to the latest circular No. 19-5-2015/12/1 dtd. 12.03.2015, which states that "all mining leases granted before the commencement of the Mines & Minerals (Development & Regulation) Amendment Ordinance 2015 shall be deemed to have been granted for a period of fifty years".
- (3) It was reported by the PP that the first lease was granted in favor of Sanjeev Kumar Pathak for 20 years from 06.06.2002 to 05.06.2022 but after the enforcement of Govt. circular dated 12.03.2015, now the lease have been extended upto 50 years (05.06.2052).
- (4) SEAC in its 419<sup>th</sup> SEAC meeting dtd 24.01.2020 has recommended the case with 41 special conditions for issuance of EC.
- (5) It was noted that as per DFO L.No. 4548 Satna, dtd. 14.08.2015, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. There is no forest boundary within 250 m from mining site.
- (6) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (7) It was noted that the water requirement is 9.0 KLD (4.0 KLD for Dust Suppression + 3.0 KLD for plantation + 2.0 KLD for Domestic purpose) which shall be met from mine sump as well as from dugwell/ borewell.
- (8) The proposed plantation programme was examined and it was found that 5000 saplings shall be covered under plantation program.
- (9) It was also noted that the Public Hearing was carried out on 17.06.2019 at Mine Parisar Village - Lakhanwah, Tehsil - Rampur Baghelan, District - Satna (MP) under Chairmanship of Upper Collector, Satna.

**After detailed discussions and perusal of recommendations of 419<sup>th</sup> SEAC meeting dtd 24.01.2020, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Lease agreement shall be carried out before execution of mining operation.
- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. PP shall demarcate a barrier zone of 7.5 m as no mining zone in the periphery of mining lease area and develop a green belt. Three rows plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- V. PP will plant 3 years old 5000 saplings of suitable tree species like Neem, Peepal, Bargad, Sheesham, Amla, Mango, Karanj, Gulmohar, Mahua etc. 1000 plant species will be planted in Green Belt area and along the transportation route within six months and submit the compliance report in SEIAA otherwise EC will be revoked. The rest of the plants (4000 plants) will be planted in BF area, Green belt area & along transportation route during lease period.
- VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.
- VII. The overburden and waste will be stacked for five years and simultaneously backfilled in the mined out area where plantation will be raised on it.
- VIII. No overburden will be dumped outside the mine lease area.
- IX. Regular water quality monitoring shall be carried out by PP before discharging it into the nearby agriculture fields from authorized laboratory in consultation with Regional Officer, MPPCB. Regular air and noise quality monitoring shall also be carried out at regular interval.
- X. PP shall ensure generation of employment opportunities nearby Village on priority bases.
- XI. Payments of wages to the workers shall be done in consonance with the provisions in the labour laws.
- XII. Proper infrastructure with shelter, drinking water, toilet and first-aid facilities shall be provided for the laborers. A provision should be made to construct a pakka rest shelter along with toilet and drinking water facility.
- XIII. PP should also carry out regular sprinkling in the mining lease area to arrest dust emission from mining activities affecting the nearby agriculture fields.
- XIV. Mining shall be limited to the area as shown in surface plan and as per the approved mining scheme.

- XV. PP shall ensure the proper water supply arrangements for plantation especially in summer season.
- XVI. PP shall ensure proper implementation of plantation, dust suppression, construction of approach road and maintenance of existing pakka road as part of Environmental Management Plan. Additional budget provision shall be made as part of EMP.
- XVII. PP must ensure implementation of the following activities with separate budget provision of total Rs. 1,00,000/- (@ Rs. 2.00 Lakhs/year) under CER as committed:
- a) 1<sup>st</sup> year – Hand pump installation and water supply during summer season (Village – Lakhanwah); Vocational training for drilling, blasting, operation of HEMM and Organizing traffic rule training (Village – Lakhanwah, Bamhauri, Tihai and Kotar); Maintenance of play ground in school and aid for infrastructure (Furniture etc.) (Village – Lakhanwah); and Regrassing in Charnoi Bhumi (Village – Lakhanwah).
  - b) 2<sup>nd</sup> year – Hand pump installation (Village – Bamhauri) and water supply (Village – Lakhanwah); Vocational training for drilling, blasting, operation of HEMM and Organizing traffic rule training (Village – Lakhanwah, Bamhauri, Tihai and Kotar); Maintenance of play ground in school and aid for infrastructure (Furniture etc.) (Village – Kotar); and Regrassing in Charnoi Bhumi (Village – Kotar).
  - c) 3<sup>rd</sup> year – Hand pump installation (Village – Tihai) and water supply (Village – Lakhanwah); Vocational training for drilling, blasting, operation of HEMM and Organizing traffic rule training (Village – Lakhanwah, Bamhauri, Tihai and Kotar); Maintenance of play ground in school and aid for infrastructure (Furniture etc.) (Village – Tihai); and Regrassing in Charnoi Bhumi (Village – Tihai).
  - d) 4<sup>th</sup> year – Hand pump installation (Village – Kotar) and water supply (Village – Lakhanwah); Vocational training for drilling, blasting, operation of HEMM and Organizing traffic rule training (Village – Lakhanwah, Bamhauri, Tihai and Kotar); Maintenance of play ground in school and aid for infrastructure (Furniture etc.) (Village – Lakhanwah); and Regrassing in Charnoi Bhumi (Village – Lakhanwah).
  - e) 5<sup>th</sup> year – Hand pump installation (Village – Lakhanwah) and water supply (Village – Lakhanwah); Vocational training for drilling, blasting, operation of HEMM and Organizing traffic rule training (Village – Lakhanwah, Bamhauri, Tihai and Kotar); Maintenance of play ground in school and aid for infrastructure (Furniture etc.) (Village – Kotar); and Regrassing in Charnoi Bhumi (Village – Kotar).

- XVIII. PP should ensure to submit half yearly compliance report, Plantation and CER activity report along with photographs of all activities in MP-SEIAA. If PP is failed to upload or submit two consecutive half yearly compliance reports of EC conditions to concerned authority (SEIAA and Regional Office, MoEF&CC, Gol, Bhopal) than prior environmental clearance issued to PP will automatically be treated as cancelled/ revoked as per OM No. 930/SEIAA/2019 dated 30.05.2019 issued by MPSEIAA.

- (1) This is a project pertaining to mining of **Limestone & Dolomite** Mine in MLA of 1.518 ha. The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National Park /Sanctuary/Biosphere Reserve etc. thus it is not attracted by the general conditions and falls under category 'B-1" by virtue of its location and mining lease area. There is no forest boundary within 250 m. from ML area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine having valid lease period upto 05.03.2037 with production capacity of 89302 TPA.
- (2) The lease was initially granted for 10 years from 06.03.1987 to 05.03.1997 and the lease area comes under Govt. land over an area of 1.518 Ha. The Mining lease plan was first renewed for 20 years period from 06.03.1997 to 05.03.2017. The Mining Plan was earlier approved under Rule 24 of MCR 1960 for renewal of Mining Lease for 20 years period vide letter no. M.P./Jabal/Lime/MPLN/R-9/1997-98 dated 07.10.1997. This is a case of new mining lease. The Mining Plan with progressive mine closure plan has been approved by IBM, Jabalpur Vide Letter No. - MP/Katni/Limestone/M.Sch-12/2015-16/3874 dated 21.07.2015.
- (3) PP has produced an order of the Mineral Resources Deptt. GoMP dtd. 03.09.2015 in which after hearing the case the State Govt. has established that action be taken according to the latest circular No. 19-5-2015/12/1 dtd. 12.03.2015, which states that "all mining leases granted before the commencement of the Mines & Minerals (Development & Regulation) Amendment Ordinance 2015 shall be deemed to have been granted for a period of fifty years".

- (5) It was noted that as per DFO L.No. 5339 Satna, dtd. 08.09.2015, the National Park/Sanctuary is not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted. There is no forest boundary within 250 m from mining site.
- (6) PP/Consultant made a presentation on all aspects of the project and all concerned issues were discussed in detail.
- (7) It was noted that the water requirement is 7.0 KLD (4.0 KLD for Dust Suppression + 1.0 KLD for Green Belt + 2.0 KLD for Domestic purpose) which shall be met from mine quarry where water is already stored and from nearby Gram Panchayat.
- (8) The proposed plantation programme was examined and it was found that total 1600 saplings shall be covered under plantation program.
- (9) It was also noted that the Public Hearing was carried out on 28.08.2019 at Mine Parisar Village - Amehta, Tehsil - Vijayraghgarh, District - Katni under Chairmanship of Collector, Katni.

**After detailed discussions and perusal of recommendations of 419<sup>th</sup> SEAC meeting dtd 24.01.2020, it was decided to accept the recommendation of SEAC for grant of prior EC to the project subject to the following specific conditions:**

- I. Before commencing any mining activity fencing shall be carried out all around the lease area. Proper watch and ward arrangements should be made with installation of signage at 4 corners of lease area to avoid any untoward incident involving public and animals by the PP.
- II. Lease agreement shall be carried out before execution of mining operation.
- III. Plantation programme as mentioned in EIA/EMP and presented during presentation in SEIAA & SEAC shall be followed in content and spirit.
- IV. PP shall demarcate a barrier zone of 7.5 m as 'no mining zone' in the periphery of mining lease area and will develop a green belt. Three rows plantation shall be carried out in the greenbelt area in current year with proper watering arrangement.
- V. PP will plant 3 years old 1600 saplings of suitable tree species like Neem, Peepal, Bargad, Karanj, Khmer, Dalbergia Sissoo, Amla, Gulmohar, Mango, Mahua, Bel, Munga, Sagwan, Sheesham, Labher, Ashok, Palm, Aaron rod etc. in ML area, outside ML area along road side and open area. 1000 plant species will be planted in Green Belt area and along the transportation route within six months and submit the compliance report in SEIAA otherwise EC will be revoked. Remaining plants will be planted in 2 years.
- VI. The mining operation shall be restricted to above ground water table and in no case it should intersect the ground water table. In case of working below the ground water table approval of the Central Ground Water Board shall be obtained.

- (1) This is a project pertaining to mining of Stone Mine in MLA of 13.0 ha The activity is mentioned at S.No. 1 (a) of the Schedule of EIA Notification 2006 as amended from time to time. The project is reported to be at a distance of more than 10 km from National park and sanctuary etc. thus it is not attracted by the general conditions and falls under category 'B-2' by virtue of its location and mining lease area. The case was forwarded by SEIAA to SEAC for appraisal of EIA for environment clearance for the project. It was submitted that this is a proposed mine with production capacity 328967 cum/year.
- (2) It was reported that the lease area of 13.0 ha. This is a new case. The lease period is 10 years from 20.01.2016 to 19.01.2026,
- (3) SEAC in its 420th SEAC meeting dtd 27.01.2020 has recommended the case with 40 special conditions for issuance of EC.
- (4) The proposed plantation programme was examined and it was found that 15000 sapling of tree species shall be covered under plantation.
- (5) It was noted that as per Forest Conservator Letter no. 2163 dated. 04.11.2015, the National Park/Sanctuary are not located within 10 Km., radius from the mining site. Hence, the General Conditions are not attracted.
- (6) It was noted that the water requirement is 10.5 KLD (3 KLD for Dust Suppression + 2.0 KLD for Domestic + 5.5 KLD for Green Belt) which shall be met from bore well and hand pump.
- (7) It was also noted that the Public Hearing was carried out on 16.12.2019 at Mine Parisar Village- Bedar, Tehsil - Maharajpur, Dist. Chhatarpur under Chairmanship of Upper Collector, Tikamgarh.
