- 1. The locations of the well sites have to be provided and the EIA study will address the environmental issues separately for each well site locations within the Block requested for permission.

- 3. The details about blowout prevention measures are to be included.
- 4. The contingency plan of environmental restoration for any accidental release of the drilling fluid and mud to the surroundings has to be included along with details about compensation to the affected people.
- 5. The detailed land use/land cover maps are to be prepared for an area of 1km radius around each of the well sites on the basis of analysis of 5m resolution multispectral satellite images. The relief map for the same are also to be prepared based on 1 suitable stereo image.
- 6. For the Environmental Management Plan (EMP) the aforesaid thematic map must have to be considered.
- 7. The shape files of the land use/land cover plan are to be provided.
- 8. As the habitations and several schools are very near to the well sites, the noise suppression measures are to be included in the EIA.
- 9. The company shall have to submit 6 monthly compliance reports to the SEIAA.
