Agenda Item No.-1

Harinagar Sugar Mills Ltd. (HSM), Village:- Harinagar, Tehsil:- Ramnagar, District:- West Champaran, State:- Bihar, Seeking EC for Capacity Expansion from 10,000 TCD to 11,500 TCD (Proposal No. - SIA/5(j)/523/18) Online Proposal No.:- SIA/BR/IND2/25875/2018) in the same premises without any additional installations.

The proposal has been appraised and recommended for grant of Environmental clearance by the SEAC in its sitting of 28.12.2018 with usual terms and conditions.

The SEIAA also noted the followings -

1. In public hearing no adverse comment other than traffic congestion and dust pollution were raised. District Magistrate West Champaran suggested regular water sprinkling on main transport route and yards where vehicles assemble, wait, remain parked & leave the yard.
2. During sugarcane transportation from field to the unit some part of transportation – route passes through Valmiki Tiger Reserve (VTR). Due to transportation road get damaged and dust pollution increases. The road requires regular maintenance which is presently done by authorities of VTR.

After due discussion, the SEIAA resolved to grant EC with the following additional conditions:-

- Either the SEIAA or any member of the SEIAA may undertake special inspection of unit during its running condition and if required may add additional EC stipulations.

- Period of validity of Environmental Clearance – 7 years.
- As per EIA report unit to follow zero liquid discharge commitment.
- The Project proponent shall prepare a scheme of sugarcane harvest in consultation with Field Director VTR in such a manner so that harvest starts from distant part and sugarcane removal at the edge of VTR is reached at the later stages keeping probable Man-Animal conflict at its lowest.
- The portion of the road from sugarcane fields to HSM falling outside of VTR will be maintained by HSM regularly and the portion of the road falling within the jurisdiction of VTR will be maintained by VTR administration for which funds will be provided to VTR, if asked for.


Taking these facts into consideration and recommendation of SEAC, SEIAA resolves to grant EC with all usual as well as above additional conditions.
