


The Authority after detailed discussion and deliberation decided the following:


1. **Serial No. 1:** The Authority had granted ToR with public consultation to this proposal in the 5.88th meeting held on 27.07.23. PP has submitted a letter dated 17.8.23 from Chief Airport Officer with a request *"to grant ToR corrigendum and include the reference of para 7 III (ii) (b) of EIA, 2006 along with a public consultation statement"*. The Authority was of the view that this proposal requires further examination in respect of the grounds on which the application has been made and precedents given.

Hence the Authority decided to defer this proposal.


2. **Serial No. 2:** This proposal was deferred in 5.88th meeting of the Authority for submission of revised DCF Mandsaur certificate mentioning distance of lease area from the ESZ boundary of Gandhi Sagar WLS and additional information on conservation plan submitted to DCF Kota only, not to DCF Mandsaur. PP has submitted a certificate from DCF Mandsaur which mentions that the lease area is at a distance of 5 km from the boundary of ESZ. PP has also submitted a receipt of conservation plan which has been submitted to DCF Kota with enclosure to DCF Mandsaur and seal of the same. Hence, the Authority decided to **approve EIA/ EMP and grant EC** to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects along with the conditions laid down by SEAC.
3. **Serial No. 3:** This proposal was deferred in 5.88th meeting of the Authority regarding clarification on khasra no. being 32, 877/31 mentioned in form 1 and affidavit of cluster EMP implementation. PP in his reply dated 17.8.23 admitted it as a typographical mistake and submitted the corrected form 1 and affidavit. Hence, the Authority decided to **approve EIA/ EMP and grant EC** to this proposal. PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects along with the conditions laid down by SEAC.



4. **Serial No. 4:** This proposal was deferred in 5.80th meeting of the Authority as the WRD certificate dated 10.4.23 didn't state anything on whether lease area is infringing upon with the directions of Hon'ble High court of Rajasthan or not. Now, PP has submitted a WRD certificate dated 21.7.23 which says, "*Lease are will not infringe the directions of Hon'ble High court of Rajasthan in the matter of Abdul Rehman*". Hence the Authority decided to **grant EC** to this proposal.
5. **Serial No. 5:** This proposal was deferred in 5.81st meeting of the Authority for submission of authenticated DSR, certified production figures for 2022-23 and 5.87th meeting subsequently for certified production figures for 2022-23 duly authenticated by Mining Department. The matter has been pending for more than 75 days on account of required information. PP has still not submitted the production figures for 2022-23 duly authenticated by Mining Department. The Authority decided to accord a last opportunity to PP to submit the required information within 30 days failing which project will be closed & delisted. The matter is **deferred** till such time.
6. **Serial No. 6:** This proposal was deferred in 5.84th meeting of the Authority for submission of authenticated DSR of the proposed mineral. Now, PP has submitted the required document. Hence, the Authority decided to **grant EC** (Expansion & Inclusion) to this proposal.
7. **Serial No. 7:** This proposal was deferred in 5.88th meeting of the Authority for clarification on reference number and revised cluster certificate. PP has submitted a revised cluster certificate dated 8.7.23 but has not submitted clarification on reference number. The Authority decided to accord a last opportunity to PP in this meeting. PP is required to ascertain the correct ML reference no. 20221000052410 as per LoI which is also recorded in Form 1, DCF certificate, Affidavit and Mining plan. However, there has been a typographical error in recording the ML Reference no. in the Aravali certificate, Cluster certificate and Simankan report. PP is directed to get the typographical error rectified in the above mentioned documents and submit the same within 45 days. The matter is **deferred** till such time.
8. **Serial No. 8:** This proposal was deferred in 5.72nd meeting of the Authority for submission of latest Certified Compliance Report. Now, PP has submitted the certified compliance report dated 18.8.23. Hence, the Authority decided to **grant EC** to this proposal.
9. **Serial No. 9:** This proposal was closed & delisted in 5.79th meeting of the Authority. PP requested relisting of the proposal vide his letter dated 19.6.23 along with





submission of DCF Certificate and Cluster certificate dated 5.12.22. Proposal was considered in 5.87th meeting of the Authority and deferred since the PP has not submitted the latest certificate. Now, PP vide his letter dated 27.7.23 has submitted latest cluster certificate dated 27.7.23 Hence, the Authority decided to re-list and refer back this proposal to SEAC for examination on technical grounds.

10. **Serial No. 10:** This proposal was deferred in 5.90th meeting of the Authority for submission of CA certified turnover figures, undertaking with respect to mechanical parking and PHED application for water requirement of the proposal. Now, PP has submitted CA certified turnover figures dated 14.8.23, an affidavit dated 16.8.23 with respect to mechanical parking being provided whenever required and another affidavit dated 16.8.23 for obtaining PHED connection and depositing requisite charges for connection.

SEAC has recommended this proposal for grant of EC along with the amount of Rs. 14,50,000/- in reference to Remediation Plan and Natural & Community Resource Augmentation Plan to be deposited to RSPCB in the form of Bank Guarantee, in addition to this penalty of Rs 6,88,000/-. As per the latest CA certificate dated 14.8.23 the penalty amounts to Rs. 7,61,000/- on the basis of considering it is a suo-moto case. Hence, the Authority decided grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 7,61,000/- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 14,50,000/- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project as well as inclusion of the conditions in the EC as spelt out in the 5.90th meeting.

11. **Serial No. 11, 49:** The Authority accepted the recommendations of SEAC and decided to close & delist these proposals.
12. **Serial No. 12, 13, 16, 17, 18, 20, 24, 25, 45:** The Authority accepted the recommendations and additional conditions laid down by SEAC and decided to grant EC to these proposals.
13. **Serial No. 14, 15, 19, 21, 29, 30, 31, 32, 33, 34, 35, 36, 38, 39, 40, 41, 42, 43, 44, 47, 48:** The Authority accepted the recommendations of SEAC and decided to approve EIA/ EMP and grant EC to these proposals. PPs shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects along with the conditions laid down by SEAC.


14. **Serial No. 22:** In this proposal, khasra no. 1617/293 is mentioned in affidavit of PP. However, in rest of the documents, it is 6317/293. Hence, the Authority decided to **defer** this proposal for submission of revised affidavit with correct khasra no. mentioned, within 45 days.
15. **Serial No. 23:** The proposed lease area is at a distance of 1.84 km from the boundary of Mukundra Hill Tiger Reserve. PP/ Consultant has not submitted conservation plan. Hence, the Authority decided to **defer** this proposal for submission of conservation plan within 45 days.
16. **Serial No. 26:** In the lease execution document of this proposal, khasra no. 33 is mentioned and in other documents it is mentioned as 508/04. Hence, the Authority decided to **defer** this proposal for submission of clarification on khasra no. which is to be submitted within 45 days.
17. **Serial No. 27, 28, 51, 52, 53, 54, 55, 56, 57:** The Authority accepted the recommendations of SEAC and decided to **grant amendment in EC** to these proposals.
18. **Serial No. 37:** SEAC has recommended to approve EIA/EMP and grant EC to this proposal along with bank guarantee of **Rs. 49,50,000/-** for remediation plan, natural resource augmentation plan & community augmentation plan and a penalty of **Rs. 18,33,158/-**.

Hence the Authority decided to **approve EIA/EMP and grant EC** to this proposal with the condition that the PP shall ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects. **The EC is granted subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 18,33,158 /- by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 49,50,000 /- towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.**

19. **Serial No. 46:** In this proposal the DSR submitted is of Sandstone instead of Quartz & Feldspar. Hence the Authority decided to **defer** this proposal for correct DSR.
20. **Serial No. 50:** In the provided KML of this proposal, proposed lease area falls within and adjacent to the forest area. Hence, the Authority decided to **defer** this proposal with a direction to submit revised DCF Certificate. The concerned DCF should physically ascertain the distance in terms of the KML and mention the same in the certificate as well.
21. **Serial No. 58:** The Authority decided to **grant Transfer EC** to this proposal.





22. Serial No. 59: The Authority decided to grant Transfer EC to this proposal with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
23. Serial No. 60, 61, 62, 63, 64, 65: The Authority decided to grant Transfer EC to these proposals with a direction that since the ECs were issued by DEIAA, the concerned PP shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
