At the onset the Chairman, SEAC Offer his thanks to the Honorable Member Shri B.P Duarah, Dr. G.C Sarma & Prof. S Phukan for successfully conducting field visit to the sites proposed by the NHIDCL and M/S Joyshree Assam Industries and furnishing their site inspection reports in time.

Resolution 6/1: The minutes of the 5th meeting of SEAC, Assam held on 27th August, 2020 was placed on the table for perusal and after a brief discussion the resolutions adopted there in are unanimously approved.

1. EC for collection of sand from "Doomdooma pathar sand MPA" under Dibrugarh Forest Division by M/S R.B Enterprise. SEIAA.1248/2020 (*Proposal no. SIA/AS/MIS/124494/2020*)

Resolution 6/2:

Document of the Project Proposal is examined and after due discussion mining in 0.33 Ha area for collection of 1000 Cu.M of Sand for one Year from Doomdooma Pathar MPA is approved. The mining has to be extracted as per general terms & conditions laid down in the Mining Plan approved by the Geoglogy & Mining Department, Assam. The DFO Dibrugarh Division is requested to ensure that the mining is done strictly as per terms and conditions laid down in the M P approved by the Geology & Mining Deptt. Assam. The DFO, Dibrugarh Division should arrange regular monitoring of the mining process to avoid any irregularities.

On examining the documents furnished by the P.P and after through deliberation the committee approved the project proposal to issue EC allowing to extract 5,35,000 Cu.M of stone for 5 years period i.e 1,07,000Cu.M per year. Extraction of minerals (stone) from the river bed will not go beyond the depth of 3 mtr from the unmine top level of river bed. The mining operation has to be conducted strictly following the terms and considerations laid down by the Geology & Mining deptt, Assam in the Mining Plan. The DFO Cachar Division should ensure that the mining operation is done following the statutory conditions to avoid any irregularities. Both the DFO Cachar Dvn and the P.P be informed accordingly.

On examining the documents submitted by the P.P and after through discussion the committee approved the project proposal for issue of EC allowing to extract 5,35,000 Cu.M of river bed stone for a period of 5 (five) year i.e annual extraction target is fixed 1,07,000 Cu.M Extraction of mineral (stone) from the river bed will not go beyond the depth of 3 mtr from the unmine top level of river bed. The mining operation has to be conducted strictly following the terms and condition laid down by the Geoglogy and Mining Deptt, Assam in the Mining Plan. The DFO Cachar Dvn should ensure that the mining operation is done strictly following the statutory conditions to avoid any irregularities. Both the DFO, Cachar Division the P.P be informed accordingly.

the Mining Plan approved by the Geology and Mining Deptt. Assam. The DFO Dibrugarh Dvn should ensure regular monitoring of the mining operation to avoid occurrence of any irregularities and to take measures accordingly.

The committee examined the documents furnished by the P.P Sir Joydeep Goala for collection of sand from "Chiri river Mining Contact area unit 2" located in the Chiri River Bed under Cachar Forest Divn. It is observed that EC was issued dt 28/07/2014 for a period of 5 (five) years to collect Sand 9000 Cu,M per year though the validity of the mining plan was for 7 years. The P.P has applied for extension of the EC for another two years on the basis of the M.P submitted. The matter is reviewed by the DFO, Cachar Division and recommended for extension of the EC for another two years to extract 9000Cu.M of Sand per year although the P.P requested for 9000 Cu.M of sand per year. But, the DFO Cachar Dvn. recommended 9000 Cu.M of sand for two years. The committee approved the proposal allowing to extract 9000Cu.M Sand for two years i.e 4500 Cu.M per year strictly adhering to the conditions laid down by the Geology and Mining Deptt, Assam. The DFO, Cachar Division has to ensure regular monitoring of the mining operation to avoid occurrence of irregularities.

15. Extension of EC Extracted of Sand from "Chiri River Minor Mineral Unit (Stone) Under Cachar Dvn, Silchar by Sri Joydeep Goala .SEIAA 1337/2020 (Proposal No. SIA/AS/MIS/168930/2020)

Resolution 6/16:

The Committee examined the documents furnished by the P.P Sir JoyDeep goala for extraction of stone from "Chiri River Minor Mineral unit (stone)" located in the Chiri River Bed under Cachar Division. It is seen that EC was issued dt 28/07/2014 for extraction of stone/gravel 12000 Cu.M per year for 5 years against the mining period approved by the Geology & Mining Deptt, Assam. Now, the P.P applied for extension of the EC for another two years to extract 24,000 Cu.M of stone. The matter is reviewed by the DFO, Cachar Division and recommended to extend the validity of the EC for another two years to extract 24000 Cu.M of stone. Considering the fact stated above and approved Mining Plan, the committee approved the proposal to extend the validity of the EC for another two years to extract 24000 Cu.M stone for two years i.e 12,000 Cu.M per year. The P.P shall have to strictly follow the terms & Conditions laid down in the Mining Plan approved by the Geology & Mining Deptt, Assam. The DFO, Cachar Divn. should ensure regular monitoring of the mining process to avoid occurrence of any irregularities.

On Scrutiny of the project documents furnished by the P.P are found in order. The Order of the Honorable Guwahati High Court dtd.25/02/2015 relating to the mining area in question has also been seen. Considering the above, as well as the demand of building/ construction materials of the Govt. agencies, the Committee approved the proposal for issuance of EC in favour of the DFO Cachar Division allowing to extract 51,780 Cu.M of stone for two years fixing annual target for extraction 25890 Cu.M. of stone. The P.P has to follow all the statutory conditions laid down by the Geology & Mining Deptt, Assam as approved in the M.P. In addition to above the mining must not exceed one meter depth from the un mined level but not below water level of the river. Mining should also be restricted 15 mtr. away from the high bank. The materials to be extracted should exclusively be used to meet the demand of the Govt. Deptt. Farther, before initiating mining operation the P.P shall have to collect NOC from the Chief Wildlife Warden, Assam relating to the mining operation.

Resolution 6/19:

The project proposal submitted by the Division Forest Officer, Cachar Division, Silchar for extraction of stone from the "Madhura River Stone Quarry Block no.1" has been discussed. The project documents furnished by the Divisional Forest Officer, Cachar Divn. is scrutinized and found in order. The Order of the Honorable Guwahati High Court dtd.25/02/2015 relating to the mining area in question has also been observed. Considering the above, as well as the demand of building/ construction materials of the Govt. agencies, the Committee approved the proposal for issuance of EC in favour of the DFO Cachar Division allowing to extract 59,178 Cu.M of stone for two years fixing annual target of extraction 29,589 Cu.M. of stone. The P.P has to follow all the statutory conditions laid down by the Geology & Mining Deptt, Assam as approved in the Mining Plan. In addition to the above mining must not exceed one meter depth from the un mined level but not below water level of the river. Mining should also be restricted 15 mtr. away from the high bank. The materials to be extracted should exclusively be used to meet the demand of the Govt. Deptt. Farther, before initiating mining operation.

Resolution 6/20:

The project proposal is discussed. In the mean time as resolved by the SEAC, a subcommittee comparing Dr. G.C Sarma and Prof.Sarat Phukan visited the proposed site on 11/09/20 and submitted their field visit report on 19/09/2020. The report already submitted by the P.P in connection with the RESIN Manufacturing Industry including the EIA report is discussed in the meeting. On deliberation and considering the field inspection report, the committee asks clarification as well as probable measures to be adopted by the PP as additional points in TOR, which are also to be incorporated in the EIA report.

On receiving the additional clarification and incorporation in the final EIA reports the committee will consider the project for issuance of TOR (additional information).

The SEAC Members have decided to ask for the following information in addition to EIA Report submitted already.

- (i) Details of Solid wastes that will be generated during operation: Type of waste, possible Composition and amount etc.
- (ii) Details of liquid waste that will be generated during operation: Type of waste, Composition and amount etc.
- (iii) Details of scheme of solid and liquid waste treatment/ management plan, recycling plan including criteria for selecting vendors for the purpose.
- (iv) Details of plan of plantation activities to establish green zones which should start simultaneously with the construction activities.
- (v) Details of safeguards against spillage of waste liquid to the surrounding.
- (vi) Details of safeguards against leakage of hazardous gases, if any to the atmosphere.
- (vii) Details of firefighting measures

20. Proposal For "Development of Multi- Modal Logistic Park Project at Jogighopa and External Trunk Connectivity Infrastructure to the MMLP" TOR by NHIDCL. SEIAA.1255/2020 (proposal no. SIA/AS/MIN/50932/2020)

Resolution 6/21:

The project proposal submitted by the NHIDCL has been discussed. A preliminary physical presentation was given by the P.P in the 4th SEAC meeting held on 13th August/2020. A sub-committee was constituted composing the honorable member of SEAC Prof. P.K Saikia, Prof. S. Phukan & Prof. R. Mahanta to have a field/site visit, but due to Covid 19 pandemic Prof P.K Saikia and Prof. R Mahanta could not move for field visit. Subsequently, another subcommittee is reconstituted comprising Prof. S Phukan and Prof. B.P Duarah who have visited the site on 5th Sept 2020 and submitted their report on 19/09/2020. Going through all the report /documents, the committee resolved and approved for issuance of TOR for the project.

All the statutory condition should be included in the TOR. In addition to the following additional points are also to be included with a request to furnish suitable measure/clarification proposed by the P.P in the project as indicated in field inspection report. Simultaneously we may ask the concerned authority to conduct public hearing and submit report accordingly for taking onward needful action.

The additional points to be included are noted below:

Examine details of land use/land cover as per Master Plan and land use/land cover around 10km radius of the project site. Mapping and analysis of land use/land cover should be based on satellite images of 5m resolution and extensive fieldwork. The land use/land cover mapping must be done based on visual interpretation of satellite images in GIS platform and not be based on digital image interpretation (supervised/unsupervised/object-oriented image etc. classification). The shape files are to be submitted along with the EIA report.

- Submit details of environmentally sensitive places, land acquisition status, rehabilitation and resettlement of communities/villages and present status of such activities.
- Examine baseline environmental quality along with projected incremental load due to the project.
- Environmental data to be considered in relation to the project development would be (a) land, (b) groundwater, (c) surface water, (d) air, (e) biodiversity, (f) noise and vibrations, (g) socio economic and health.
- A detail study of the aquatic flora and fauna of the water bodies and low-lying areas around the
 project site must be done for pre- and post-monsoon seasons of the year. Examine details of
 possible effects of the activities related to construction and operation of the proposed project
 on the aquatic flora and fauna of the surrounding.
- Submit copies of elevation contour map (0.2m resolution), slope map and drainage map of the Project site and its immediate surroundings of 1 (one) K.M buffer zone. Drainage map, a Slope and aspects map is to be prepared for a buffer zone of 10(Ten) K.M. Shape file of these data are also to be submitted. Any obstruction by the construction and operational activities of the proposed project on these natural aspects must also be shown.
- Submit details of the trees to be felled for the project.
- Submit details of any plan for land use/land cover change in the project site and the surrounding and necessary permission required for any conversion of the existing land use/ land cover.
- Submit roles and responsibility of the developer etc. for compliance of environmental regulations under the provisions of EP Act.
- Groundwater classification as per the Central Ground Water Commission.
- Examine details of source of water, water requirement, use of treated waste water and prepare a
 water balance chart. The developer should avoid utilization of groundwater as the project cite is
 endowed with rich sources of surface water. The effluent water must be treated and recycled
 and not to be released to the surrounding as there is a rich community aquatic flora and fauna
 in there.
- Rain water harvesting plans should be made with safeguards for groundwater quality. Maximize recycling of water and utilization of rain water. Examine details.
- Examine soil characteristics and depth of groundwater table for rain water harvesting along with suitable plan.
- Examine details of solid waste generation, treatment and its disposal.
- Examine and submit details of use of solar energy and alternative source of energy to reduce fossil fuel consumption.

- DG sets are likely to be used during construction and operational phase of the project. Emissions
 from DG sets must be taken into consideration while estimating the impacts on the atmosphere.
 Examine and submit details.
- Examine road/rail connectivity to the project site and impact on the traffic due to the proposed project. Present and future traffic transport facilities for the region should be analyzed with measures for preventing traffic congestion, accident, law & order troubles and providing faster trouble-free system to reach different destinations on every direction of the project site.
- A detailed traffic and transportation study should be made for existing and additional projected passenger and cargo traffic.
- Examine the details of transport materials for construction which should include source and availability.
- Examine separately the details of construction and operation phases both for the Environmental Management Plan and the Environmental Monitoring Plan with cost and parameters.
- Submit details of a comprehensive Disaster Management Plan including emergency evacuation during natural and man-made disasters.
- Details of litigation pending against the project, if any, with direction/order passed by any Court
 of Law against the project should be given.
