

**MINUTES OF THE 13<sup>TH</sup> MEETING OF STATE LEVEL ENVIRONMENT IMPACT  
ASSESSMENT AUTHORITY (SEIAA) HELD ON 27<sup>TH</sup> JULY, 2017 AT PARIBESH  
BHAVAN**

The thirteenth meeting of the State Level Environment Impact Assessment Authority (SEIAA) was held on 27<sup>th</sup> July, 2017 in the Conference Room of West Bengal Pollution Control Board, Paribesh Bhavan, 10A, LA Block, Sector – III, Salt Lake, Kolkata-700106. Following cases were discussed:

**I. Cases for Final Environmental Clearance**

- 1. Application for Environmental Clearance for the proposed expansion of installation of 2X20 MT Induction Furnace with Ladle Refining Furnace and 1,00,000 TPA Rolling Mill at Village – Gopalpur, P.S. Kanksa, Mouza – Bamunara, Dist. Burdwan, West Bengal by M/s. Alaknanda Sponge Iron Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

- 2. Application for Environmental Clearance for the proposed manufacturing unit of synthetic resins viz. Unsaturated polyester resin (G P resin) and alkyd resin having production capacity of 12 TPD (300TPM) at Village – Belmuri, P.S. Dhaniakhali, Mouza – Chhota Khanpur, J.L. No. 192, District – Hooghly, West Bengal by M/s. Nataraj Hydrocarbons Pvt. Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

- 3. Application for Environmental Clearance for the proposed 4X20 T Induction Furnaces with matching ladle refining furnaces, continuous billet casting machine along with Hot Rolling Mill at Plot No. AB, AC & AB1, Plasto Steel Park, Vill – Ghutgoria, P.S.- Barjora, Dist. – Bankura, West Bengal by M/s. SRMB Srijan Pvt. Ltd.**

The Authority considered the recommendation of SEAC and approved the proposal for Environmental Clearance.

- 4. Environmental clearance application for the proposed residential complex “Tolly Towers” at 3, Netaji Subhas Chandra Bose Road, KMC Ward No. 97, P.S. Regent Park, Kolkata - 700040 by M/s. Tollygunge Estates Pvt. Ltd.**

The Authority examined the submissions made by the project proponent dated 19.07.2017 and made the following observations :

- i. The position of STP is not clearly shown in the drawing. The detailed plan and sections of the STP showing all levels in a scaled drawing to be submitted, not in an isolated manner but as a part of the building itself.
- ii. As per the Notification No. S.O.3999(E) dated 09.12.2016 of MoEF & CC, GoI, ‘A rain water harvesting plan needs to be designed where the recharge bores of minimum one recharge bore per 5,000 square meters of built up area and storage capacity of minimum one day of total fresh water requirement shall be provided’. Detailed plan and sections of the storage tank with reference to the building line and levels to be submitted.



**5. Application for Environmental Clearance for the proposed expansion of hotel and service apartment complex at premises no. 30-111, plot no. BG-9, AA-1, New Town, P.S. Rajarhat, Dist. North 24 Parganas, West Bengal by M/s. Anik Industries Ltd.**

The Authority examined the recommendation of the SEAC and made the following observations :

- i. It is found that as per earlier EC issued vide No. 2849/EN/T-II-1/091/2014 dated 20.11.2015, the configuration of the proposal of hotel and residential apartment complex was comprising of 5 no. of blocks : A (1B+G+M+8), B(2B+G+M+10), C1(G+12), C2(G+12) and C3(G+12) - 3 towers with **2 common basements**. The present proposal submitted by the project proponent on 02.07.2016 is not tallying with the earlier EC. The project proponent is requested to apply for amendment of earlier EC.
- ii. Details of all dimensions and functional, positional arrangement of STP in the floor plan. Further the project proponent should mention the type (aerobic / anaerobic) of STP and its working principle considering the locational details.
- iii. Site plan showing Land Use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD 2010) & hard copy formats.
- iv. As per the Notification No. S.O.3999(E) dated 09.12.2016 of MoEF & CC, GoI, *'A rain water harvesting plan needs to be designed where the recharge bores of minimum one recharge bore per 5,000 square meters of built up area and storage capacity of minimum one day of total fresh water requirement shall be provided'*. Detailed plan and sections of the storage tank with reference to the building line and levels to be submitted.

**6. Application for Environmental Clearance for the proposed residential complex at premises no. 46A/1, Biplabi Barin Ghosh Sarani, P.O.-Ultadanga, PS - Maniktala, K.M.C. Ward No. - 14, Kolkata - 700 067, West Bengal by M/s. Swastik Projects Pvt. Ltd.**


The Authority examined the recommendation of the SEAC and made the following observations :

- i. Details of all dimensions and functional, positional arrangement of STP in the floor plan. Further the project proponent should mention the type (aerobic / anaerobic) of STP and its working principle considering the locational details.
- ii. Site plan showing Land Use distribution with polyline and corresponding legend mentioning Area and Percentage of each use both in soft (Auto CAD 2010) & hard copy formats.
- iii. As per the Notification No. S.O.3999(E) dated 09.12.2016 of MoEF & CC, GoI, *'A rain water harvesting plan needs to be designed where the recharge bores of minimum one recharge bore per 5,000 square meters of built up area and storage capacity of minimum one day of total fresh water requirement shall be provided'*. Detailed plan and sections of the storage tank with reference to the building line and levels to be submitted.


## II. Miscellaneous


