The 51<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC), Assam held on 16<sup>th</sup> December 2022 from 11-00 a.m. onward in the Conference Hall of the State Pollution Control Board, Assam, Bamunimaidam, Guwahati-21. At the outset the Chairman Sri S K Seal Sarma welcomes all the members of the Committee present and called the meeting in order. The Chairman initiated the discussion as per the agenda circulated on 14<sup>th</sup> December, 2022.

#### Points to be discussed:

- (a) Agenda of the 50<sup>th</sup> SEAC meeting held on 3<sup>rd</sup> Dec. 2022 is to be approved.
- (b) Altogether 37 nos. of proposals are included in the agenda for appraisal and deliberation including presentation on three nos. of proposals by the respective proponents.

## Agenda item-1. Confirmation of the resolutions adopted the 50<sup>th</sup> meeting of SEAC, Assam. Resolution 50/1:

The 50<sup>th</sup> meeting of the State Expert Appraisal Committee (SEAC), Assam held on 3<sup>rd</sup> Dec, 2022 from 11-00 a.m. onward in the Conference Hall of the State Pollution Control Board, Assam, Bamunimaidam, Guwahati-21 and the draft minutes f the 50<sup>th</sup> meeting placed before the Hon"ble Members for perusal and discussion. The minutes of the 50<sup>th</sup> meeting is approved unanimously following a brief discussion.

#### Agenda item- 2.

 Proposal requesting extension of EC for mining of Ordinary clay from "Balakuchi Ordinary Earth or Clay Mining Permit Area under North Kamrup Forest Division proposed by Sri Girish Deka. (SEIAA.1354/2020,(SIA/AS/MIN/295206/2022).

## Resolution 51/2:

The proposal asking modification of EC for mining of ordinary earth/clay from "Balakuchi Ordinary Earth/ Clay Mining Permit Area" under North Kamrup Forest Division proposed by Sri Girish Deka is placed before the SEAC for appraisal and detail discussion. The previous EC was granted on 9<sup>th</sup> Oct 2020 with validity of two years for extraction of 37232 cu.m. Ordinary earth. The proponent could not extract entire allotted quantity within the stipulated period. Reportedly learnt that only 12000 cu.m ordinary earth within the stipulated period as communicated vide letter No. NOC/898/orest/2021/77 dated 20<sup>th</sup> Sept. 2022 by the Deputy Commissioner, Nalbari. Accordingly a fresh approved mining plan dated 14<sup>th</sup> Nov.2022 submitted for extraction of balance quantity of minable materials. The issue has been deliberated thoroughly. The committee after due deliberation and considering the recommendation made in the Mining Plan (at page no. 8) recommended for modification approving to extract (20358 cu. - 12000 cu.) = 8358 Cu.m. ordinary earth from the proposed mining site within 1 (one) year period. The proponent shall have to strictly follow all terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, North Kamrup Forest Division, Rangia is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, he is requested to ensure that mining is allowed only within the approved mining site and not beyond the limit of the same.

#### Agenda item- 2.

 Proposal requesting extension of EC for mining of Brick earth from "Brick Earth Mining Permit Area" at Newuldova under Kamrup West Division proposed by Md. Lal Chand Ali. SEIAA. 1341/2020, (SIA/AS/MIS/293344/2022).

#### Resolution 51/3:

The modification proposal of EC requesting for extract of balance quantity of brick earth from the "Brick Earth Mining Permit Area" at Newuldova under Kamrup West Division proposed by Md. Lal Chand Ali is placed before the SEAC for appraisal and deliberation. The previous EC was granted on 22<sup>nd</sup> Oct. 2020 for extraction of 9506 cu.m. brick earth from the approved 0.5 hect project area within a period of two years. Fresh approved mining plan dated 17<sup>th</sup> March 2022 has been furnished for extraction of balance quantity of brick earth. The Divisional Forest Officer, Kamrup West Division submitted status report stating that the proponent could extract only 4753 cu.m within the stipulated time vide letter dated 21<sup>st</sup> Oct 2022. The issue is discussed in detail and after due deliberation the committee recommended the modification proposal approving to extract balance 4753 cu.m. brick earth from the proposed site within a period of one year. The proponent shall have to strictly follow all terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Kamrup West Forest Division is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, he is requested to ensure that mining is allowed only within the approved mining site and not beyond the limit of the same.

#### Agenda item- 2.

 Proposal requesting extension of EC for mining of Ordinary earth from "Patta land ordinary earth mining permit area at Kamarkuchi Nonkey under Kamrup East Forest Division proposed by Protech Buildcon Private Limited. SEIAA. 1131/2020, (SIA/AS/MIN/294162/2022).

## Resolution 51/4:

The modification proposal of EC for mining of ordinary earth from "Patta land ordinary earth mining permit area at Kamarkuchi Nonkey" under Kamrup East Forest Division proposed by Protech Buildcon Private Limited is placed before the SEAC for appraisal and detail discussion. The previous EC was granted by SEIAA, Assam of 29<sup>th</sup> Feb. 2020 with validity one & half year for extraction 50000 cu.m. ordinary earth from the proposed mining site 2.42 hect area on the basis of the mining plan approved dated 21<sup>st</sup> Dec. 2019. Now the proponent has submitted request for extension of validity of the EC for another two years on the ground that he failed to operate because of past COVID situation and his ailment during the period. Necessary status report from the Divisional Forest Officer, Kamrup East Division has not been furnished along with the proposal. No half yearly compliance report has been furnished as mining could not be executed. Necessary documents submitted by the proponent are examined. The committee after detailed deliberation resolved to get the following additional information relating to the project for taking further requisite action.

- (i) Original application along with the concerned File relating to the proposal maintained in the office being off line processing in that time is required for verification.
- (ii) Status report from the Divisional Forest Officer, Kamrup East Division is necessary as to not executing of mining activities after receiving requisite EC on 29<sup>th</sup> Feb. 2020.
- (iii) Necessary certificated from the Divisional Forest Officer, Guwahati Wildlife Division is required certifying that the proposed mining site is located outside the limit of the notified CSZ of the Amchang Wildlife Sanctuary.

Proposed project area is 4.9 hect, that located in the Chiri River. Necessary documents submitted in support of the proposal is examined and appraised. Recommendation of the concerned DFO dated 27<sup>th</sup> Sept. 2022 and dated 28<sup>th</sup> Feb 2022 is deliberated. The Mining plan approved by the DGM, Assam dated 14<sup>th</sup> Aug. 2022 is discussed in detailed. Due deliberation is held and the committee recommended the project proposal approving to extract 86800 cu.m. river bed stone from the proposed mining site within a period of 2 (two) years subject to the condition that (a) at least 50 meters gap has to be kept between the GPS coordinated 24<sup>0</sup>57' 52.17'' –N; 93<sup>0</sup>3'27.34''-E and 24<sup>0</sup>57' 53.67'' –N; 93<sup>0</sup>3'28.33''-E within the proposed mining site as buffer/ non mining zone. (b) The active bank of the river is not get disturbed because of mining operation and transportation of mining materials. The proponent is allowed to extract 43400 cu.m. river bed stone from the proposed mining site annually and should strictly follow all other terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Cachar Forest Division, Silchar is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. The project area is 3.34 hect and the mining plan duly approved by the DGM, Assam dated 21<sup>st</sup> Sept. 2022. Scrutinized the documents submitted by the proponent. The recommendation of the DFO, Porbotjhora Forest Division in pursuance to the approval of the Secretary, BTC dated 23<sup>rd</sup> Sept. 2022 and dated 23th May 2022 are discussed in detailed. The committee after thorough deliberation recommended the project proposal approving to extract 63000 cu.m sand-gravel from the proposed mining site within a period of five (5) years subject to the condition that the maximum mining depth is recommended two (2) meters from the unmined ground surface. The proponent is allowed to extract 12600 cu.m. approved minable materials per year strictly following all other terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Porbotjhora Forest Division under BTC is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, he is requested to ensure that mining be allowed only within the approved mining site and not beyond the limit of the same. Accordingly he will mark the boundary of the mining site on the ground fixing permanent pillars following the GPS coordinates mentioned in the approved mining plan. Compliance by the proponent of all the terms and condition laid down in the EC shall have to be ensured by the concerned Divisional Forest Officer.

The project proposal asking EC for mining of Sand from the "Mineral Concession Area in Dhansiri River (2 No Parghat)" under Golaghat Forest Division proposed by the Divisional Forest Officer Golaghat Forest Division is placed before the SEAC for appraisal and detail discussion. Proposed project area is 4.8 hect in Dhansiri River and the requisite mining Plan has duly been approved by the DGM, Assam vide letter dated 21st Oct. 2022. Necessary documents submitted by the proponent have been examined. The letter issued by the DFO, Golaghat dated 3rd Nov. 2022 is also discussed in detail. Thorough deliberation is held and the committee recommended the proposal to excavate 51000 cu.m. sand from the proposed location within a period of two (2) years with the following conditions: (i) Maximum mining depth is recommended up to two (2) meters from the unmined ground surface, & (ii) Mining activities should be restricted in the sand bar area keeping 50 meters away from the left bank of the river. The proponent is permitted to extract 25500 cu.m. Sand from the approved mining site annually adhering to the conditions mentioned above.

The Divisional Forest Officer, Golaghat Forest Division is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, he is requested to ensure that mining be allowed only within the approved mining site and not beyond the limit of the same. Accordingly he will mark the boundary of the mining site on the ground fixing permanent pillars following the GPS coordinates mentioned in the approved mining plan. Compliance by the proponent of all the terms and condition laid down in the EC shall have to be ensured by the concerned Divisional Forest Officer (proponent).

The proposed project area is 5.0 hect that comes under category B<sub>2</sub>. The mining plan approved by the DGM, Assam vide letter dated 23<sup>rd</sup> Nov. 2022 allowing to extract 50000 cu.m. Sand-gravel within five years. Necessary LOI issued by the concerned Divisional Forest Officer vide letter dated 16<sup>th</sup> Aug. 2022. The DFO's recommendation dated 29<sup>th</sup> Nov. 2022 is also discussed in detailed. The committee after due deliberation recommended the proposal approving to extract 50000 cu.m. Sand-gravel from the proposed mining site within a period of five (5) years with the conditions noted below. (i) Maximum mining depth is approved up to two (2) meter

from the unmined ground surface & (ii) the river bank should not be disturbed during mining operation and transportation of mining materials. The proponent is permitted to extract 10000 cu.m. minable materials per year strictly following all other terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Kamrup West Forest Division is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, she is requested to ensure that mining be allowed only within the approved mining site and not beyond the limit of the same. Accordingly she will arrange to mark the boundary of the mining site on ground fixing permanent pillars following the GPS coordinates mentioned in the approved mining plan. Compliance by the proponent of all the terms and condition laid down in the EC shall have to be ensured by the concerned Divisional Forest Officer.

The subcommittee of the SEAC, Assam physically inspected the proposed site on 10<sup>th</sup> Sept. 2022 and submitted their report on 23<sup>rd</sup> Sept. 2022. Necessary documents furnished by the proponent including reply on ADS are discussed in detailed. The proponent was invited to give presentation describing detail activities proposed therein and to participate in the subsequent discussion. The proponent accordingly with assistance of his consultant have given presentation before the SEAC and participated in the open deliberation. The Security Clearance provided by the Special Branch Headquarters, Assam Ploice, Kahilipara, Guwahati-19 vide letter No. SB.VIII/77/S-Plan/Paramount/2021-22 dated 1<sup>st</sup> July 2022 is also discussed I detailed. The committee after thorough deliberation recommended for issuance of EC with the following conditions.

- All the terms and condition laid down in the Security Clearance given by the Assam Police, Special Branch Headquarters vide letter No. SB.VIII/77/S-Plan/Paramount/2021-22 dated 1<sup>st</sup> July 2022 shall have to adhere to in letter and spirit as the proposed site located in the high security zone.
- All other terms and condition laid down in the EC shall have to strictly follow during construction and post constriction period.
- Sprinkling of water should be carried out in the project site regularly to suppress dust in the project site and its surroundings.

## Resolution 51/10:

The project proposal asking EC for "Establishment of a New Standalone Cement Grinding Unit of Capacity 2.0 MTPA" at Village Chamata Pather, Tehsil Sonapur in the District of Kamrup (Metro), Assam proposed by Star Cement North East Limited is placed before the SEAC for appraisal and detail deliberation. On receipt of the proposal by SEIAA a subcommittee of the SEAC, Assam was constituted vide O.O. No. 03 dated 25th Feb 2022 for site inspection. Accordingly, the subcommittee so constituted has physically inspected the proposed project site on 26th Feb.2022 and submitted report. Subsequently requisite TOR was issued on 2nd April 2022 with a direction to submit detail EIA report along with report on Public Hearing. The proponent has furnished report on public hearing duly conducted in presence of the authorized members of both the Dist. Administration and State PCB on 29th Aug. 2022 along with detail EIA report on 26th Oct. 2022.

The proponent was invited to give detail presentation before the SEAC on the project proposal basing on the EIA report. The proponent with the assistance of their consultant has given detail presentation on different activities and measures proposed relating to the proposal. Detail deliberation is held in presence of the proponent. The proposal comes under category B<sub>1</sub> of Schedule 3(b) as per EIA notification. The proposed grinding unit with capacity 2.0 MTPA will be established on a land area of 12.85 hect. This is adjacent to a grinding unit by its group company, Star Cement Limited. The committee after thorough deliberation and discussion the committee recommended the proposal with the following conditions:

- Land conversion from Agriculture land to Industrial land is to be completed.
- (2) Adequate sprinkling in the project site, approach road from the National High Way and peripheral areas of the project site is required during construction and operation stage of the project.
- (3) An appropriately designed reservoir / pond to hold adequate rain water and project discharge area is to be constructed within the project boundary, so that it held adequate water for sprinkle throughout the year whenever necessary.
- (4) CSR activities including health camp should be carried out on regular basis. CSR activities in the adjoining villages should be executed in consultation with the inhabiting population and the local bodies.
- (5) The approach road from the NH-37 to the project site should be upgraded and adequately maintained to minimize traffic congestion from the heavy vehicles.
- (6) The measures proposed in the EIA report should strictly be adhered to in the interest to contain better environment over the area.
- (7) Native plant species having evergreen nature should be planted in the green area.

 Proposal of EC for "Construction of A New Medical College and Hospital at Tamulpur, Assam under NIDA proposed by Govt. of Assam, Health and Family Welfare Department. SEIAA. 3135/2022, (SIA/AS/MIN/241097/2022).

#### Resolution 51/11:

The project proposal requesting EC for "Construction of A New Medical College and Hospital at villgage Kachubari, Mouza Pub Baska in the District Tamulpur (BTAD), Assam" under NIDA proposed by Govt. of Assam, Health and Family Welfare Department is placed before the SEAC for appraisal and detailed discussion. The proposal comes under category B2 in Schedule 8 (a) covering the plot of land 214048 Sq.m. and built up area 95502.97 Sq.m. proposed building is ground plus 6th floor. The proposal was initially appraised and discussed in the 47th SEAC meeting held on 21st Oct. 2022 and certain additional information was sought, Examined the required documents submitted by the proponent including reply on ADS. Necessary allotment of land given by the Principal Secretary, Bodoland Territorial Council communicated vide letter No. BTC/LR. 196/2020/61 dated 20th July 2021is discussed. Necessary Administrative Approval conveyed by the Project Director. Assam Infrastructure Financing Authority communicated vide letter No. AIFA 23/2021/44 dated 22nd Feb.2022 is also discussed in detailed. The proponent was invited to give detail presentation on the project before the SEAC and accordingly necessary presentation is given by the concerned consultant in the 51st SEAC meeting elaborating the activities/ measures proposed therein. Followed by the presentation detail deliberation is held in presence of the proponent/ consultant. The committee after thorough discussion recommended the project proposal with the following conditions:

- (1) The storm water from the project site is planned to be released in the natural drainage/ nalla located along the Eastern boundary of the project site. As such it is suggested that the storm water from the project site should be passed through a discharge pit which should be designed to arrest all solid waste in the pit and it should be followed by a filter system to remove any unwanted contamination before the entire storm water from the project site is released to the nalla/natural drainage.
- (2) During construction stage adequate measures are to be adopted for dust suppression.
- (3) A Biomedical Waste Treatment facility should be included in the project to maintain better environmental status.
- (4) Since it appears that the only source of water is ground water. Appropriate permission to use ground water for the project is to be taken for construction as well as operation stage of the project. The proponent is advised to consult the state PHE Department to set up of a PHE Sub Division for optimum, uninterrupted water supply.
- (5) Native plant species having evergreen nature should be planted covering the green area.

Project area is 5.0 hect in the Jamuna River bed. Necessary documents submitted by the proponent has been examined and appraised. The Mining Plan approved by the DGM, Assam vide letter dated 14th Aug. 2022 and LOI issued by the concerned DFO dated 1st Aug. 2022 is also discussed. Recommendation of the DFO, Nagaon South Forest Division dated 1st Aug. 2022 is discussed in detail. The committee after due deliberation recommended the proposal approving to extract 55000 cu.m minable materials (i.e 41250 cu.m. ordinary sand + 13750 cu.m. gravel= 55000 cu.m) from the proposed mine area within 5 (five) years with the condition that (i) maximum mining depth is fixed at 2 (two) meters from the unmined ground surface & (ii) high rise river bank should not be disturbed during mining operation and transportation of materials. The proponent is allowed to extract 11000 cu.m. minable materials i.e ordinary sand 8250 cu.m. and gravel 2750 cu.m. annually strictly following all other terms and condition laid down in the approved mining plan.

The Divisional Forest Officer, Nagaon South Forest Division, Hojai is requested to ensure due vigilances on the mining operation to avoid occurrences of irregularities during the mining period. Further, she is requested to ensure that mining be allowed only within the approved mining site and not beyond the limit of the same. Allotted area of the project is quoted 1.0 hect. and minable area is 0.87 shown in two different blocks hect. and the proposal is forwarded by the Deputy Commissioner, Nalbari District. Scrutinized the documents submitted by the proponent.
