#### Resolution 2/1:

The Chairman SEAC read out the Minutes of the 1st meeting of SEAC which have been approved by the members' present in the meeting.

# Agenda item= 2.

1. EC for collection of sand from Jhanji River Sand MPA under Jorhat forest Division Proposed by Sumesh Tanti

#### Resolution 2/2:

On Scrutiny of the project proponent and after deliberation in project is recommended for issuance of EC following statutory condition laid down in mining plan approved by the Director Geology and Mining, Assam.

#### Agenda item- 3.

2. EC for Sand from "Sand & Ordinary clay MPA of 2019-21 at Nawjan Area" under Dibrugarh Forest Division Proposed by Sri Satyajit Deori.

#### Resolution 2/3:

On scrutiny and after detail discussion, the committee recommended the project with condition that actual excavation of sand be allowed about 100 (one hundred) mtr away from the high bank so that existing river bank remain safe from erosion etc. in dedication to the statutory condition. The D.F.O Dibrugarh Forest Division should ensure that the collection of materials allowed as stated above.
