The members present declared that there are no conflicts of interest with the projects being considered in this meeting. After general introductory remarks by the Chairman, SEAC, the Committee took up items agenda-wise. The decisions of the SEAC on each case are recorded below.

Minutes of the SEAC Meeting held on 20.07.2022

Agenda Item No. 01	182.78 Ha. Coal Mine of M/s. Indaram Khani - 1A Incline, 338 to 340, 354 359, 366, 374-503, 519-531, 537-551, 580, 581, Indaram Village, Jaipur Mandal, Mancherial District. - Environmental Clearance (Violation) - Reg.
Proposal No.	SIA/TG/CMIN/79866/2017 (EC Violation)

The representative of the project proponent Sri J.V.L Ganapathi and Sri J. Rahul and Shaheeda Begum of M/s. EIAC, EPTRI, Hyderabad attended and made a presentation before the SEAC.

During presentation, the proponent informed that Indaram Khani-1A Incline is and underground coal mine operating since 1994-95 and producing coal at an annual rated capacity of 0.54 MTPA within a mine lease area of 182.78 Ha. However, Prior Environmental Clearance was not obtained at the time of renewal of mining lease i.e in 2006 as per MoEF&CC Circular No. J-20012/11/98-IA.II(M), dt.28.10.2004. SCCL submitted Form-1 to MoEF&CC on 23.08.2013 for obtaining EC under violation category, but the proposal was delisted by MoEF&CC for want of credible action by the State Government. Subsequently, Form-1 was again submitted on 11.09.2017 for seeking EC under violation category as oer S.O.804 (E), dt.14.03.2017 for which TOR was granted. The present proposal is for obtaining EC for a production capacity of 0.54 MTPA in the exsiting project area of 182.78 Ha.

The SEAC noted that earlier, the MoEF&CC, GoI, issued TORs (Violation) on 04.04.2019 for preparation of EIA Report as per the provisions of EIA Notification, 2006 & its amendments then. Accordingly, the proponent undergone the process of public hearing on 24.08.2021 and submitted Final EIA Report. Meanwhile, as per the latest amendment vide S.O.1886 (E) dt.20.04.2022 to EIA Notification, 2006, the file was transferred by MoEF&CC, GoI. Now, the proponent has applied under Violation within window period. The SEAC observed from the minutes of Public Hearing & representations that the issues emerged during public hearing are employment to local people; providing Infrastructure developments; take adequate measures to control air pollution & noise pollution during mining operations; provide medical facilities; regular water sprinkling & develop greenbelt on both side of the road; etc., The proponent reported that they have allocated Rs. 1.01 Crores towards implementation of EMP measures, Rs. 10.0 Lakhs towards health camps, 54.77 Lakhs towards Pollution controlling measures & monitoring, 92.0 Lakhs for Greenbelt development and Rs. 2% of 3 years average profit of the company towards implementation of CER/CSR activities.

The SEAC noted that the project is for Coal Mine with Mine Lease Area of 182.78 Ha. which is more than 5.0 Ha. Hence, the project is considered under B1 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent informed that the mine was operating since 1994-1995. It is proposed to mine 0.54 MTPA of Coal Mine and it was informed that the life of mine is reported as 5 years (from 2022-2023).

The nearest village is Indaram exists at a distance 1.74 km from the proposed site; nearest water body is Godavari river exists at 100 m from the mine lease area.

During presentation, the SEAC noted that a stream is passing on South direction of mine lease area. In this regard, the proponent informed that it is an underground mine and underground opening is about 500m away from the stream.

The proponent informed that State Government has initiated credible action against the proponent vide CC No. 550/2020 was filed in the Hon'ble Judicial Magistrate of First Class, Chennai. Honble court imposed a penalty of Rs. 1,00,000 & the same was paid by the proponent and submitted copies of supporting documents.

The total cost of the project is Rs. 46.11 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 491.0 Lakhs and recurring cost Rs. 34.77 lakhs/annum.

The SEAC noted that, the SEIAA approved guidelines w.r.t processing of Violation proposals of Mining projects for various minerals, but the mineral 'Coal' was not mentioned in the guidelines earlier as coal mining projects were never processed earlier at the SEIAA. In this regard, the proponent informed that they have been presenting various coal mining projects involving violation at the central level at MoEF&CC, GoI and calculated the amounts for Remediation Plan, Natural Resources Augmentation Plan & Community Resources Augmentation Plan and presented the present proposal with the same criteria. Hence, the SEAC followed the criteria of the MoEF&CC, GoI w.r.t to violation proposals, as presented by the proponent.

Accordingly, the amount of Bank Guarantee to be submitted for Implementation of Remediation plan; Natural Resource Augmentation Plan; and Community Resource Augmentation Plan is worked out to be Rs. 1,37,00,000/- and the details are as following:

After detailed discussions, the SEAC recommends the project for issue of Environmental Clearance subject to approval by the SEIAA for submission of Bank Guarantee for an amount of Rs. 1,37,00,000/-.

The representative of the project proponent Sri V.N.V.R.M. Suresh and Sri Chandrasekhar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

The SEAC noted from Proceedings dt. 05.05.1999 that quarry lease was granted in favour of the proponent for a period of 15 years (i.e., upto 04.05.2014) for which the proponent obtained EC vide order dt. 25.10.2013 which expired on 04.05.2014. Further, the 1st renewal of quarry lease was granted (in-principle) on 25.01.2017 (w.e.f 13.05.2014 to 12.05.2034) for a period of 20 years. It may be noted that the Mine Lease is granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 0.809 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan. The proponent informed that the production capacity of the project is to mine 10,785.80 m³/annum of Black Granite. The proponent started mining operations from the year 2016-17 and continued even after expiry of mine lease & EC, as per lr. dt. 21.06.2022 of ADMG, Mahabubabad District, without obtaining prior EC.

Nearest human habitation is a Arpanpalli @ 0.23 km (S); Nearest water body exists at 0.3 km (ESE); Nearest RF is Nayakpalli RF exists at 0.46 km from the mine lease area.

The SEAC confirmed the project as a case of violation of the EIA Notification, 2006 and the project has to be considered in the terms of the provisions of the S.O.No.804 (E) dt.14.03.2017; S.O.1030 (E), dt.08.03.2018; and O.M. dt: 07.07.2021 & O.M. dt: 28.01.2022 issued by the MoEF&CC, GoI w.r.t. SOP for identification and handling of violation cases under EIA Notification., 2006.

The proponent informed that they have already collected the baseline data from March – May 2022 and requested to consider the same for preparation of EIA report based on the Standard Terms of Reference for proposed Quarry. The SEAC considered the request of the proponent for utilizing the baseline data from March – May 2022 for preparation of EIA report.

After detailed discussions, the proponent is directed to prepare EIA report considering the baseline data from March – May 2022, as per the Standard Terms of Reference (TORs) issued by the MoEF&CC, GoI for "Mining of Minerals" along with the Specific Terms of Reference w.r.t.

violation as per S.O.No.804 (E) dt.14.03.2017; S.O.1030 (E), dt.08.03.2018; OM dt.07.07.2021 & OM dt.28.01.2022 and submit final EIA report to the SEAC for appraisal.

The representative Sri V.N.V.R.M. Suresh & Sri. Chandrashekar Reddy of M/s. Space Enviro Solutions, Hyderabad, attended before the SEAC and informed that there are few modifications in the proposal after uploading documents and hence they are withdrawing the proposal.

In view of the above, the SEAC decided to return the proposal.

The representative of the project proponent Sri V.N.V.R.M. Suresh and Sri Chandrashekar Reddy of M/s. Space Enviro Solutions, Hyderabad attended and made a presentation before the SEAC.

The proponent informed that the lease was granted (in-principle) on 24.01.2022 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The Proponent also submitted a copy of Ir.dt. 29.06.2022 of ADMG, Khammam, informing that there are 4 quarry leases (EC's granted before 15.01.2016) falling within 500m from the proposed quarry lease. The SEAC noted that the mine lease area is 1.26 Ha. The project proponent informed that the leases w.r.t. Agenda no. 4 (1.26 Ha.); Agenda No. 15 (1.0 Ha.) & Agenda No. 16 (0.96 Ha.) are also located within 500m from each other. But their details are not mentioned in the Cluster letter, as only LOI was granted to them. It is further noted that the total Cluster area is 8.420 Ha. and Net cluster area is 3.22 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The nearest village Kukkala Tanda exists at a distance 0.79 km from the proposed site; nearest water body exists at 0.53 km from the mine lease area.

It is proposed to mine 6,000 m³/annum of Black Granite and the life of mine is reported as 9 years.

The total cost of the project is Rs. 50.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 5.52 lakhs and recurring cost: Rs. 3.50 Lakhs/annum.

After detailed discussions, the SEAC recommended for issue of EC.

The representative of the project proponent Sri B. Raghupathi Reddy and Smt. Urvashi of M/s. Ambiantal Global Pvt.ltd., Delhi attended and made a presentation before the SEAC.

The proponent informed that the lease was granted (in-principle) on 28.02.2019 in favour of the proponent for a period of 20 years. It may be noted that the Mine Lease is granted after 09.09.2013. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP.

The Proponent also submitted a copy of Lr.dt. 06.06.2022 of ADMG, Mulugu District informing that there are three existing quarry leases (all the leases granted before 09.09.2013) falling within 500m from the proposed quarry lease. The SEAC noted that the mine lease area is 4.0 Ha. It is further noted that the total Cluster area is 6.926 Ha. and Net cluster area is 4.0 Ha. which is less than 5.0 Ha. The project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT.

The nearest village Mallampalli (V) exists at a distance 1.91 km from the proposed site; nearest water body i.e., Nandigama lake exists at 4.89 km (S) from the mine lease area.

It is proposed to mine 1,09,405.28 m³/annum of Building Stone & Road Metal and the life of mine is reported as 17.30 years.

The total cost of the project is Rs. 15.0 Lakhs. The proponent is proposing budget for Environmental protection towards capital cost: Rs. 3.57 lakhs and recurring cost: Rs. 2.94 Lakhs/annum.

The SEAC observed from the KML file (Google timelines) that no mining activity is carried out 2019. Hence, it is considered as a fresh mine.

After detailed discussions, the SEAC recommended for issue of EC.

Further, the 1st renewal of quarry lease was granted (in-principle) on 29.06.2022 for a period of 20 years. It may be noted that the Mine Lease is granted before 09.09.2013. Hence, cluster is not applicable to the project. The SEAC noted that the mine lease area is 1.0 Ha. which is less than 5.0 Ha. Thus, the project is considered under B2 Category as per the provisions laid under EIA Notification, 2006 & its subsequent amendments and orders of the Hon'ble NGT. The proponent submitted a copy of Scrutinized/ Approved Mining Plan & EMP Report.

The proponent submitted a copy of lr. dt. 19.01.2022 of ADMG, Kamareddy District furnishing the details of dispatch particulars during the period 2007-08 to 2021-22 (upto January – 2022). It is observed from the letter that dispatch permits were issued during the period 2007-08 to 2020-21 and nil during the period 2021-22 (upto January – 2022).

The proponent submitted a copy of Certificate dt. 21.06.2022 issued by the Sarpanch of Grama Panchayath, Bichkunda (V), Kamareddy District stating that the proponent has donated Rs. 1,00,000/- for construction of sewer lines.

After detailed discussions, the SEAC recommended for issue of EC.

The SEAC noted that total plot area is 12,646.01 Sq.m., Out of which green area is 3,357.20 Sq.m. (26.55%)

It was informed that the total built up area of the project is 70,876.17 Sq.m. The project consists of Residential Apartments to accommodate 360 units. The maximum no. of floors proposed in the project are 2B + S + 10 Upper Floors.

It is also noted that Parking area to be provided is 20,650.39 Sq.m., (41.11% against required 33%).

During presentation, the SEAC observed that the site is adjacent to waterbody. In this regard, the proponent submitted a copy of letter dt. 09.06.2021 of the SE, Irrigation Circle, I&CAD dept. It is observed from the document that the total extent of applicant's land is (Ac. 05-19 Gts) out of which an extent of Ac.0-33 Gts is affected in Buffer zone, as per G.O.Ms.No.168, dt.07.04.2012 of MA&UD Dept. leaving balance land of Ac. 4-26 Gts. Accordingly, the proponent proposed layout of the project.

The total cost of the project is Rs.72.0 Crores. The proponent is proposing budget for Environmental protection towards capital cost: Rs.96.0 Lakhs and Recurring cost: Rs.17.0 lakhs/annum.

Nearest human habitation is Vinobabhavenagar (V) @ 2.5 km; Nearest water body i.e Seasonal stream is @ 0.45 km; Nearest RF i.e., Ibrahimpatnam RF @ 0.3 km from the industry.

Project Cost is Rs.5.0 Crores. Budget for Environmental protection towards Capital Cost is Rs.58.3 Lakhs and Recurring Cost is Rs.18.7 Lakhs/annum. Budget for CER is Rs.12.0 lakhs.

During presentation, the SEAC observed that the total area of the project is only Ac. 0.99 which is less than Ac.2.0. In this regard, the proponent vide letter dt. 20.07.2022 informed that the proposed resins manufacturing unit will generate less pollution loads w.r.t. waste water, air pollution and no solid waste generation from process. The facility requires less process area for
