

The Authority after detailed discussion and deliberation decided the following:

Serial No. 1: Proposal was deferred in the 5.96th meeting of SEIAA for "submission of affidavit for implementation of Cluster EMP by PP". Now, PP has submitted the requisite document. Hence, the Authority decided to approve EIA/EMP and grant





- **EC** to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 2. Serial No. 2: Proposal was deferred in the 5.96th meeting of SEIAA as "the Authority decided to issue a show cause notice to the PP. Since, they have stated in their affidavit that, "the project/ activity pertaining to the mining lease has been in violation of the order dated 02/08/2017 of the Hon'ble Supreme court in the matter of writ petition (civil)No. 114 of 2014, Common Cause v/s UOI". Hence, PP needs to explain why the application should not be rejected as PP has applied for fresh EC." Now, PP has submitted the correct affidavit along with the clarification stating that "due to human error we have wrongly mentioned violation of EIA Notification in Affidavit submitted earlier, therefore, we humbly seek apology for the error." Considering the same, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal.
- 3. Serial No. 3: Proposal was deferred in the 5.97th meeting of SEIAA for "submission of revised parking in compliance of SEIAA order 15.09.2023."
  Based on the discussion in the last meeting, PP has submitted revised parking provisions wherein, a provision of 364 cars has been incorporated against the original provision of 40 cars (all other parking being scooters). Given the location of the project as well as the fact that it is an EWS and LIG project under CMJAY-2015, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 4. Serial No. 4: Proposal was deferred in the 5.97<sup>th</sup> meeting of SEIAA for "submission of affidavit regarding violation/no violation by PP and consultant". Now, PP has submitted the requisite documents. Hence, the Authority decided to approve EIA/EMP and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 5. Serial No. 5: Proposal was deferred in the 5.97th meeting of SEIAA for "submission of a valid mining plan as submitted Mining Plan was valid till 2021-2022." Now, PP has submitted latest Mining Plan dated 24.08.2023. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.

- 6. Serial No. 6: Proposal was deferred in the 5.89th meeting of SEIAA as "in the revised Aravalli and Cluster certificate, Khasra number 2301 is missing. Hence, a revised Aravalli and Cluster certificate with correct khasra numbers needs to be submitted." Now, PP has submitted a corrigendum in Cluster certificate (04.10.2023) and revised Aravalli certificate. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 7. Serial No. 7: Proposal was deferred in the 5.96th meeting of SEIAA as "in this proposal, Affidavit submitted in the name of PP is signed by Mr. Shanti Lal Nahar of M/s ERA Minerals & Mines but his name is not mentioned in partnership deed." Now, PP has submitted the correct affidavit. Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal along with the condition to comply with the conditions stated in the certificate issued by Water Resource Department for this proposal.
- Serial No. 8: Proposal was deferred in the 5.96th meeting of SEIAA and "a show cause notice was issued against the PP to explain why the proposal should not be rejected as per the State Government order dated 14.6.2023."
  - Now, PP has submitted a cluster certificate dated 24.05.2023 stating that cluster area including the sanctioned auction leases is 2.33 ha. Considering the same, the Authority was of the view that the query raised by SEIAA has not been satisfactorily replied by the PP. Hence, the Authority decided to **defer** this proposal and PP may be afforded an opportunity of personal hearing to explain why this proposal may not be rejected, as the nearest forest is at 40 m distance from the lease area as per the certificate issued by DCF, Banswara vide letter dated 06.09.2021 and whereas the State Government order dated 14.06.2023 has specified minimum distance for mining as 50 m or more from the forest boundary.
- Serial No. 9: Proposal was deferred in the 5.96th meeting of SEIAA as "the proposed quantity of SW generation has not been provided in the EIA report and the quantity of water requirement is not clear."
  - Now, PP has submitted the requisite details i.e., solid waste (5 kg/day) and water requirement (10.03 KLD). Hence, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal.
- 10. Serial No. 10: Proposal was deferred in the 5.99th meeting of SEIAA as "This proposal involves offices and shops for which no parking provisions have been



anv

provided. Also, Conceptual plan mentions that the proposal will involve construction of a single block but in building maps provided, two towers are marked. Hence, the Authority decided to call PP for personal hearing to explain parking provisions for offices and shops in the complex and also to explain the reason for proposing one block in Form 1 and two tower as shown in maps"

PP provided explanation for the queries raised which were found satisfactory. Revised parking provisions as per the new norms [356 E.C.U (cars: 290 + scooters: 199)] are more than the required norms agreed upon. In addition, PP informed that they will also apply for PHED connection for high rise buildings, In view of the facts, the Authority accepted the recommendations of SEAC and decided to grant EC to this proposal with the specific condition that the PP may apply for PHED connection as well for the fulfilment of their water requirement.

11. Serial No. 11: Proposal was deferred in the 5.99th meeting of SEIAA as "In this proposal, size of flats has not been furnished for calculation of parking provisions. Hence, PP may be called to explain the parking provisions in light of the order issued by SEIAA dated 15.9.2023"

Now, <u>PP has submitted the revised parking provisions as per new norms i.e., 570 E.C.U (528 cars + 127 scooters)</u> which is found satisfactory. In addition, <u>PP informed that they will also apply for PHED connection. Hence, the Authority accepted the recommendations of SEAC and decided to <u>grant EC</u> to this proposal with the specific condition that the <u>PP may apply for PHED connection as well for the fulfilment of their water requirement.</u></u>

12. Serial No. 12: Proposal was deferred in the 5.99th meeting of SEIAA as "In this proposal, size of flats has not been furnished for calculation of parking provisions. Hence, PP may be called to explain the parking provisions in light of the order issued by SEIAA dated 15.9.2023"

Now, PP provided clarification to the queries raised. The Authority was satisfied with the clarification provided. Moreover, there is an adequate space available in the complex for additional parking, if required. In addition, <u>PP informed that they will also be applying for PHED connection</u>. Hence, the Authority accepted the recommendations of SEAC and decided to <u>grant EC</u> to this proposal with the specific condition that the PP may apply for PHED connection as well for the fulfilment of their water requirement.

- 13. Serial No. 13, 65, 66, 67, 68: The Authority accepted the recommendations of SEAC and decided to grant Amendment in EC to this proposal.
- 14. Serial No. 14, 43, 50, 51, 52, 53, 54, 55, 60: The Authority accepted the recommendations & additional conditions of SEAC and decided to <u>approve</u> <u>EIA/EMP and grant EC</u> to these proposals with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 15. Serial No. 15: In this proposal, production capacity for cluster given in the approved cluster mining plan is 11, 59,736 TPA (ROM). Hence the Authority accepted the recommendations & additional conditions of SEAC and decided to approve EIA/EMP with cluster production capacity of 11, 59,736 TPA (ROM) as approved in Cluster Mining Plan and grant EC to this proposal with the condition that PP shall also ensure to raise a dense plantation in the 7.5m green belt around the lease area to mitigate the pollution effects.
- 16. Serial No. 16, 44: The Authority accepted the recommendations of SEAC and decided to <u>close and delist</u> these proposals.
- 17. Serial No. 17, 18, 20, 23, 24, 25, 26, 27, 28, 34, 38, 40, 41, 45, 46, 49, 57, 58, 59, 61: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>grant EC</u> to these proposals.
- 18. Serial No. 19, 29, 30, 31, 32, 33: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to these proposals along with the condition to comply with the conditions laid down by Water Resource Department in their concerned certificate.
- 19. Serial No. 21: In this proposal, production certificate for FY 2021-2022 and 2022-2023, duly authenticated by Mining Department has not been submitted. Hence the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of past production certificate from Mining Department for FY 2021-22 and 2022-23 within next 45 days.
- 20. Serial No. 22: In this proposal, Khasra no. 1807/217 is missing from the affidavits submitted by PP and consultant. Hence, the Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal subject to the submission of revised affidavits.

- 21. Serial No. 35: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant EC to this proposal subject to deposition of penalty as per MoEF&CC SOP dated 07.07.2021 of Rs. 0.90 Lacs by online/ Demand Draft mode and also submit the Bank Guarantee of Rs. 39.66 Lacs towards remediation plan with RSPCB within 15 days of the receipt of the letter in this regard failing which action shall be initiated to stop this project.
- 22. Serial No. 36: In this proposal, there is discrepancies in the parking figures and Ground water application is only applied for 50 KLD against the fresh water requirement of 351 KLD. Also, in the submitted Certified Compliance Report, Miscellaneous conditions no. 1 and 4 are mentioned as not complied. Hence, the Authority decided to defer this proposal and PP may be afforded an opportunity of personal hearing for the clarification on above said discrepancies/issues.
- 23. Serial No. 37: In this proposal, following issues have been observed:
  - a. Pichola Lake is adjacent to the instant project.
  - b. Ground water application is applied for 30 KLD against the fresh water requirement of 300 KLD.
  - c. There are two different figures given for the parking in presentation as well as Conceptual Plan.
  - Hence, the Authority decided to defer this proposal for submission of the following and PP may be afforded an opportunity of personal hearing:-
  - a. WRD certificate is required which clearly stating that the project will not infringe the directions of Hon'ble High court in the case of Abdul Rehman vs. State of Rajasthan is required.
  - Clarification on how the balance fresh water requirement of 270 KLD will be met.
  - c. Final figures for the parking which should be in compliance of the new norms as per SEIAA order dated 15.09.2023.
- 24. Serial No. 39: The Authority decided to defer this proposal. Since, this is a huge project PP may be called for detailed AV presentation to explain the project with special emphasis on parking provided for retail and conventional centre and how such traffic will not impact the existing entry and exit facility for the airport passengers.
- 25. Serial No. 42: In this proposal, Kumbalgarh WLS is at a distance of 9.5 km as per the certificate issued by DCF, Rajsamand vide letter dated 31.03.2023 and hence NBWL

- clearance is required. Hence, the Authority decided to <u>Close & Delist</u> this proposal till the receiving of the NBWL Clearance from the concerned Authority.
- 26. Serial No. 47: In this proposal, Cluster certificate has been expired. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of latest cluster certificate within 45 days.
- 27. Serial No. 48: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR under violation to this proposal with the condition to submit past production certificate from Mining Department for FY 2022-23 at the time of submission of TOR compliance/EC applications.
- 28. Serial No. 56: In this proposal, LOI has been expired. Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of valid LOI within 45 days.
- 29. Serial No. 62: The Authority accepted the recommendations and additional conditions of SEAC and decided to grant TOR to this proposal.
- 30. Serial No. 63: In this proposal, following discrepancies/issues are observed:
  - a. In the proposal, production capacity is 88920 TPA (ROM) but in PFR it is mentioned as 22620 TPA (ROM).
  - b. Cluster certificate has expired.
  - c. Proposal is for Quartz & Feldspar but DSR is submitted for Bajari/sand mining.
    Hence, the Authority decided to <u>defer</u> this proposal for additional information i.e., submission of revised PFR, latest cluster certificate and correct DSR with 45 days.
- A. Serial No. 64: The Authority accepted the recommendations and additional conditions of SEAC and decided to <u>grant TOR under violation</u> to this proposal with the condition to submit past production certificate from Mining Department for FY 2022-23 and latest LOI/Lease sanction order at the time of submission of TOR compliance/EC applications.
- B. Serial No. 69, 70, 71: The Authority decided to grant Transfer EC with the condition that the PPs concerned shall apply for TOR under violation within 45 days. In addition to this, RSPCB must monitor the same and ensure that such application is submitted on the portal within the time provided, in absence of which necessary action be taken to stop production.
- C. Serial No. 72: The Authority decided to grant Transfer EC to this proposal.



D. Serial No. 73, 74, 75, 76, 77, 78: The Authority decided to grant Transfer EC to these proposals with a direction that since these were the ECs issued by DEIAA, the PPs concerned shall apply for reappraisal within 30 days as per MoEF&CC OM Dated 28/04/2023 and Hon'ble NGT order dated 07/12/2022.
