The members present declared that there are no conflicts of interest with the projects being considered in this meeting.

The Member Secretary, SEIAA welcomed the Chairman and the Member of SEIAA. After general introductory remarks by the Chairman, SEIAA, the Committee took up items agenda-wise and reviewed the recommendations of State Expert Appraisal Committee (SEAC). After detailed deliberations & discussions on recommendations of the SEAC, the SEIAA recorded their decisions on case to case basis as under.

The SEIAA discussed in detail the recommendations of SEAC, the SEIAA approved for issue of EC in its meeting held on 03.07.2025 subject to submission of revised EMP duly signed by the proponent, along with the following additional conditions:


1. The proponent shall implement occupational health and safety to the employees and provide insurance.
2. The proponent shall transfer money through online/cheque only for CSR activities.
3. The proponent shall maintain the photographic evidence of CSR activities.
4. The proponent shall implement waste management plan.
5. The proponent shall develop greenbelt along the boundary and approach road.
6. The proponent shall comply to Ministry's OM dt:24.07.2024 for plantation in the earmarked green belt area as part of tree plantation campaign "Ek Ped Maa Ke Naam".
7. The project proponent shall upload self-certification report in the parivesh portal as per format every year on 1st June and 1st December.
8. The proponent shall carry out ambient air quality monitoring by NABL approved laboratory and submit the reports every quarterly.


However, the project proponent has not submitted the said information so far.

Meanwhile, a complaint was received from Smt. P. Indira Reddy vide mail dt: 13.07.2025 and a copy of the same was also forwarded by MoEF&CC, GoI vide mail dt: 25.07.2025 against the proposed project. It is also noted that there is a O.A No. 09 of 2022 in the Hon'ble NGT, Chennai w.r.t Sy.No. 268 of Bandaraviryala Village, Abdullapurmet Mandal, Rangareddy District.

Further, it is also noted that the Mine lease has expired on 13.11.2023.

In view of the above, it is decided to referback the said proposal along with the complaint of Smt. P. Indira Reddy dt:13.07.2025 to SEAC to re-examine, if required duly forming a sub-committee for site inspection and submit the report along with recommendations.
