LOCATION OF MINING LEASE IN PANNA LANDSCAPE




Figure 10.13 Area (terrestrial and riparian habilat) proposed for landscape consolidation




Figure 10.45 Areas to be consolidated in Satna Forest division

A few forested compartments of the Amarpatan & Maihar Range of Satna Division falling within the 10 km zone of influence. No national park, wildlife sanctuary or tiger reserve is located within it and no wildlife/tiger corridor passes through the 10 km zone of influence. Distance to nearby protected areas as per the kml file obtained from Digital Support System (DSS) available in NTCA website and the spatial data from the Madhya Pradesh Forest Department is as under:





MAP SHOWING THE DEMARCATED PURCHASED LAND & TO BE PURCHASED ANNEXURE 5






