This has reference to the above mentioned **Latest ADS letter from MOEF &CC reference no.18 dated 5<sup>th</sup> Aug 2023** on the proposal for setting up a green field Pellet Plant by M/s. Essar Minmet Ltd., at Paradeep.

**EAC Observations:**

*Ref no 2: A proposal for EC, as per the details given below has been examined by the Member Secretary. The said proposal has not been accepted on account of the Additional details sought as per the statement uploaded on the portal of Ministry. Please upload the Additional details sought by Member Secretary.*

**PP information on EAC observation and current status:**

1. The matter for Public Hearing for Beneficiation Plant is continuously being pursued with Principal Secretary Industries- Govt. of Odisha, Collector-Keonjhar and Member Secretary - Odisha State Pollution Control Board.
2. The matter of Public Hearing for linked project Beneficiation plant at Tikarpada-Keonjhar was again taken up with Member Secretary – OSPCB on 26<sup>th</sup> May 2023 vide letter no. EML/General/23/44. Based on the same Member Secretary OSPCB has taken up with Collector Keonjhar on vide letter dated 26/06/2023 for conducting Public Hearing. Same is enclosed.
3. The issue of the delay in Public Hearing for Beneficiation plant is also taken up with Ministry of Steel , Govt of India on 1<sup>st</sup> Aug 2023 through the National Infrastructure Pipeline Project (NIP) report highlighting the steps taken by EML on the matter. This will be discussed by Ministry of Steel , GOI with Chief Secretary Govt of Odisha.

Sir,

In inviting reference to the subject cited above and letters under reference, this is to intimate that the unit has applied for Environmental Clearance for Pellet Plant of capacity 14MTPA for which Public Hearing has already been conducted 05.01.2022 and the proceedings has already forwarded to the Secretary, MoEF&CC, Govt of India. But the Public hearing date, time and venue is not fixed for the installation of 14.3 MTPA capacity Iron ore Beneficiation Plant at Tikarpada in the District of Keonjhar till date.

As per the recommendation by the Expert Appraisal Committee in its 13<sup>th</sup> meeting held on 14-15<sup>th</sup> September 2022 that, Pellet plant and Beneficiation plant are both interlinked projects, hence EC of the Pellet plant could not be considered without EC of the Beneficiation plant.

It may be noted that as per EIA notification 2006 and amended thereafter, of MoEF&CC, Govt of India, an environmental Public Hearing is mandatory to obtain Environmental Clearance from the concerned authority. As requested by the unit, Environmental Clearance application of the Pellet plant will be lapsed within 75 days from the ADS issued date. Public hearing is essential to obtain EC for Beneficiation plant and which can only be achieved after Public hearing is done.

Till date this office has not received any communication regarding the above subject matter. Earlier you were requested to fix a Date, Time and Venue for conducting Public Hearing of aforesaid project.

Based on the above context, I would request you to suggest a Date, Time and Venue for conducting Public Hearing of the above proposal to this office through Email: publichearing@ospboard.org with 40 days in advance.
