Accordingly, vide reference cited (2), SCCL submitted BG (No.0416822BG0000185, dated 05.05.2022) to TSPCB for a period of 2 years (from 05.05.2022 to 27.04.2024) and the same was acknowledged vide reference cited (3). However, there was delay in obtaining Stage-I Forest Clearance and obtained from MoEF&CC on 21.11.2023. Subsequently, BG and Stage-1 FC have been submitted to MoEF&CC. Hence, BG for the extended period was sought from the Bank and the same is being submitted for kind perusal. The details of the Bank Guarantee are as follows:




