In continuation to the earlier ADS raised and replies given by Essar Minmet Limited mentioned from reference no 2 to 7.

EAC Observations:

Point no 6: In view of above, PP is again advised to expedite the process of EC application for the integrated Iron Ore Beneficiation plant of 14.3 MTPA at Tikarpada Keonjhar District for further action on the instant project in the Ministry.

PP information on EAC observation and current status:

Point no. 1: Based on Letter Ref No EML/General/22/119 Dtd 30/12/2022 of Essar Minmet Ltd, addressed to The Member Secretary Odisha State Pollution Control Board (OSPCB) to expedite the Public Hearing Process for submission of Final EIA report to MoEFCC for appraisal, Member Secretary OSPCB has written a letter to Collector- Keonjhar vide letter no. 194 /IND-II-PH-956 dated 12/01/2023 requesting to suggest a date, time and venue for conducting Public Hearing for the Beneficiation Plant and inform Member Secretary OSPCB office.

Point no. 2: Our 14 MTPA Pelletization Complex with Slurry pipeline is registered under National Infrastructure Pipeline (NIP). The review meeting on this is conducted by Ministry of Steel, GOI and sometimes all related Govt. Ministries like MOEF&CC, Road Transports & Highways, and Railway officials are called. The issue of Public Hearing date for our Beneficiation Plant at Tikarpada-Keonjhar was discussed on 7th Feb 2023 based on our monthly report of Jan 2023 submitted on NIP status.

Point no. 3: Essar Minmet Ltd senior officials are continuously pursuing the matter with the State Govt. officials on issuance of Public Hearing date. It is understood that Odisha Truck Owner's Association is opposing the transportation through slurry pipeline. While the State Govt. is addressing the issue, no Public Hearing for many industries including ours has taken place. We are hoping that Public Hearing will be held shortly.

In inviting reference to the subject cited above and letters under reference, this is to intimate that the unit has applied for Environmental Clearance for Pellet Plant of capacity 14MTPA for which Public Hearing has already been conducted 05.01.2022 and the proceedings has already forwarded to the Secretary, MoEF&CC, Govt of India. But the Public hearing date, time and venue is not fixed for the installation of 14.3 MTPA capacity Iron ore Beneficiation Plant at Tikarpada in the District of Keonjhar till date.

As per the recommendation by the Expert Appraisal Committee in its 13th meeting held on 14-15th September 2022 that. Pellet plant and Beneficiation plant are both interlinked projects, hence EC of the Pellet plant could not be considered without EC of the Beneficiation plant.


It may be noted that as per EIA notification 2006 and amended thereafter, of MoEF&CC, Govt of India, an environmental Public Hearing is mandatory to obtain Environmental Clearance from the concerned authority. As requested by the unit(copy enclosed), Environmental Clearance application of the Pellet plant will be lapsed within 75 days from the ADS issued date. Public hearing is essential to obtain EC for Beneficiation plant and which can only be achieved after Public hearing is done.

Till date this office has not received any communication regarding the above subject matter. Earlier you were requested to fix a Date, Time and Venue for conducting Public Hearing of aforesaid project.

Under the above circumstances, I would request you to suggest a Date, Time and Venue for conducting Public Hearing of the above proposal to this office through Email: publichearing@ospcboard.org with 40 days in advance.
