This has reference to your online proposal No. IA/CG/RIV/131439/2017 and letter No. 5264/W/2019 dated 25.11.2019 for the Environmental Clearance to the Reservoir Project (12,260 ha) in Dhamtari, Chhattisgarh by Water Management Division, Government of Chhattisgarh.

  - Details regarding budgetary allocation for CER as per the Ministry O.M dated 01<sup>st</sup>
    May 2018 shall be submitted along with the activities proposed with time plan for
    implementation.
  - iii. The project falls in Udanti & Sitanadi Sanctuaries, status of Wildlife Clearance from the Standing committee of NBWL shall be submitted.
  - iv. QCI/NABET certificate for the period of baseline data collection shall be submitted.
  - v. Component wise status of construction of the project including balance work should be submitted along with the timeline for the construction of balance work.

- vi. ToR compliance of additional conditions as stipulated in the ToR letter shall be submitted.
- 3. Further, you are also required to submit an undertaking as part of the EIA report from project proponent, owning the contents (information and data) of the EIA report with the declaration about the contents of the EIA report pertaining to a project have not been copied from other EIA reports.
- 4. Also, as the project involves forest land, it is a pre-requisite for the project Proponent to submit a copy of the Stage-I Forest Clearance (FC) before grant of EC by the Competent Authority. In this context, it is advised to submit a copy of the **Stage-I Forest Clearance** in accordance with the Ministry's latest guidelines.
- 5. In view of Para Nos. 2 (Sl. i to vi), 3 & 4 above, it is advised to submit all the information as sought by the EAC at the earliest along with the Undertaking in the format given below, to enable us to process the proposal for further necessary action.
