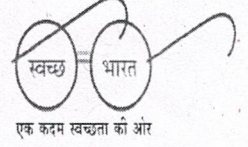

Sir,

This is to bring to your kind attention that MoEF&CC vide its letter J-11015/309/2010- IA.II (M) dated 20/05/2014 had communicated that Tawa-III UG Project (greenfield project) was recommended for grant of environmental clearance with the condition that formal EC would be issued only after the Stage – I Forestry Clearance is submitted. For this purpose a maximum time limit of one year was provided failing which, it was directed that the process of obtaining EC will have to be initiated de novo, as per the procedure under EIA 2006. The Stage-I FC for the quantum of forest land involved in the project, till date, is awaited. Subsequently the Project has been de- listed as seen in the MoEF&CC Portal.

Now based on the recast Project Report/ Mining Plan as approved and communicated vide no. WCL/BD SECTT/2018/104 dated 01.06.2018 a fresh Form – 1 has been prepared for Tawa-III UG Coal Mine Project and the application is being submitted for fresh TOR.

Therefore, please find attached herewith the duly filled in application (Form-1) prepared in line with EIA Notification, 2006 along with Executive Summary of approved Project Report and proposed Terms of Reference (TOR) for Tawa-III Underground Project (Production capacity of 0.60 MTPA and land area of 207.47 ha) of WCL located in Village Gandhigram, Tehsil Ghoradongari & District Betul, Madhya Pradesh State.

You are, therefore, requested to kindly consider the aforesaid application for grant of TOR.
