CHAPTER 1.0 PUBLIC CONSULTATION

1.0 Introduction

Public hearing for the project was conducted on 29.08.2017, from 10.00 A.M onwards at Project site, Pachanapalli Village, Chittoor Mandal and District. The chairman of the public hearing was Smt. S. Razia Begum, District Revenue Officer and Additional District Magistrate, Chittoor District while the member convener was Sri A. Narendra Babu, Environmental Engineer, APPCB, Regional Office, Tirupati.

1.1 Advertisement

Advertisement for the public hearing was notified in two prominent news papers namely, Andhra jyothi a Telugu daily news paper on 29.07.2017 and Hans India (English), an English newspaper on 29.07.2017.

Minutes of the meeting

The minutes of the public hearing along with the attendance sheet is enclosed in annexure.

Lakshmanan Cements Pvt Ltd has proposed to establish a standalone Cement (OPC/PPC) Grinding unit with a production capacity of 300 TPD at Survey No. 69-3, 69-4, Pachanapalli Village, Chittoor Mandal & District on 29.08.2017 at 10.00 a.m.

In accordance with the Notification No. S.O. 1533 dt. 14.09.2006 of Ministry of Environment & Forests, Government of India, New Delhi, the Environmental Engineer, Andhra Pradesh Pollution Control Board, Regional Office, Tirupati issued a notification pertaining to the Environmental Public Hearing on the M/s. Lakshmanan Cements Pvt Ltd has proposed to establish a standalone Cement (OPC/PPC) Grinding unit with a production capacity of 300 TPD at Survey No. 69-3, 69-4, Pachanapalli Village, Chittoor Mandal & District in leading newspapers published on 29.07.2017 inviting suggestions, views, comments and objections of the general public and was conducted on 29.08.2017 at 10.00 a.m and the minutes of the meeting are as follows:

The Environmental Engineer, A.P. Pollution Control Board, Tirupati welcomed the **District Revenue Officer and Additional District Magistrate, Chittoor District** & Chairman of the Public Hearing panel and Public gathered at the Public Hearing venue. He explained the need to conduct Public Hearing for the proposed project as per the Ministry of Environment & Forests, Govt. of India, New Delhi notification 2006.

He also explained as per the Terms of Reference (TOR), Ministry of Environment & Forests, Govt. of India vide letter dt. J-11011/231/2016-1A-II(I), Dt: 18.01.2017 it is necessary to get the public hearing conducted for this project for obtaining the Environment Clearance in accordance with the procedure prescribed under the EIA Notification 2006 for establishing similar type of Cement Grinding units. Then he requested the District Revenue Officer, Chittoor District to take over the proceedings of the Environmental Public Hearing.

Then District Revenue Officer and Additional District Magistrate, Chittoor District & Chairman of the Environmental Public Consultation while speaking on the occasion, she informed to the public that the Government has made mandatory to get the public hearing done before establishing certain line of activities of the industries. The surrounding people may utilize the opportunity to express their views, suggestions, objections if any on the proposed industry and same will be recorded and sent to Government for taking necessary action on the proposal of the industry.

Sri. G.Bhaskar, Director, M/s. Lakshmanan Cements Pvt Ltd while speaking on the occasion requested the people for their co-operation for establishment of the industry.

Sri. M. Srinivasa Reddy, Environmental Consultant of the project, M/s Team Labs & Consultants, Hyderabad while explaining the salient features and technicalities of the proposed project informed that M/s. Lakshmanan Cements Pvt Ltd, is proposed to establish a cement clinker grinding unit at an area of 1.41 acres with an project cost of Rs 1.35 Crores.

He briefly explained the project process that a ball mill will be used for grinding of clinker and other additives then screening and packing. With regard to water pollution industry proposed to use water of 5 KLD only for water sprinkling, greenbelt development and domestic purposes. There won't be any wastewater generation from the process. With regard to Air pollution industry proposed to provide bag filter to the ball mill to minimize the Air pollution on surroundings.

He also informed to the public that industry proposed to generate solid waste / Hazardous waste in the form of used batteries and waste oils. These wastes are proposed to dispose through authorized agencies. Industry has also proposed to develop greenbelt with 750 saplings to compensate the 25 mango trees are proposed to cut down for construction of the proposed project.

He also explained that they have collected base line data from 10 km radius in between December, 2016 to March, 2017 around the project site to assess the impacts arises from the proposed industry. The observed pollutants were within the limits as per National Ambient Air Quality Standards (NAAQS). During the study they have collected water samples and found that the water quality is within the standards stipulated.

Due to establishment of the factory the Socio-economic development of the surrounding villages will takes place and industry proposed to provide employment for 22 Nos preferably for locals.

Then The District Revenue Officer and Additional District Magistrate, Chittoor District requested the general public to express their opinions/ suggestions, objections, if any, on the proposed project, so as to record the same and will send to the State Level Environment Impact Assessment Authority (SEIAA), Andhra Pradesh for taking necessary action.

Sri N.Mohan, Sarpanch, Paluru panchayath while speaking on the occasion welcomed the industrial establishment and demanded the job opportunities to the local people on priority basis and requested the management to operate the industry without causing any pollution problems on surroundings.

Sri. K.Palakshi Naidu, r/o Lakshmi Puram, while speaking on the occasion requested the management to operate the industry without causing any air pollution as he owned a mango garden of 30 acres nearer to the proposed industrial establishment.

Sri. T.Johnson Raju, r/o Pachanapalli, while speaking on the occasion raised his voice that industry shall take the responsibility on environmental damages causes at surrounding area if any.

Sri. V.
