PROCEEDINGS OF THE ENVIRONMENTAL PUBLIC HEARING FOR THE PROPOSED 200 MW COAL BASED THERMAL POWER PLANT BY M/S MG POWER PROJECTS LIMITED HELD ON 29.12.2014 at 10.30 AM at GRAM PANCHAYAT OFFICE, PEDAVEEDU VILLAGE, MATTAMPALLY (M), NALGONDA DISTRICT.

At the outset, the Environmental Engineer, TSPCB, Regional Office, Nalgonda, while welcoming the public and the District Revenue Officer (FAC), Nalgonda District explained about the New EIA Notification 2006 of the Ministry of Environment and Forests, Government of India's EIA Notification No. S.O. 1533 (E) dated 14th September 2006. The Environmental Public hearing is made mandatory for certain category of projects to obtain prior environmental clearance. He stated that M/s. MG Power Projects Ltd., has proposed to establish 200 MW (1x135 MW & 1x65 MW) Coal based Thermal Power Plant at R.Sy.No.540/108/1A, 540/120/1A, 540/120/2B, 540/123/1, 540/123/2, 540/124/1, 540/124/2, 540/123/3A, 540/125/2, 540/128, 540/129/1, 540/129/2A, 540/129/2B, 540/129/3, 540/129/4, 540/144/2 & 540/144/3, Pedaveedu(V), Mattampally (M), Nalgonda District. The approximate project cost is Rs.1150.0 Crores.

The industry obtained TOR (Terms of Reference) from the State level Environment Impact Assessment Authority (SEIAA), AP, Govt. of India, Ministry of Environment and Forests (MoEF) after submitting draft EIA report and requested the Board to conduct public hearing.

Accordingly, a press notification was published in Telugu and English daily news papers on 29.11.2014 (i.e., Sakshi and The Hindu) pertaining to the present public hearing with 30 days advance notice.

The said notification invited public suggestions, concerns, comments and objections, if any, on the proposed project. He added that the copies of Draft Environment Impact Assessment/Environmental Management Plan (EIA/EMP) report and the executive summary in Telugu & English were made available to the people as mentioned in the press notification.

He further informed that the hearing is intended only to record the views, opinions, objections and suggestions of the participants and same will be conducted in a transparent manner and the proceedings will be video recorded. The minutes of the hearing along with the representations will be forwarded to the MoEF for further course of action. The said minutes will be placed for public access on the TSPCB website/ TSPCB office and copy will be communicated to the local Gram Panchayat Office for the public access. He then requested the District Revenue Officer (FAC), Nalgonda to preside over the public hearing process.

The District Revenue Officer (FAC), Nalgonda District, presided over the proceedings and explained briefly about the environmental public hearing process. He affirmed that the public hearing programme is necessitated to consider the proposal for environmental clearance from MoEF. He added that the objective of the hearing is to solicit and record the opinions, views, comments or objections of the people as such the panel is not vested with the powers to take any decision on the Environmental Clearance. The public hearing is a part of the environmental clearance process and that decisions are not taken during the hearing. He added that all the persons willing to offer their views orally or in writing on the proposed project will be granted the opportunity.

He further stated that the minutes of the hearing along with videography will be communicated to the MoEF for taking decision on environmental clearance. He then requested the Revenue Divisional Officer, Miryalguda Division, Nalgonda District to take forward the proceedings.

The Revenue Divisional Officer, Miryalguda Division stated that opinions, feelings, views, comments or objections can be expressed by all people on the proposed project. He then requested the management of the industry and their consultants to explain in detail, the salient features of the proposed project of M/s.MG Power Projects Ltd., for establishment of 200 MW (1x135 MW & 1x65 MW) Coal based Thermal Power Plant.

Sri Y.Maheshwar Reddy, Environmental Consultant, M/s.Pioneer Enviro Laboratories & Consultants Pvt. Ltd., Hyderabad explained about the proposed project as below:

- The industry proposed coal based thermal power plant of capacity 200 MW in which 1 x 135 MW and 1 x 65 MW power plants will be established.
- They proposed to adopt CFBC (Circulating Fluidized Bed Combustion) for Boiler which is latest technology in the world.
- In this technology, un-burnt coal particles are collected in cyclone and sent back to boiler for firing which gives complete combustion thereby reduced the emissions into atmosphere.
- Lime Stone bed is provided in the boiler which absorbs sulphur in the coal thereby reduces the sulphur emissions.
- Temperature less than 1100°C is to be maintained in the boiler so as to reduce the NOx emissions.

- ESP is proposed as Air Pollution Control equipment to control boiler emissions.
- Chimney of height 108 mtrs. (350 ft) is proposed to provide to 135 MW power plant.
- Chimney of height 87 mtrs. (230 ft) is proposed to provide to 65 MW power plant.
- Dust emissions are to be generated from coal handling activities like unloading, transportation coal to boiler for which water sprinklers and conveyers covering are proposed to control dust emissions.
- They conducted the Environmental Impact Assessment study on the Environmental quality before and after establishment of the project.
- Air Quality is within the National Ambient Quality standards prescribed by the Central Pollution Control Board.
- No affect on the environment due to proposed project as the industry management proposed all necessary pollution control measures.
- The required water of 19300 m³/day will be obtained from Pulichintala Reservoir of Krishna River.
- The industry generates boiler blow down, cooling tower blow down, DM plant regeneration as waste water and the same are treated and used for ash suppression, dust suppression and for green belt development. No effluent discharges outside the industry thereby adopting Zero Liquid Discharge (ZLD) system.
- Proposed to provide rain harvesting systems in the industry.
- Generated Ash is disposed as per the MOEF Guidelines.
- Proposed to dispose the ash to M/s. Sagar Cements Ltd., to utilize for cement production.
- Latest technology is adopted so as to control noise and noise levels will be within the noise standards.
- Proposed to develop green belt in 1/3rd area of the industry as per CPCB norms.
- There are apprehensions to the public on the thermal power plants.
- The thermal power plants already operating with existing old technology and colonies were developed in the surroundings of the existing thermal power plants with higher capacities at Kothagudem and Vijayawada areas and no pollution problems to them.
- No affect from the proposed project on the surrounding environment as latest technologies are proposed to be adopted.
- He requested the public to extend their cooperation for the proposed project.

The District Revenue Officer (FAC) has requested the NGOs and public to express their views, suggestions and objections on the proposed project and same will be recorded and sent to Government.

Sri P. Syam Sundarachary, B.Tech Student, R/o. Pedaveedu (V) has expressed as follows:

- In India, 58% of power generation is from thermal power plants and 22% of power is from hydel.
- This project is proposed to install 200 MW coal based power plant.
- In other places of thermal power plants with higher capacities like NTPC – 2000 MW in Karimnagar District and 1720 MW in Kothagudem, people are living without any pollution problems.

- He requested to provide jobs to local candidates.
- To take up development programmes to their village so as to make their village as model one in Nalgonda District.
- He requested to take necessary pollution control measures.
- He welcomed the project.

Sri D. Naresh, R/o. Pedaveedu (V) has expressed happiness on the proposed project in their village as they will get employment to unemployed youth. State Government is encouraging to establish power projects for generation of 7600 MW in this area. This project is not harmful. He welcomed the project.

Sri G. Vijaya Reddy, NGO, REEDs has expressed the following:

- Their NGO organization is taking up research on the affect on the surrounding environment before and after establishment of industries.
- We have to welcome the project and we have to force the industry to rectify the demerits in pollution control if any.
- Requested the management to take necessary measures to rectify the problems after establishment of the industry.
- The project is to be opposed with technical reasons but not general oppose.
- He requested to provide 100% jobs to locals.
- He requested to clarify on the allocation of water from the Pulichintala Project for industry purpose.
- The industry proposed to require 99 acres of land for the proposed project and industry will construct the compound wall all around their site which may cause obstructions to canals, water streams and pathways.
- He requested to develop the plantation particularly fruit bearing trees.
- He requested to prepare action plan on disposal of fly ash as there are more power plants are to be established in future.
- He requested to send the proposal to Government for permission.

Sri T. Hussain Naidu, Mellacheruvu has expressed the following:

- He requested to provide jobs to locals.
- Power Plant is necessary due to power shortage in Telangana State.
- No forest area and tigers in this region.
- He requested to clarify on the time required to restart the ESP in case of ESP trip.
- He welcomed the project.

Sri M. Saidi Reddy, President, Green Crop Society opined that industries are required to this populated Country. In other places of thermal power plants with higher capacities, people are living without any pollution problems and technology is changing and hence no problems are arise due to power plants. He welcomed the project as the State Government is encouraging the power plants due to power shortage so as to develop the cultivation and industries in Telangana. He requested to spend the CSR funds for health camps, free educations by providing schools, water facilities, instead of roads and buildings. He requested to provide 100 % jobs to local people particularly SC, ST & BC. He requested to explore to provide

website regarding information on development programmes adopted by the industry. He requested to form a 5 member team to take up plantation in 33% area and create awareness in development of green belt by the public in their houses and surrounding villages. He welcomed the project.

Sri E. Venkanna, Journalist, Nalgonda he expressed that industrialization is important in this Country. This power project is necessarily established due to power shortage in Telangana State. He requested to take up the latest technology measures so as local people may feel happy. He requested to develop the green belt more than norms i.e., 40 acres land preferably with neem plantation. He requested to provide jobs to locals and clear the apprehensions of the people. He welcomed the project.

Sri N. Srinivasa Chary, B.Tech Student, R/o. Pedaveedu (V) has expressed the following:

- NOx, SO2, CO2 & CO gases are emitted from the power plants and requested the industry to take necessary measures to control these emissions.
- At present power shortage to agricultural activity and he requested the industry to give generated power to local agricultural activity.
- He requested to provide 70% jobs to locals.
- Name of the Pedaveedu village is highlighted due to establishment of cement units in this area.
- He welcomed the project.

Sri R. Ramesh, Pedaveedu (V) has opined that poverty, unemployment & un-education are main reasons for backward socially. Japan & America preferring for nuclear power plants which are more affected one than coal based power plants and hence we have to welcome the project. We have to demand for providing health facilities, jobs to locals and other development programmes. He welcomed the project.

Sri B. Srikanth Reddy, B.Tech Student, R/o. Pedaveedu (V) has expressed that some persons are creating apprehensions among the tribes. Educated youth doing labour jobs due to not getting jobs. He requested to provide 70% jobs to local people and ensure that same should be implemented. He requested the industry to operate the pollution control equipments for entire period of the industry as per the Government norms. He welcomed the project.

Smt. Ch. Prasanthi, R/o. Pedaveedu (V) has welcomed the project as this project gives jobs to local and not harmful as already cement plants are existing in this area.

Sri K. Laxmaiah, Pedaveedu (V) has expressed happiness on the proposal as already suffering un employment problems. So many families are dependent on existing industries and similarly this project to give job opportunities to the local people. He requested to adopt the existing lift irrigation schemes in this area as the farmers are not able to maintain the same due to financial and power problems.

Sri G. Venkateshwarlu, Ex - ZPTC, Mattampally has expressed that this area was developed due to existing cement plants and similarly this proposed project will give employment to local people. He requested to extend their support in operating existing lift irrigation schemes. He welcomed the project.

Sri N. Harinder, Human Rights Forum has expressed the following:

- The proposed project is providing employment only for 120 people with Rs.1100 Cr investment as mentioned in the EIA reports.
- He questioned the industry how many permanent employments are provided to the local people.
- Zero emission system is not possible.
- The industry reported that they reduce the NOx emissions and not eliminate the NOx emissions. Human health will be affected due to NOx emissions.
- The industry reported that the industry uses 3500 TPD of coal for which require 350 lorries per day for transportation of coal and 150 lorries per day for ash transportation i.e., total of 500 lorries will be travelled on the village road which would cause dust emissions there by leads to accidents and pollution problems to the villagers.
- There is no latest technology in establishing thermal power plants as developed countries like America are not establishing these plants.
- As per EIA report, no sound pollution will be caused but lorry movement will be leads to noise pollution.
- Industry reported that there is no reserve forest but in recent News papers, presence of Cheetah in this area is appeared as News item.
- 1.7 Lakh Ltrs/day from Pulichintala project for which the industry has not obtained the permission.
- He opposed the project

The District Revenue Officer (FAC), Nalgonda District has requested the public express their views briefly and not to provoke the public.

Smt. G. Sulochana, Human Rights Forum has requested to give opportunity to affected people to express their views. She opposed the project.

Sri G. Laxminarayana, Lecturer (In teacher Education College), Pedaveedu has expressed the following:

- There will be losses and profits due to projects.
- He opined that if the project is established without loss, the project should be welcomed.
- He requested to clarify the apprehensions of the some of the people.
- He requested to provide jobs to locals particularly socially & economically backward people.
- He requested to provide schools and health facilities.
- He welcomed the project.

Sri S. Narendar Goud, Huzurnagar has felt unhappy for the proposal of power plant in the situation of organizing environmental meetings to control pollution by the United Nations Organization. Heavy metals such as Boran and Arsenic will be generated from the power plant which will affect on crops, aquatic life and already affecting due to existing units. Private units are not bothered about the public health and environment. He opposed the project.

Sri M. Swamy, Gurrampode Thanda has opposed the project as their Thanda (Hamlet of Tribes) is fall within 0.5 km.

Sri Dasru, Gurrampode Thanda has opposed the project as this project would affect their agricultural lands. He stated that he has 10 acres of land near the proposed project site.

Sri Ramavath Ramulu, R/o. Mattampally, Native of Gurrampode Thanda has expressed the following:

- He requested to give opportunity to people of Gurrampode & Krishna Thanda to express their views.
- Their Gurrampode Thanda was established as rehabilitated village due to Nagarjuna Sagar dam project.
- Everyone needs fresh air, water and land.
- Ground water will be affected due to proposed project thereby affect on the crop yield.
- They need power project and he questioned whether industry will take responsibility to solve the problems due to the project.

Smt M. Sali, Gurrampode Thanda has opposed the project and they are not required any jobs as this project will affect the people.

Smt Veeramma, Pedaveedu Village has opposed the project as this project will affect the agricultural lands. She stated that she has 10 acres of land near the proposed project site.

Sri K. Ananta Reddy, Pedaveedu Village while welcoming the project he requested the industry to maintain existing lift irrigation schemes and give power to Government.

Sri B. Bhajan Naik, B.Tech Student while welcoming the project he expressed the following:

- The value of surrounding lands will rise and the people will get jobs.
- Pollution problems will be aroused to some extent even though adopting latest technologies.
- He requested the industry to ensure that pollution equipment are operated continuously.
- He requested to provide water plants for drinking purpose.
- He requested to withdraw the police cases against their villagers.

Sri M. Nageshwar Rao, Thummala Thanda has expressed that the surrounding lands of the proposed plant fall under Thummala Thanda. He supported the project.

Sri V. Srinivas, INTUC has expressed happiness for the proposed project. He requested to provide jobs local people. He opined that locals are opposing the project due to not fulfilling the assurances given by the earlier industries particularly on employment. He welcomed the project.

Sri D. Naveen Naik, while welcoming the project he expressed that earlier industries are not fulfilled the requirements of the villagers and not given jobs to their tribes. The existing units are not taken up development programmes. He requested to take up the development programmes, libraries, school, plantations and infrastructures.

Sri Eslavath Balaji Naik, President, Telangana Unemployed Youth Association has expressed the following:

- Power problems in this area particularly to farmers.
- Guvvala Gutta was rehabilitated due to Nagarjuna Sagar project to present location i.e., Gurrampode Thanda.
- He requested to educate the villagers on the proposed project.
- Industries are not fulfilling the assurances given in earlier public hearings.
- He supported the project.

Smt Saidamma, Gurrampode Thanda has opposed the project as this project would cause the health problems.

Smt Sheela, Krishna Thanda has opposed the project as this project would cause the problems and they are already suffering from the existing units.

Sri G. Janardhan Reddy, NGO has opined that some persons creating apprehension on the proposed project among the tribes. No one live without power and power is required to meet domestic and agricultural needs. He welcomed the project.

Smt J. Soni, Gurrampode Thanda has opposed the project as this project would affect the children and their village is existing within 0.5 Km. Handicapped persons are exist in Thanda. We are doing labour jobs for their lively hood. The proposed project is coming up adjacent to their habitation. She questioned whether the industry give assurance that children birth takes place without deformity.

Sri SK. Kasi Rizwi, Pedaveedu village has expressed that earlier they afraid before establishment of existing units. We have faith on this management as we enquired about them. We have to welcome this project as we are suffering due to power shortage. He requested to provide jobs to SC, ST & BC. He welcomed the project.

Sri Ch. Kashiram, NGO has expressed that nowadays, power is the main part for living the human beings. He requested to develop the neem, mango and other plantation. He requested to provide jobs to local people. He welcomed the project.

Sri Ravindar Naik, Gurrampode Thanda opined that power plant is required and he requested to clarify the apprehensions among the public. He welcomed the project.

Sri G. Ravindar, Tribal, Civil Engineer has expressed that power plants have not create problems and he requested the public not to oppose the project but they can demand for their requirements. The project will give more indirect employment than direct employment. He welcomed the project.

Sri Matangi Venkateswarlu, Ward Member, Peddaveedu Village while welcoming the project he expressed that direct employment may be less but the projects will give lot off indirect employment. This project will give livelihood to Tribes thereby they develop individually. He said that development took place in the area due to existing cement units. He welcomed the project.

Sri Markapudi Mukkanti, Pedaveedu Village has expressed power plants will not affect the people particularly causing abortions, health problems and crop damages. He welcomed the project.

Sri Krishna Naik, PhD Student has opposed the project strongly.

Smt Syed Bibi, MPTC has welcomed the project.

Smt Megli, Krishna Thanda has opposed the project as this project would affect their lands. She has 8 acres of land near the proposed project site.

Smt Saidamma, Krishna Thanda has opposed the project as this project would affect the child birth and give birth with handicap.

Sri V.Koteswara Rao, Co-convener, Telangana JAC, Nalgonda has opposed the project and requested establish the power plants in coal mine areas to avoid losses.

The District Revenue Officer (FAC) has requested the industry management to give clarifications on the issues raised by the above speakers.

Sri Y.Maheshwar Reddy, Environmental Consultant, M/s.Pioneer Enviro Laboratories & Consultants Pvt. Ltd., Hyderabad has expressed the following in response to the clarifications raised by the speakers:

- Industry will see that plantation includes fruit bearing and neem plants.
- Regarding ground water pollution and crop damage,
 - ❖ Central Pollution Control Board (CPCB) prepares standards on quality of Air, Water & Solid Waste and the industry will comply with the CPCB standards.
 - ❖ The industry has conducted the EIA study and industry adopting latest CFBC technology.
 - ❖ The industry meet the standard of SPM – 50 mg/Nm³; SO₂ – 80 µg/m³, NOx -80 µg/m³.
 - ❖ Chimney will be designed as per CPCB norms to avoid any affect due to SO₂ emissions.
 - ❖ Lime stone bed will be provided for boiler to reduce the SO₂ emissions.
 - ❖ NOx emissions are generated if the temperature is greater than 1100⁰ C and hence temperature of 850⁰ C is maintained in the boiler to control NOx emissions and meet the CPCB standard.
 - ❖ There is no affect due to power plant when the plant is operated within the standards prescribed.
 - ❖ The industry will adopt zero liquid discharge system for effluent treatment through neutralization and treated effluents are to be used for ash suppression.
 - ❖ Regarding health problems, MOEF gives permission for power plants subject to follow the norms prescribed.
 - ❖ Trucks are covered during transportation to control dust emissions if any.
 - ❖ Regarding noise pollution, vehicles as per standards are selected for transportation.


- ❖ ESP is a pollution control equipment and coal feeding is stopped in case of ESP break down which is called inter locking system thereby no pollution affect on surrounding environment.
- ❖ Regarding Ponds and fishes, industry will adopt dust suppression systems, bag filter, conveyor covering and ZLD system hence there is no impact on surrounding environment.
- ❖ Ash is stored in silos and disposed to cement units.

Sri G. Vijaya Bhaskar Reddy, Vice President, M/s. MG Power Projects Ltd., has expressed the following:


- 70% jobs will be provided to locals particularly to Thanda people.
- More indirect employment will be generated due to this project.
- The industry give opportunity to Thanda people to avail health facilities and school.
- The industry provide school bus under CSR activity.
- The industry will provide 5 member team for development of green belt.
- The industry will take up the responsibility for maintenance and man power for the Gurrampode lift irrigation scheme and Pedaveedu lift irrigation scheme, after commissioning of the plant.
- The industry will also take up the maintenance of 2 motors belong to Ramachandrapura Thanda.
- The industry will not cause pollution problems to the surrounding agricultural lands and incase any problem aroused, the industry will acquire that lands as per the market rate.
- Irrigation department has issued permission for drawing the water. A copy was submitted to the panel of the public hearing.
- The industry will provide online monitoring system and in case of any break down of ESP, the plant will be stopped.
- He expressed thanks to one and all.

The District Revenue Officer (FAC), Nalgonda District, stated that the public hearing proceedings reflecting all the views and concerns expressed are recorded and the proceedings are drawn. The proceedings, representations along with the video- graphy will be submitted to SEIAA, MoEF, GOI for further course of action. The minutes will be made available for public access at TSPCB office and local gram panchayat.

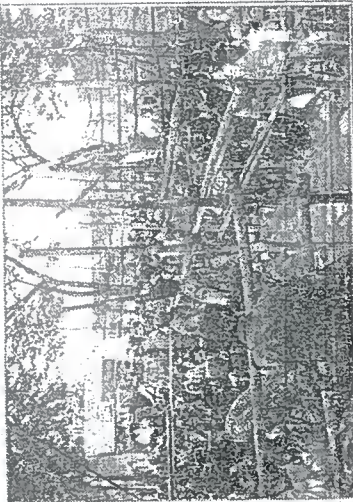

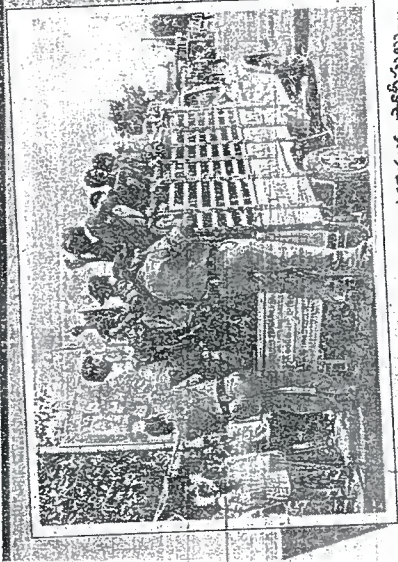
