


M/s Mylar Sugar Limited located at Sy No. 241/C3, 158/2, 251/A, 257/1,
248/1, 267/B, 248/B/1B, 263/2A, 269/C, 240/A, 247/A, 241/B, 243/A, 247/B,
247/D, 241/C1, 241/C2 of Birabbhi Village and Sy No.157/3, 157/1 of Kotihal
Village, Hoovina Hadagali Taluk, Ballari District has submitted EIA report for its
expansion of existing Sugar unit with crushing capacity from 3500 TCD to
10,000 TCD and Co-Generation Power Plant with capacity from 14 MW to 60

MW and establishment of 120 KLPD Distillery along with incineration Boiler to generate 5 MW Power. The project has to obtain Environmental Clearance from MoEF, Government of India, as per the EIA Notification dated 14.09.2006 (as amended on 01.12.2009) and it is mandatory to conduct Environmental Public hearing.

Accordingly, MoEF has issued the Terms of Reference (TOR) for this project & directed to conduct Environmental Impact Assessment (EIA) studies. In view of the above, the Project Proponents have prepared the EIA report and Executive summary of the said Project in Kannada and English version which has been submitted to Regional Office, Karnataka State Pollution Control Board, Ballari in accordance with EIA notification. As per MoEF, GOI Terms Of Reference (TOR) letter No. F.No. J-11011/136/2016-IA-II (I) dtd. 17.01.2016 and based on request of the project proponent letter dtd.12.06.2017, the Environmental Public Hearing is being conducted by the Board. In accordance with the EIA Notification, the Environmental Public Hearing notification was published in leading news papers of Karnataka State, i.e “Deccan Herald” (English) and “Vijaya Karnataka” (Kannada) on 22-09-2017 and in local news paper “Sanjevani” on 23-09-2017 and 21-10-2017 regarding the proposed project by inviting suggestions, views, comments and objections of interested bonafide residents, environmental groups and others located at project site and likely to be affected by the proposed project and informed to submit within 30 days from the date of publication of the Notification. The Rapid Environment Impact Assessment (REIA) report and Executive summaries with respect to the project were kept in designated places like: Deputy Commissioner’s Office, Ballari, Chief Executive Officer, Zilla Panchayat, Ballari, District Industry Centre, Ballari, Town Municipal Council, Hoovina Hadagali and Village Panchayat, Birrabbi, Regional Office, Karnataka State Pollution Control Board, Ballari, South Zone Office, MOEF, Bangalore and Help desk, KSPCB, Bangalore for public reference. Local publicity has been conducted through handouts and audio announcement in the surrounding villages such as Birrabbi, Aralihalli, Angoor, Kotehal, Hosahalli, Aralihalli Thanda, Kalenahalli, Hire Hadagali, Tumbinakere and Thumbinakere Thanda.



The Environmental Public Hearing was conducted on 23-10-2017 at project site of M/s Mylar Sugar Limited, Birrabbi Village, Hovina Hadagali Taluk, Ballari District. Dr. Doddashanaiah, Environmental Officer, Karnataka State Pollution Control Board, Ballari extended a warm welcome to Dr.V.Ramprasad Manohar, Deputy Commissioner and District Magistrate, Ballari District and Sri K.M.Nagaraj, Senior Environmental Officer, Divisional Office, Karnataka State Pollution Control Board, Ballari, Farmers and public who are attending the meeting. He briefly explained the purpose of conducting environmental public hearing and requested the Deputy Commissioner to conduct the public hearing.

The Deputy Commissioner informed the public regarding the purpose of conducting public hearing and appealed to ask any more information on the project after the presentation and informed the public to go through the presentation peacefully. If any objections, questions and more information required shall be asked after the presentation. Further, the Deputy Commissioner informed the project proponent to present the project details before the public.


Accordingly on behalf of M/s Mylar Sugar limited the environmental consultant of the company M/s Environmental Health and Safety Consultancy Pvt Ltd., Bangalore have made technical presentation on the proposed project in Kannada language and highlighting the proposed project activity impact and impact on air, water and soil and preventive measures taken by the industry. The presentation made by the project proponent is enclosed as Annexure-5.

After the presentation by the project proponent The Deputy Commissioner appealed to the public and invite them to express their views/suggestions/objections and more information required if any about the proposed project. Accordingly, the public have expressed their views/comments/objections related to environmental aspects of the proposed project. The following are the opinions and the suggestions expressed by the public.

1. Sri Madhav Rao, Harihara Taluk Kalasanur Co-operative Society Director, Nandigavi Village :

He expressed that since the existing sugar industries were closed in the district we are struggling to transport our sugar cane to other districts and facing lot of problems. Drivers were struggling for parking and facing lot of problems

with respect to food and other amenities. Mylar Sugar industry is located in this area they were happy to transport the sugar cane happily since the expenditure is less and getting more yield. Mylar Sugar company is co-operating with farmers friendly and helped the farmers time to time. He requested to give permission to the company for crushing of sugar from 3500 TCD to 10,000 TCD.

2. Sri Nagendra Muddi, Guhilagundi Village, Haveri District :

He expressed that, he is facing difficulties during the supply of sugar cane to M/s Renuka Sugars and waiting 3 to 4 days for unloading of sugar cane in a queue. Drivers and farmers are facing very difficulty due to inconvenience for food and shelter. Since Mylar Sugar is established industry in this area the transportation cost is very less and industry is supporting the farmers by taking the sugar cane intime and farmers were getting maximum profit. He requested to give permission to the company for the proposed project.

3. Sri Prashuram Doddamani, Bhoo Sampathu Samrksana Samiti, Vice President, Angoor Village :

He expressed that, he is facing difficulties during the supply of sugar cane to M/s Shamanur Sugars and waiting in a long queue for unloading of sugar cane. Drivers and farmers are facing very difficulty due to inconvenience for food and shelter and also loss of yield due to drying of sugar cane until unloading. Since Mylar Sugar has established the industry in this area, the transportation cost is very less and industry is helping the farmers by taking the sugar cane intime and farmers friendly atmosphere and also they were supporting local farmers, the economy of farmers is improved. Further he expressed that he asked the industry to give employment to the locals and to give first preference to local farmers for crushing of sugar cane. Further requested to develop Birrabbi village under CSR activity and also requested to put pumpset to the river and provide agricultural facility to farmers to grow more sugar cane. He requested to give permission to the company for the proposed project.

4. Sri S.Chandrappa, Farmer, Hyarda Village :

He expressed that M/s Mylar Sugar company people has visited the surrounding villages before establishing the industry and advised the farmers to supply the sugar cane to their industry and assured to give more praise than others. Accordingly the industry has taken all sugar cane in the surrounding villages and gave more praise than others as per their commitment. Further, they

have are helping the farmers during cutting of sugar cane and transporation and their by helping the farmers. He requested the industry to given employment to the locals. He requested to give persmission to the company for the proposed project.

5. Sri Chennaveera Goudru, APMC Director, Holalu Village :

7. Sri Shantharaj, Rtd Head Master, Magala Village :





26. Sri Doddamani Deelabba, Birrabbi Village :



He expressed that due to establishment of Mylar Sugar company in this area will helping the surrounding farmers. He requested to give permission to the company for the proposed project.


35. Sri Shankar Tangoda, Birrabbi Village :

The Deputy Commissioner asked the project proponent to give explanation before the public with respect to the public objections spelled during the meeting. Accordingly the project proponent Sri Mahadevaiah Veeraiah Gachinmath have submitted the following information before the public :

- 1) M/s Mylar Sugar company have provided with air pollution, water pollution and solid waste management facilities as per the pollution control board directions / norms and agreed to provide all control measures as to related by the pollution control board for their proposed project.
- 2) Presently they have given employment to the local people and as per Saroji Mahishi report they have employed 80% of Kannadiagas only.
- 3) As a part of air pollution control measures they have planted 5000 trees which were generating more oxygen in the premises. Further proposed to plant 5000 trees in this regard they have submitted demand to the forest nursery and planning to grow 10,000 trees in the premises.
- 4) Under the scheme CSR industry has constructed toilets in the surrounding villages under Swach Bharath Abhiyan. They have proposed to construct more toilets and planting more trees in school premises in surrounding villages.
- 5) They have constructed 5000 cubic meter capacity RCC tank for collection of treated effluent and this water is going to be use for developing greenbelt in the premises and there is no question of discharging treated / untreated effluent outside the premises at any point of time. Hence there is no chance of water pollution in the area.
- 6) They have provided fencing allround the industry premises and there is no chance of entering the stray animals inside the premises.


- 7) They have agreed to adopt Birrabbi nearby village and provide all infrastructure such as road, toilet, water, health and education. In this regard they have agreed to prepare action plan and will be submitted to District Administration as early.


After the project proponent celebration the Deputy Commissioner appeal to the public to give opinion if there any further objections / need of information. Accordingly one public who is speaking already Sri Doddamani Pakkireshappa expressed and informed that his agriculture field located adjacent to the industry and he is facing problem of air pollution and water pollution due to which the crop is being damaged. Hence, he is appealed the Deputy Commissioner to get the compensastion from the industry if they were failed to give compensastion is going make suicide.

Further the Deputy Commissioner asked the Environmental Officer of Pollution Control Board and express the compiled proceedings happened since from the beginning before the public. Accoridngly the Environmental Officer Dr.Doddashanaiah has expressed compiled proceedings before the public accordingly out of 35 orall discussions by the public 32 are speaking by faviouring the project and 03 are submitted their agitation against the proposed project.

The Deputy Commissioner concluded the compiled proceedings and expressed before the public once again informed that out of 35 speakers 32 are favouring the proposed project and 03 were against the project. Further informed the complied proceedings of this Environmental Public Hearing will be prepared and forwarded to Ministry of Environment and Forest, GoI, New Delhi through Karnataka State Pollution Control Board, Bangalore for further deliberations & necessary action. Finally the Environmental Officer Dr.Doddashanaih has concluded the hearing by vote of thanks.

Further, the Publics/Organisations who have participated in the meeting have submitted 142 written Suggestions/Opinions on the proposed Project the same are enclosed as Annexure – 4.
