

Public Consultation

GIL proposes to set up captive resin manufacturing plant at Routhusuramala village, Thottambedu mandal, Chittoor district, Andhra Pradesh to cater upcoming medium density fiberboards (MDF) manufacturing unit.

Subsequently District Revenue Officer, Chittoor District requested the management of the proposed project to summarize and answer the concerns raised by the public during the environmental public hearing.

The Environmental Engineer, A.P. Pollution Control Board, Tirupati welcomed the District Revenue Officer, Chittoor District & Chairman of the Public Hearing panel and Public gathered at the Public Hearing venue. He explained the need to conduct Public Hearing for the proposed project as per the Ministry of Environment & Forests, Govt. of India, New Delhi notification 2006.

He also explained as per the Terms of Reference (TOR), Ministry of Environment & Forest, Govt. of India, Dated 14.12.2016 it is necessary to get the public hearing conducted for this project for obtaining the Environment Clearance in accordance with the procedure prescribed under the EIA Notification 2006. Then he requested the District Revenue Officer, Chittoor District to take over the proceedings of the Environmental Public Hearing.

Then District Revenue Officer, Chittoor District & Chairman of the Environmental Public Consultation while speaking on the occasion, she informed the importance of the Environmental public hearing to the public. She requested the public to utilize this opportunity for detailed discussion on the proposed project to know the details of benefits getting by the surrounding people due to the establishment of this industry. She also informed that she will make her comments after completing the discussions and assurances made by the project proponent on the issues raised by the public during public hearing. Then she requested the project proponent to explain salient features of the proposed project for information of the public.

Mr. Mahesh, Executive, M/s. Greenply Industries Limited welcomed the gathering. While speaking on the occasion, he informed to the public that M/s. Greenply Industries Limited has proposed to setting up Captive Plant for Resin Production – 1,00,000 Tons/Annum at Survey No. 97/1, 98 & 99, Routhu Suramala Village, Thottembedu (M), Chittoor District at an extent of 1.0 Acre for using the same in their MDF manufacturing industry with an project cost of Rs. 13.75 Crores.

He also informed the Public that M/s. Greenply Industries Limited is presently operating MDF, Plywood, Doors, Veneers manufacturing units at 4

states viz., Utharakahnd, Nagaland, West Bengal etc., and created employment for more than 4500 people. He further informed that, water requirement (10 KLD) will be fulfilled either drawing the same from Telugu Ganga Canal with permission to the Government or through by Borewell.

Then **Kum. Svega**, Environmental Engineer, M/s Vimta Labs Ltd, Hyderabad, while explaining the technicalities of the proposed project on behalf of the proponent of the project informed to the public that they have collected base line data from 10 km radius around the project site to assess the impacts arises from the proposed industry. The observed pollutants were within the limits as per National Ambient Air Quality Standards (NAAQS). During the study they have collected water samples at 16 locations and found that the water quality is within the standards stipulated and also fit for potable usage.

Water requirement for the proposed project is 10 KLD and the same is fulfilled by drawing from Telugu Ganga Canal with permission to the Government or through by Borewell. The proposed industry does not generate any waste water from the process and the waste water generated from flour washes is proposed to treat in equalization tank and sewage generated is proposed to treat in STP.

She also informed that, an amount of Rs 1.2 crores will be spent in the coming 3 years on surrounding villages under CSR Budget. She further informed drastic change in the socio economic scenario of the area may happen due to the establishment this industry.

Then the District Revenue Officer, Chittoor District & Chairman of the Environmental Public Consultation requested the general public to express their opinions/ suggestions, objections, if any, on the proposed project, so as to record the same and will send to the Ministry of Environment, Forests and Climate Change, Govt. of India, New Delhi for taking necessary action.

Sri S. Rajendranath Reddy, r/o Routhusuramala village while speaking on the occasion welcomed the establishment of the industry and brought the following to the notice of public hearing panel for kind consideration

1. As per the information furnished in the executive summary the employment generation is only 50 members during construction and 20 members after completion of the project. As it seems to a very less number of job opportunities available to the local public and requested to provide good number of jobs at their sister concern industries.
2. Providing of Health infrastructure facilities shall be developed at the surrounding villages especially to arrest seasonal diseases ie malaria etc.,
3. Establishment of well equipped schools at surrounding villages.
4. Providing of Protected drinking water supply systems at surrounding villages.

Sri Yagani Benny, r/o Poonabaka village, Nellore District while speaking on the occasion welcomed the industrial establishment at their area. He informed during public hearing that there are so many weaker section colonies located nearby the proposed establishment and they are very much co-operative with the management even they have given their land for laying of approach road to reach the proposed industrial premises. In this regard, he requested the management to provide proper education facilities at the said colonies and also requested to provide good number of jobs to the surrounding people either the way of direct or in-direct employment. He also stressed the importance of compensatory greenbelt development at the area for maintaining ecological balance.

Sri. Veera Raghavulu, r/o Pallemala village while speaking on the occasion informed that they are not having any apprehensions on the proposed establishment with regard to environment. He also informed the importance of the creating awareness on the surrounding agricultural farmers on growing of eucalyptus, subabuls in place of traditional crops as the raw materials of the

proposed project is eucalyptus and subabuls. He also requested to conduct skill development programs to train the youth of surrounding area for getting suitable jobs.

Sri. K. 
Then **District Revenue Officer, Chittoor District** requested the management of the proposed project to summarize and answer the concerns raised by the public during the environmental public hearing.


Sri. Suresh, Project Manager, M/s. Greenply Industries Limited, answered the following on the issues raised by the public during the public hearing.

1. The management has already recruited fresh people and giving training for the duration of 6 months and they will be suitably employed on the upcoming industry on permanent basis.
2. The management will deploy skilled / unskilled people mostly from surrounding villages on the upcoming project.
3. The management has already provided an RO plant at Routhusurumala village with a capacity of 1000 Lts./day.
4. The allocated CSR budget will be spent for development of surrounding villages in co-ordination with District Rural Development Authority (DRDA), Chittoor district.
5. As suggested, regular health camps will be conducted at surrounding villages.
6. As suggested, growing of greenbelt as per the Govt. norms the management will prefer to develop fruit bearing and medicinal plant.
7. Awareness programs to the local farmers on harvesting of alternative crops (Eucalyptus & Subabul) in place of traditional crops will be conducted and expressed faith that within 3 to 4 years the change may be occurred.


