



As per the minutes of the meeting of the Committee "For studying Hydro Pumped Storage and Wind Power Projects in the Country" held on 20.4.2017 in Ministry of Power, New Delhi, (copy encosed), the representative of Tamil Nadu Govt. has informed that Kundah PSP (500 MW) is under construction.

As per CEA records, M/s TNEB had submitted DPR of Kundah pump storage project (4x125=500MW) with an estimated cost of Rs.1005.20 Crores in Nov, 2006 in CEA for concurrence. The DPR of the project was examined and returned to TNEB in Dec, 2007 due to non resolution of inter-state issues between Kerala, Tamil Nadu, Karnataka and Puducherry.

In view of the above statement given by representative of Tamil Nadu Govt. that Kundah PSP is under construction, it is requested to kindly intimate that who has concurred the project and what is exact status as on date.





Referring to the letter cited, the following details are furnished:

- I) i. The 'Detailed Project Report' on Kundah Pumped Storage HEP (4x125MW) was returned by CEA during December-2007 before notification of Cauvery Water Disputes Tribunal Award. Now, the CWD Tribunal Award (February-2013) has been notified (Clause- xviii) it is mentioned that, 'Nothing in the order of this Tribunal shall impair the right or power or authority of any State to regulate within its boundaries the use of water or to enjoy the benefit of water within the State in a manner not inconsistent with the order of this Tribunal'.
 - ii. The Kundah Pumped Storage HEP is neither a conventional HEP nor an irrigation project. It is purely a pumped storage project involving only recycling of 5.184Mm³ (0.18TMC) of water between two existing reservoirs. No new reservoir is envisaged in this project. The quantum of recycling of water is only 0.18 TMC which does not in any way affect or have any bearing on the Inter State allocation of water.
 - iii. This scheme gives quality and reliable power to meet the peak hour demand.
 - iv. Already Ministry of Power/GOI is driving to install more number of Pumped Storage Projects to augment the vast growth of Power under Non Conventional Energy resources such as wind, solar, etc., This project will fulfill the above objective.
 - v. Moreover, the Kundah basin depends entirely on the catchments in Tamil Nadu and on the down stream side the river flows only in Tamil Nadu. Therefore, Inter State issue does not arise. A copy of basin map is also enclosed for reference.



- II) Government of Tamil Nadu accorded approval for execution of this project in 3 phases within the State Government's powers of sanction vide GOs cited below:
 - a) Approval for execution of Phase-I (1x125 MW) accorded vide GOTN, GO. Ms. No.133.Dt. 3.12.08 for Rs.486.46Cr.
 - Approval for execution of Phase-II (2x125 MW) accorded vide GOTN, GO. Ms.No.50, Dt. 29.4.13 for Rs.498.58Cr (Addl. capacity).
 - c) Approval for execution of Phase-III (1x125 MW) accorded vide GOTN, GO. Ms.No.44 Dt. 20.6.14 for Rs.229.86Cr(Addl. capacity).

Accordingly the works have been commenced for this project and is under progress. Copies of the above GO's are enclosed.

2) Present Status of the project:

Construction of Access Tunnel for a length of 1000m and cable cum Ventilation Tunnel for a length of 500m have been completed. Approach road to all project components have also been completed. Expenditure towards the above and for other predevelopment works has been incurred for Rs.120 Crore. Financial tie-up has been already made with REC.

Tenders for other major civil works in 2 EPC packages are under finalization and works will be awarded by June-2017.

The tender specification for E&M works of Phase I (1x125MW) is under finalization. Tender is proposed to be floated by June-2017.

- M/s WAPCOS (a Central Government agency under CWC/ GOI) has been engaged as Consultant to this project from Specification preparation to Commissioning.
- As requested by the Director/ Hydro Project Monitoring Division, vide CEA Ir dt.04.05.2017, the details for monitoring the progress of this project have been furnished to CEA in TANGEDCO Ir dt.23.05.2017. (Copy enclosed). Monthly progress report for the month of May-2017 also has been sent to the Monitoring Division.





In the G.O. first read above orders according in principle approval have been issued for taking up the work of Kundah Purnped Storage Hydro Electric Project (500 MW) in the Nilgins District of Tamil Nadu.

- 2) In the G.O. second read above the Government have accorded approval to execute the Kundah Pumbed Storage hydro-electric Project (4x125 MW) in Nilgiris District in phases and to take up the phase I (1x125 MW) execution initially at a project cost of Rs 488.48 crores.
- 3) The Chairman and Managing Director, Tamii Nadu Generation and Distribution Corporation Limited in the reference third read above has stated that due to the poor financial condition of the Board earlier, the project execution could not be taken up. Considering the present power situation in the State and also that

the Power Finance Corporation and Rural Electrification Corporation, New Delhi have agreed to lend finance for the new project. Tamil Nadu Generation and Distribution Corporation Limited Board has decided to revert to the earlier stand of taking up the project execution in Phases each phase within the powers of the State Government and to operate the Phase I execution as ordered in the G.O. second read above. The ore-development activities / residual studies for taking up the phase I execution are in progress.

4) The project cost of Phase II (2x125 MW) which includes exclus ive civil works for unit 2 & 3 and supply, erection, testing & commissioning of 2nd & 3rd Units along with all the project enabling works has been worked out at the current price level and as detailed below.



In the G.O. first read above, orders according in principle approval have been issued for taking up the work of Kundah Pumped Storage Hydro Electric Project (500 MW) in Nilgiris District of Tamil Nadu

- 2. In the G.O second read above, the Government have accorded approval to execute the Kundah Pumped Storage hydro-electric Project (4X125 MW) in Nilgiris District in phases and to take up the phase I (1X125 MW) execution initially at a project cost of Rs.488.48 Crores.
- 3. In the G.O. third read above, Government have accorded approval to execute the Phase II (2X125MW) of the Kundah Pumped Storage Hydro Electric Project in the Nilgiris District at a project cost of Rs.498.58 Crores subject to conditions that Environment Clearance and consent from the Tamil Nadu Pollution Control Board be obtained.
- 4. The Chairman and Managing Director, Tamil Nadu Generation and Distribution Corporation Limited in the letter fourth read above, has stated that Kundah pumped storage hydro-electric project (4X125MW) is proposed to meet demands of the State grid during peak period and to ensure quality & reliable power supply by flexible operation of State grid. The execution of this project is proposed to be taken up in three phases.

- 5. The Phase I of this project includes all civil works viz., Head race tunnel, head race surge shaft, Adit to Head race surge shaft, 2 numbers pressure shafts, 4 numbers penstocks, Power house Cavern, transformer cavern, Tail race surge shaft, adit to tail race surge shaft, Access tunnel, Cable cum ventilation tunnel & tail race surge shaft, Mechanical works for all the four units. Erection, Testing and Commissioning of turbo-generator of first 125 MW along with EOT crane. Further an underground power house will be constructed to house 4 units of 125 MW each.
- 6. The Phase II of this project includes Civil works such as pressure shaft, penstock lining & machine foundation pertaining to 2nd & of 125 MW each alongwith all project enabling works.
- 7 The Phase III (1X125MW) includes civil works such as penstock lining & machine foundation pertaining to the 4" unit and supply, erection, testing & commissioning of 4" unit along with all the project enabling works.
- 8. The project cost of Phase-III (1X125 MW) has been worked out at the 2012-2013 price level and as detailed below:-

PROGRESS & PRESENT STATUS OF THE PROJECT:

- Main Access Tunnel (MAT) for a length of 1000m has been completed.
- Cable Cum Ventilation Tunnel (CCVT) with concrete lining for a length of 500m including portal has been completed.
- Formation of approach roads to Head race Tunnel Intake, Adit of Head Race Tunnel Surge Shaft, Upper reservoir (Porthimund) and Dumping yard have been completed including strengthening of existing roads.
- Power supply arrangements to Adit of Head race Tunnel and other construction locations have been made.
- Works completed to a value of Rs. 128.57 Crore so far.
- M/s WAPCOS, the Consultant prepared the tender Specification for EPCC Packages and the tender analysis carried out for Packages I & II (Civil & Hydro-Mechanical works).
- Civil & Hydro-Mechanical Packages I & II to a total value of Rs.600 Crore are to be awarded by Nov'17.
- Tenders for EPC Package III (E&M works for Unit -1) to a value of Rs. 312 Crore and EPC Package –IV (Phase-II) (E &M works for Unit 2 & Unit 3) to a value of Rs. 444 Crore have been floated during Sep'17 & Oct'17.
- Tender for EPC Package –V (Phase –III) (E&M works for Unit -4) to a value of Rs. 196 Crore is uploaded on 23.10.17.
- Tender opening for all the above E&M Packages is proposed during Dec'17 and it is proposed to award E &M Packages by 06/2018.
