

Dear Sir/Ma'am,

This is in reference to the query dated 04.11.2017 raised under Essential Details with reference to our proposal no. IA/GJ/IND2/62465/2017 regarding the conformity of the of the project activity vis-à-vis the ToR issued for the stated project.

We take this opportunity to state that as per the EIA Notification, 2006 and its subsequent amendments, our proposed project for the manufacture of cellulose based Bulk drugs falls under the category of 5(f) - **Synthetic Organic Chemicals Industry (Dyes & dye intermediates, bulk drugs and intermediates excluding drug formulations; synthetic rubbers; basic organic chemicals, other synthetic organic chemicals and chemical intermediates).**

Based on the above, when we file the related Form 1 as well as the pre-feasibility report, we had selected the option from the drop down menu which stated: **"5(f) Synthetic Organic Chemicals Industry (Dyes & dye intermediates, bulk"**

Initially, we took this to be a technical limitation of the drop down menu to completely describe the category 5(f). However, the stated words were repeated in:

1. The Acknowledgement slip which described the category as - **"Synthetic Organic Chemicals Industry (Dyes & dye intermediates, bulk"**
2. The Acceptance slip which also stated the category as - **"Synthetic Organic Chemicals Industry (Dyes & dye intermediates, bulk"**
3. The Terms of Reference which too stated the category as - **"Synthetic Organic Chemicals Industry (Dyes & dye intermediates, bulk"**

We believe that the wordings used by the dropdown menu could lead to misunderstanding of our project thereafter also, when we apply for Consent to Establish (CTE) followed by Consent to Operate (CTO).

To avoid such a future happening, we have termed the project to be for the manufacture of Bulk Drugs which also is a part of (the complete description of category) 5(f) - **(Dyes & dye intermediates, bulk drugs and intermediates excluding drug formulations; synthetic rubbers; basic organic chemicals, other synthetic organic chemicals and chemical intermediates).**

We request you to consider the above stated facts and to process our application accordingly.
