This has reference to Environmental Clearance granted for establishment of 30 KLPD molasses based distillery unitfrom MoEFCC, New Delhi vide letter No. J-11011/71/2002-IA II (I) dated 29.09.2003.

Now, in light of VNSSKL participated in National Biofuel Policy 2018, the management has planned to expand distillery from 30 KLPDto 105KLPD(on Molasses/Cane Juice). Only Ethanol will be produced under expansion i.e. 75 KLPD and same will be solely used for EBP Programme.

As per the provisions of "EIA Notification No. S.O. 1533 (E)" dated 14.09.2006; as amended vide Notification No. "S.O. 1960 (E)" dated 13.06.2019; the proposed expansion of Sugar Factory, Cogeneration Plant are listed at activity 5(j) and 1(d) while distillery activity at 5(g- i&ii). Now, as per amended notification vide No.: S.O 980(E) dated 2nd March 2021, the expansion of distilleries that manufacturing Ethanol for use as fuel for blending shall be appraised as Category B2 project. Accordingly, our expansion project from 30 KLPD to 105KLPD shall be appraised as B2 category project at Centre level. As the Sugar, Cogen & Distillery projects are located in same premises as an integrated project complex, the entire proposal of expansion of Sugar, Cogen and Distillery is being submitted at 'Ministry of Environment, Forests and Climate Change (MoEFCC); New Delhi' for grant of EC.
