We are going for expansion; hence prior EC is required as per the provision of EIA notification 2006. No violation done. There is no show cause issued by UPPCB. The existing unit is located in industrial zone on private land. The land is not falling in notified Industrial Zone. As per the project cost; our unit is under SSI.
