This has reference to the above mentioned subject matter, for grant of EC for enhancement in capacity by 40% in respect of Singhori opencast. EC for Singhori opencast was granted by MoEF&CC vide letter no. J-11015/67/2006-IA.II (M) dated 17.05.2007 for 0.80 MTPA in total lease area of 428.0 ha.

Subsequently, an application consisting of compliance certificate against EC conditions (secured vide dated 31.01.2019 from RO,MOEF & CC, Nagpur) was submitted to MoEF & CC through online portal vide dated 31.01.2019 for grant of EC under 7 (ii) of EIA notification 2006 for Singhori opencast for 40% enhancement in capacity i.e. 0.80 MTPA to 1.12 MTPA.

As per the observations, Essential Details Sought (EDS) has been raised on dated 07.02.2019, the the details are given below:

		From the above, it can be seen that the EC Letter issued by MoEF&CC has recorded that the EC has been granted under the provisions of EIA Notification 2006.
		As such, for compliance of the Ministry's Notification dated 06.04.2018, the application for revalidation of the EC for Singhori Opencast Coal Mine Project (0.80 MTPA) accorded vide letter no J-11015/67/2006-IA.II(M) dated 17.05.2007 is not required.

		From the above, it can be seen that, the coal production is likely to reach the EC capacity by Feb'2019 and as such if EC for enhanced capacity is accorded that in the remaining period of FY 2018-19, additional production beyond existing EC can be achieved to meet the national demand. As such, the proposal may kindly be considered for grant of EC for enhancement of capacity by 40%.

Sir,

This has reference to the above mentioned subject matter, for grant of EC for enhancement of 40 % capacity of Singhori OC. EC for Singhori opencast was granted by MoEF & CC vide letter no. J-11015/67/2006-IA.II (M) dtd 17.05.2007 for 0.80 MTPA in total lease area of 428.0 ha.

It may be further mentioned that, FC (Stage II) for 14.23 ha has been secured vide letter no FLD-3408/C.R 348/F-10 dated 29.11.2018 & forest land of 0.96 ha has been diverted in favour of Executive Engineer, MAHAGENCO for which FC (Stage-I) secured vide letter no. FC-I/MH-06/2015-NGP/1318 dated 03.02.2017.

Considering the present scenario of the mine and surged demand of power grade coal from WCL Coal mines for the power plants of Maharashtra, a Mining Plan has been prepared for enhancement of capacity by 40% and it has been approved by WCL Board in 307th meeting held on 24.12.2018 (resolution vide no WCL/BD/SECTT/BM-307/2019/023 dated 01.01.2019). The Mining plan has in built mine closure plan. The certificate of compliance from RO, MOEF & CC, Nagpur has been secured vide letter no. 3-10/2010 (ENV)/4874 dated 31.01.2019

Subsequently, EIA-EMP for Singhori Opencast with increase in production capacity from 0.80 to 1.12 MTPA within area 426.00 ha covered under existing EC land of 428.00 ha located in Singhori village, Parseoni tehsil, Nagpur District, Maharashtra has been prepared and enclosed along with this letter in both hard and soft format.

It, is therefore, most earnestly solicited that our above submission may kindly be considered for grant of EC under 7 (ii) of EIA notification 2006 for Singhori Opencast for 40% enhancement in capacity i.e from 0.80 to 1.12 MTPA.
