**Hindustan Oil Exploration Company Ltd. (HOEC)** intends to drill 24 developmental wells and construct & commission of two Gas Gathering Station (GGS), expansion of existing M-GPP and approx. 13.5 km underground pipeline.

We have received the standard ToR for conducting EIA study vide file No. IA-J-11011/102/2018-IA-II(I) dated 23 April 2018. EIA study has been conducted as per Standard ToR and study period was from October to December 2017.

During 2017 EC was granted to the Consortium vide File no. J-11011/245/2014-IA II (I) dated 31<sup>st</sup> January 2017 for six Development wells, Group Gathering Station (GGS), Gas Processing Plant (GPP) and 11.5 km Gas Pipeline from GGS to GPP. Public Hearing for the project was conducted as part of the EC process on 3<sup>rd</sup> July 2015.

The present proposal submitted for development phase is to enhance the production level by replicating similar scope of project activities like drilling of more development wells, commissioning of GGS, expansion of capacity of GPP and laying of underground pipelines.

The proposed activity area as per current proposal is also within the same study area of which EC was granted during July 2017 and PH for the project was conducted at Margherita, Tinsukia, Assam on 3<sup>rd</sup> July 2015.
