No.- J-11013/36/2014-IA-I, Dated- 10/12/2014) issued, Public Hearing (Public consultation) is not applicable to the project located within notified Industrial zone (notified before 14-09-2006); and our project site is located within the Notified Industrial Zone of Dadra and Nagar Haveli as per the regional plan notified vide no. 13-1(39)/95/PWD-I/2000/752 dated 05/07/2001. Hence, conducting of Public Hearing is not applicable to the proposed project as per EIA Notification 2006 and as amended. Hence, as per the TOR point no.-(i) of the awarded TOR Letter No.-IA-J-11011/337/2017-IA-II(I) dated 23/08/2017, public consultation is not required in terms of the provisions contained in para 7 (ii) of EIA Notification, 2006.
