**Sub: Proposal to obtain amendment on existing EC for 1.30 MTPA due to value addition facilities, technological upgradation, waste utilization and environment improvement facilities at JSW Steel., Salem works, Tamil Nadu– reg**

**Ref: i) EC Issued (F.No. J-11011/281/2006-IA. II (I) Dated: 7<sup>th</sup> July 2017) for the expansion of steel production capacity from 1.0 MTPA to 1.3 MTPA.**

**ii) EC amendment - ToR issued dated 09.11.2018 & Amendment in ToR issued dated 27.06.19**

This has reference to the above mentioned EC issued by your good office for the expansion of steel plant production capacity from 1.0 to 1.3 MTPA. The execution related to expansion is currently in progress (phased manner).

In view of installation of value addition facility of slag grinding unit (0.8 MTPA) and other few facilities related technological up gradation an amendment is requested (online application dated 19.09.2018) in the existing EC. Based on the 36<sup>th</sup> EAC (Industry –I) committee meeting dated 09.10.2018 a Terms of Reference (ToR) has been issued (F.NO. IA-J-11011/281/2016. IA. II(I) dated 09.11.2018) to submit EIA study report for further proceedings.

During the expansion activity it is identified that there is scope to improve waste to wealth management and work area improvement on environment front without increasing pollution loads with respect to EC issued earlier. With the objective to establish better environmental friendly facilities we have approached your good office to issue an amendment in the existing ToR dated 09.11.2018. Based on the 6<sup>th</sup> reconstituted EAC committee meeting (Industry-I) amendment in the existing ToR has been issued by your good office dated on 27.06.2019 with inclusion of proposed additional facilities. With respect to all the proposed facilities EIA study is done by competent EIA consultant and the report is ready for submission.


