Dear Sir,

We, Heranba Industries Limited(HIL) is planning to setup an agrochemicals plant of capacity 890 MTPA at Plot no. C-195 & 196, Sayakha Industrial estate, Village Sayakha, Taluka: Vagra, Distrct: Bharuch, Gujarat. Our project falls under Category 5(b) "A" as per Environmental Impact Assessment (EIA) notification. Thus, the proposed project is to be considered and appraised at the Central level and requires EIA study. The proposed project conducted public hearing on 02/06/2017.

Fresh water requirement for domestic and industrial activities will be fulfilled through GIDC water supply. Effluent will be segregated stream-wise and treated stream-wise in adequately sized ETP. The final treated effluent from the ETP will be reused in process. Sewage generated from the industry will be treated in septic tank /soak pit facility. Adequate Air pollution Control device will be installed with all the Flue Gas stacks and Process stacks. Hazardous waste generated will be collected, stored and disposed as per Hazardous Waste Management Rules, 2016.
