Dear Sir,

We, **Deepak Cellulose Pvt. Ltd.** located at Plot. No. **115&115/1** , GIDC Industrial Estate, Gundlav, Taluka: Valsad, Dist: Valsad, Gujarat is planning to go for an expansion project for manufacturing of BULK DRUGS (EXCIPIENTS) AND EMULSIONS. The project falls under Category 5 (f)-“B” as per EIA notification. Thus, the project is to be considered and appraised at the State level Expert Appraisal Committee (SEAC) and requires EIA study.

Fresh water requirement for domestic and industrial activities shall be fulfilled through GIDC water supply. Wastewater generated from the unit will be treated in adequate effluent treatment plant consisting of primary, secondary and tertiary treatment unit and taken into RO followed by Psychrometric evaporator to achieve zero liquid discharge.

In existing unit, there is no use of any boiler/thermopak/D G set and all the equipments are operated on electricity, hence there is no flue gas or process gas emission. After proposed expansion all the machineries will be operated on electricity hence there will be no flue gas emission. Also hot water will be supplied through proposed solar water system. Hence in proposed expansion also no process or flue gas emission will be generated.
