Our unit, **M/s Admark Polycoats Pvt. Ltd.**, is located at S. Nos. 206 & 207, Village - Luna, Padra Tal, Dist. -Vadodara and is involved in the manufacturing of Epoxy Hardeners. We have previously obtained EC from MoEF for our operations in the year 2009 vide letter **J-11011/91/2009-IA-II (I) dated 1st September, 2009**.

Presently, we intend to go for expansion in our production capacity from 1000 MT/month upto 2000 MT/month. For the same, we had made an application to MoEF&CC for ToR on 25/12/2015. Our case was considered during the 4th EAC Meeting for Industry-2, held on 12/02/2016 and the **ToR was granted through letter dated 31/03/2016**. As a part of the additional ToR stipulated to us, we are required to include a **certified report from MoEF&CC RO**, regarding the status of EC compliance of the existing unit in EIA/EMP.

For the same, we had made a request to your good office vide letter dated 19th May, 2016 and subsequent email communications dated 18/10/2016 and 21/03/2017.

Meanwhile the **Public Hearing for the project was conducted on 19th April, 2017**. Thereafter, again we had gotten in touch with your good office, and it was intimated to us to send a fresh request for Certified Compliance Report. Based on the same, <u>we had again made a request vide letter dated 6th May, 2017</u>. The copy of the speed post receipts and emails from our end are attached herewith, for your reference.

We would also like to add herewith that we have uploaded our Final EIA and associated documents and made application for EC on 27th May, 2017 vide online portal. <u>The same has also been queried by MoEF&CC and will</u> <u>only be scrutinized upon upload of the Certified Compliance Report issued by your good office.</u> The copy of the query is also attached herewith.

Considering the same, we hereby request you to undertake a visit of our site & issue us a certified compliance report based on your observations at your earliest convenience.
