Subject: Revalidation of Environmental Clearance of Parsa East and Kanta Basan Opencast Coal Mine Project (10 MTPA) and Pit Head Coal Washery (10 MTPA) in a total project area of 2711.034 ha; located in Hasdeo-Arand Coalfields, in villages Parsa, Kente, Basan, Salhi, Hariharpur, Ghatbara, Parogiya, Tehsil Udaypur, Dist. Sarguja, Chhattisgarh to M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited - reg.

The Ministry of Environment, Forest and Climate Change (MoEFCC), in accordance with the Environmental Impact Assessment (EIA) Notification, 2006 and subsequent amendment thereto had accorded Environmental Clearance (EC) for Parsa East and Kanta Basan Opencast Coal Mine Project (10 MTPA) and Pit Head Coal Washery (10 MTPA) in a total project area of 2711.034 ha; located in Hasdeo-Arand Coalfields, in villages Parsa, Kente, Basan, Salhi, Hariharpur, Ghatbara, Parogiya, Tehsil Udaypur, Dist. Sarguja, Chhattisgarh to M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited subject to compliance of terms and conditions stipulated in the EC/corrigendum/amendment letter No.. J-11015/03/2008-IA.II (M) dated 21st December, 2011; 22nd June, 2012 and 4th March, 2013.

WHEREAS the Supreme Court of India vide judgment dated 25th August, 2014 read with its order dated 24th September, 2014 has cancelled the allocation of 204 coal blocks and issued directions with regard to such coal blocks wherein the Central Government in pursuance of the said directions has to take immediate action to implement the said order.

WHEREAS in pursuance of the judgment and order of the Supreme Court, the nominated authority has, in accordance with provisions of the Coal Mines (Special Provisions) Second Ordinance, 2014 and the Coal Mines (Special Provisions) Rules 2014 conducted the auction of the mines.

WHEREAS Ministry of Coal (MOC) vide its O.M. letter no. 13016/38/2015-CA-III dated 12th May. 2015 from Ministry of Coal informing that, their Ministry has allotted 9 Coal Mines—through allotment routes to different allotees. MOC has requested this Ministry to facilitate transfer of the Environment Clearance and Forest Clearance of these blocks to the allotees.

WHEREAS Ministry of Coal vide allotment Order under clause (c) of sub-rule (2) of rule 7 and sub-rule (1) of rule 13 and Order no. 103/13/2015/NA dated 31st March, 2015 has allotted the Parsa East and Kanta Basan Opencast Coal Mine Project (10 MTPA) and Pit Head Coal Washery (10 MTPA) in a total project area of 2711.034 ha; located in Hasdeo-Arand Coalfields, in villages Parsa, Kente, Basan, Salhi, Hariharpur, Ghatbara, Parogiya, Tehsil Udaypur, Dist. Sarguja, Chhattisgarh to M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited as the successful allottee.

WHEREAS vide Gazette Notification S.O. 811 (E) Notification dated 23.03.2015, MOEFCC has made amendments to paragraph 11 in the Gazette Notification S.O.1533 (E) dated 14th September. 2006. Vide the said amendment; where an allocation of coal block is cancelled in any legal proceeding; or by the Government in accordance with law, the environmental clearance granted in respect of such coal block may be transferred, subject to the same validity period as was initially granted, to any legal person to whom such block is subsequently allocated, and in such case, obtaining of "no objection" from either the holder of environment clearance or from the regulatory authority concerned shall not be necessary and no reference shall be made to the Expert Appraisal Committee or the State Level Expert Appraisal Committee concerned.

WHEREAS pursuant to the MOC allotment Order no. 103/13/2015/NA dated 31st March, 2015 indicating that M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited is the allottee, for Parsa East and Kanta Basan Opencast Coal Mine Project (10 MTPA) and Pit Head Coal Washery (10 MTPA) in a total project area of 2711.034 ha; located in Hasdeo-Arand Coalfields, in villages Parsa, Kente, Basan, Salhi, Hariharpur, Ghatbara, Parogiya, Tehsil Udaypur, Dist. Sarguja, Chhattisgarh. Transfer of EC is not required as M/s Rajasthan Rajya Vidyut Utpadan Nigam Limited is already in possession of EC/corrigendum/amendment letter No. J-11015/03/2008-IA.II (M) dated 21st December, 2011; 22nd June, 2012 and 4th March, 2013. However, the said revalidation for EC is subject to the following conditions:



- (i) Any change in scope of work will attract the provisions of Environment Protection Λct (EPA), 1986 and Environmental Impact Assessment Notification, 2006 in conjunction with the subsequent amendments / circulars.
- (ii) All conditions stipulated in the EC/corrigendum/amendment letter No. J-11015/03/2008-IA.II (M) dated 21st December, 2011; 22nd June, 2012 and 4th March, 2013 shall remain unchanged.
- (iii) The allottee shall be liable, if any, for any act of violation of the EPA 1986 / EIA Notification 2006 /subsequent amendments and circulars which it has inherited during the transfer.
- (iv) Allottee shall be liable for compliance of all court directions, if any.
