**PROCEEDINGS OF THE PUBLIC HEARING OF M/S NALCO LTD. POTTANGI BAUXITE MINES FOR MINING OF 3.5 MTPA CAPACITY BAUXITE OVER AN AREA OF 697.979 Ha. AT VILLAGE POTTANGI, POTTANGI TAHASIL IN KORAPUT DISTRICT HELD ON 17.12.2019 AT 11.00 A.M AT MINI STADIUM, POTTANGI, KORAPUT**

The public hearing in respect of the above project was held on 17.12.2019 as per the schedule and at the venue in accordance with the EIA Notification S. O. 1533 (E) dt. 14.09.2006. The public hearing with regard to date, place and time was announced in Public Address System in nearby villages of proposed project site and also published in Local Dailies. The process followed for public hearing was adequate.

Er P Kar, Regional Officer, State Pollution Control Board, Rayagada welcomed the public to the hearing and briefed about the objectives, process & procedures followed for conducting such public hearing.

Sri Deben Kumar Pradhan, OAS (S.A.G.) Additional District Magistrate, Koraput presided over and supervised the public hearing. He briefed about the importance and objectives of such hearing and invited the project proponent to highlight on proposed project.

Sri Rabi Shankar Das, Executive Director (Mines & Refinery) & Dr P K Pattjoshi, Manager (Environment) of M/s NALCO Ltd, Damanjodi, Koraput has explained about the proposed project and briefed about the Pollution Control measures to be adopted in the Project.

The following is the summary of the public hearing proceedings, reflecting all the views and concerns expressed by the assembled public at the venue. It was recorded by the officials of the Regional Office, State Pollution Control Board, Odisha, Rayagada.

**1. Sri Pratap Kumar Choudhury, Pottangi**

Sri Choudhury described this hearing as a test for future livelihood of the locality. He informed that this area is at 3500 ft above & the climate is favourable for producing all seasonal vegetables round the year. Citing the example of Coriander leaves he informed that the local farmers are earning 20-25 crores annually from it by supplying it to consumers of the country throughout the year. He also informed that a Spices Research Centre exists in the locality & they are supplying spices like Ginger, Turmeric etc. to six different states. The farmers of this area are producing all types of vegetables and supplying to the country to meet their livelihood. They are also benefitted by the forest produce. He appealed to the Government for preservation of the local climate & environment. He informed that the proposed mines in the Serubandi hill is the origin of many perennial streams that forms Kolab reservoir. While questioning on reliability of claim made by NALCO on perenniality of the streams of existing bauxite mine of panchpattmali hills he suggested to get it certified from international Geological survey agencies. He apprehended the perennial streams may dry up & the local climate may change due to mining & questioned whether NALCO will be held responsible for such problems.

He informed they are native of this place and they enjoyed only two seasons i.e. winter & rainy during their childhood. He expressed his concern on climate change due to emissions from NALCO refinery. He expressed his dissatisfaction over non generation of thick forest in Koraput area. He informed that the life of Panchpattmali bauxite mine was initially planned for 100 years & now the life is reduced to 50 years due to market demand & the high grade bauxite available in Pottangi mine may reduced to 05 years instead of its planed period of 25 years. He apprehended the future adverse impact on climate & environment after NALCO left behind the mines. He suggested providing advance technology for agricultural development to the local farmers. Further he suggested to set up Small & Medium Industries in the locality with help of



NALCO for generation of employment for local youths to make them self dependent. He emphasised on protection of local climate & Environment from pollution due to mines & also appraised about the benefit obtained from water melon cultivation in the locality. He urged that they will consider the proposal of Mines of NALCO only after the development of irrigation facilities in the locality & employment for local youths in small industries by NALCO.

2. **Sri Nandi Bali Chaitanya, Panger**

Sri Chaitanya seeks clarification from NALCO regarding expenditure made on Peripheral development & expressed his dissatisfaction over the non fulfilment of their basic needs of drinking water & good roads by NALCO. He also questioned on installation of Industries in Tribal areas. He supported the views of previous speaker on climate change & apprehended that the local Ginger cultivation & livelihood of local inhabitants likely to be affected due to such climate change & drying up of water sources. He appealed the Government for development of education, Drinking water, roads facilities & employments for the locals prior to consider the mines proposal of NALCO.

He questioned to the NALCO that what people will do after job of 1<sup>st</sup> generation get over since they don't have land & their children are still studying. He informed that they are producing gold from their soil & what they will do if they get displaced as their livelihood depends on cultivation. He demanded quality education for locals to be competitive & better employment opportunities. He also expressed NALCO has failed in adequate plantation in surrounding Hills. He expressed his doubt over the proposed preventive measures of NALCO to maintain environment. He also apprehended that their next generation will face the adverse pollution impact once NALCO left the area. He explained the favourable climate for cultivation of fruit & vegetables in the area and supported the tourism for development of their livelihood. He told that they are ready to give their land for the development of the country provided their interest to be fulfilled. He emphasized on protection of environment due to climate change. He urged that the overall development of the area should be done first & there after they will consider the proposed mine of NALCO.

3. **Sri Muralidhar Guntha, Secretary, Serubandh Surakhya Samiti**

Sri Guntha read over the representation which was submitted to the chair during the public hearing & enclosed as Annexure-V.

4. **Sri Gamel Manju, Talganjeipadar**

Sri Manju strongly opined that they will not give the hill for mining as they are benefitted by the hill through cultivation and other forest produce. He told that the forest land belongs to Adivasis & apprehended that stream water will be dried up & forest will be affected. They can't survive without their land. He expressed his dissatisfaction of not getting any work opportunity. He informed that they are staying in the forest & asked how they will survive if they will be threatened. He urged that they will not give the hill for mining.

5. **Sri Bibhuti Kuldip, Mania**

He described about the importance of Koraput district & stressed upon the employment of their survivability. Further he demanded drinking water, school & college for education, medical facilities & protection of environment. He cited the example of development in Damanjodi & Sunabeda due to industrialisation. He requested for overall development of the locality by NALCO.

6. **Sri Krushna Chandra Jani, Ex-Sarpanch, Pottangi**

Sri Jani seeks clarification from NALCO regarding the peripheral development work such as roads, school, college, plantation etc in the nearby Gram panchyats. He urged that NALCO could have made development of education, worship places etc. in 58 panchyats under Pottangi constituency prior to go for mines. He informed that medicinal plants existing in the Deomali hill & expressed that their qualified youth are not getting any job in NALCO. He supported the views of previous speakers and demanded for overall development of the locality before going for mining. He emphasised on education for the local before going for mines to avoid nuisance in their locality. He opposed the project since no development work carried out by NALCO in their locality.

7. **Sri Balaram Barik, Pottangi**

Sri Barik enquired about the employment provided by NALCO to the people of Sunabeda, Pottangi & Nandpur Block since 1980. So how Serubandha Hill will be given for mining. He informed that they are consuming stream water but no water supply to their house hold. He expressed his concern over the pollution and reduced flow in streams & non construction of Samara Dam for better utilisation of water in irrigation & drinking water supply. He expressed his dissatisfaction for not getting any employment in NALCO by the youth of Pottangi Block. He told that they will not give an inch of land to NALCO until the development works like irrigation, health & education facilities etc. not provided. He told that they may consider the proposal of giving Serubandha hill for mining only after fulfilment of their demands. Further he apprehended the pollution problems & climate change due to mining. He urged that after seeing the developmental work of NALCO another public hearing to be conducted for further consideration of proposed mines.

8. **Sri Bhagwan Khara, Sarpanch, Pottangi**

He stressed upon the skill development & to provide employment for the local youths. He emphasized to give priority on education followed by environment for development. He also enquired about the peripheral development undertaken by NALCO in the four Gram panchyats. He further informed that there is sufficient water available for drinking and for irrigation in pottangi and seeks clarification on steps to be taken if there will be water scarcity due to mining. He requested to extend NALCO bus facilities for the locals to Vizag in emergency.

9. **Sri Nrusinghanath Behera, Ex-Chairman, Pottangi Block**

Sri Behera informed that they are opposing to give Serubandha hill to NALCO since long due to pollution & impact on environment. He urged that the project proponent should implement the preventive measures in ground not in paper for protection of the environment. He suggested the utilization of ash from the ash pond for the growth of brick manufacturers. He informed that this area is agriculturally rich and exporting grains and vegetables to other states. Further he suggested to setup food processing industries in this area to generate employment for unemployed youths. While drawing attention on unemployment problems of the locality he suggested NALCO could have extended help to set up ancillary industries to address the unemployment issues.

He told that NALCO has not done any peripheral development work except helping few students for education & street lighting facilities. Further he enquired about Rs 54 Crores deposited by NALCO at District Administration for peripheral development. He suggested that NALCO should initiate developmental work before thinking for mining. He also demanded for digital class room, library, auditorium, CHC Pottangi as Medical College, Drinking water facility etc. He also expressed his concern over the condition of worship place if NALCO takes the hill. Further he suggested to construct a dam at Madhur nallah for irrigation, water supply and fish

culture. He urged that NALCO should give commitment for overall development of the area, Protection of the environment & Training to the local ITI students so that they can allow NALCO for mining. He recommended that Government can give mines to NALCO only, not to any Private company.

**10. Sri Saptagiri Ullaka, MP, Koraput**

Hon'ble MP Sri Ullaka describes the inception of NALCO and felt proud NALCO as Navaratna Company. He clarified that there is not only direct employment opportunity in mines but indirect employments are also available. The different problems of the area can not be solved by NALCO alone but the responsibilities also lie on State Government, Central Government and District Administration. He assured that the mines cannot be established without the consent of the local public. He expressed that NALCO has spent money but no remarkable developmental works has been done and urged that the developmental plan can be jointly implemented by NALCO, District Administration & public. He informed Rs 54 Crores paid by NALCO has been sanctioned for developmental works & suggested to implement different developmental projects like school, irrigation & environmental protection in peripheral areas in consultation with public. He expressed his concern over the pollution aspect & water scarcity due to mining. He also emphasised on sustainable development. He told that though NALCO is a Navaratna Company, but people are not getting benefits. He suggested for development of small, medium & ancillary downstream industries for generation of better employment opportunities for locals. Further he had drawn attention on issues like schools, colleges, Pollution, employment & peripheral developments & asked NALCO to come up with action plans to redress those issues. He also expressed his concern over the problems of land displaced people & related employment issues. He again asked NALCO to come up with the time bound proposal for developmental activities in periphery of the mines to implement in consultation with local leaders & public. He urged that NALCO should find ways to resolve the issues of displaced people & employment problems. He assured the public that only after their consent mine can be established. He also insisted that the mines should be given to NALCO instead of any other private company.

**11. Sri Ramchandra Kadam, Ex-MLA, Pottangi**

Sri Kadam expressed that the pollution due to industries & Municipality wastes in the state are not properly addressed by Pollution Control Board. He expressed his dissatisfaction that Pollution Control Board, Rayagada did not address his earlier complaint properly. He also expressed his concern over the poor governance for the local adivasi people. He informed that it is a agricultural Block particularly for cash crops. In spite of continuous efforts spices industries in this region could not be established. He also expressed his concern over the compulsion for selling of Ginger & vegetables by local farmers at very low price due to lack of cold storage. He appreciated the hospitality extended by adivasi people of Koraput. He informed that these hills of this area are full of natural recourses, so everybody trying to displace local adivasis. He told that even after 35 years of establishment of NALCO no developmental benefits and quality education reaches to the local public. He blames the prevailing education system for not bringing them into main streams. He appealed to provide proper education and support for development of the locals to be a part of main streams. Further he asked NALCO to provide corpus fund for higher education i.e. Graduation & Post Graduation of the local students to become eligible for proper employment in NALCO. He also told that in spite of many schemes launched by State & Central Government the district administration could not able to disburse which could be utilised for making roads, model schools & drinking water supply. Further he clarified that he can't go against the public opinion. He also advised NALCO to gain confidence of the public. While citing the example of water pollution problems in streams due to mining & subsequent suffering of local people of Laximpur area he urged that the apprehensions of the

locals should be addressed. He further expressed that hills are the beauty of Koraput & they are getting water, clean air, foods & forest produce for their living from hills. He stressed that NALCO should gain confidence of the local people before establishing the mine. He also expressed his concern over the changing climate of the locality. Finally he clarified that they have no objection for NALCO subject to development & prosperity of the local people.

**12. Sri Bhagwan Golari, Maliput**

Sri Golari questioned on the peripheral development work carried out by NALCO & demanded for development. He expressed his concern over dust pollution in Kakiriguma area and apprehended similar situation in Pottangi. He informed that NALCO is sending the local tribal students to KISS since last two years & when they will back with ITI/B.Tech qualifications then they may consider to handover mines to NALCO.

**13. Smt. Golari Manika, Dumuriguda**

Smt. Golari informed that their livelihood completely depends on forest & forest produce & the hill forest is full of wild animals like tigers & Bears. She questioned on survival of their cattle if grazing fields will be handed over. She expressed that they collect fire wood from forest for cooking & also expressed her dissatisfaction over the poor distribution system of LPG. She apprehended that there will be no development for the local poor people where others will be benefitted. Further she informed that they are going to Sunabeda, Damanjodi & Similiguda as daily labourers & they are not going to be benefitted even this mines get operational. She apprehended that their land, forest etc. will be taken away then their livelihood will be affected. She urged that their interest should be protected prior to any decision taken for the mines.

**14. Sri Sunil Kumar Kara, Nuagaon**

Sri Khara informed that conversion of Forest land to non forest purposes for Mines was discussed in Pallisabha & then in Gramasabha & they opposed it in both meetings. He questioned that why it is again discussed in this hearing. Further he complained that the displaced people due to mining of gems stones & other industries in Koraput district have not been rehabilitated. Further he stated that even after 30-40 years of establishment of NALCO no development activities like education, water supply etc. has been done. So, all people of six Panchyats are opposing. He further stated that no developmental activities have been undertaken in local villages & hence they are against the proposed project. He emphasised on the protection of natural resources.

**15. Sri Jayaram Pangi, Ex-MP, Koraput, Pottangi**

Sri Pangi described the history & inception of NALCO in the area and his contributions towards establishment of NALCO. He explained the development of the area due to industrialization at Sunabeda & Damanjodi. He stated that there were no educated people during inception of NALCO but now the situation has been changed. He stressed upon the employment of local graduates in the project and barred the outsiders. He expressed his dissatisfaction for not providing employment opportunity by NALCO for his villagers. He informed that employment opportunity in mines is limited & suggested to set up a cold storage by NALCO in this area as the vegetable production of this locality is high & supplying to all over Odisha for benefit of the farmers. He strongly recommended for establishment of agricultural based industries like ginger, turmeric & chilli processing plant etc. for resolving unemployment problems of local educated youths. He also expressed that NALCO has not given training to the local youths for getting employment in mines. Further he explained that pollution related to Bauxite mines is less in compare to that of Iron & Manganese mines.

He informed that the hill meant for mines is the origin of upper Kolab reservoir & the left part of the mine is having cat's eye deposit. He suggested that should co-operate to develop Deomali hills for tourism to generate employments for local youths. Citing the example of Bhora cave in Andra Pradesh & Kailash Giri in Vizag he suggested that the Nageswar hill having seven caves is having lots of potentiality for employments for local youths. He strongly recommended to develop eco tourism in the area to avoid pollution. Further he suggested NALCO has to carry out plantation in hills which has been destroyed due to Podu cultivation by the locals for their survival. He also informed that the Nilgiri plantation in hills leading to water scarcity problem in the areas. He urged that the problems of six Panchyats first needs to be addressed by NALCO and then the proposal will be considered.

**16. Sri Banka Mohan, Retd. Agricultural Officer, Pottangi**

Sri Mohan described about the importance of Deomali Hills. He told that local people learnt how to cultivate vegetables when he was Agricultural officer & the water from hills being used for agriculture. Also described about the paddy cultivation practices in the locality. He questioned the public whether they can give hill to NALCO in exchange of employment. He expressed that land losers of other projects are still neither get compensation nor employment. He further expressed his dissatisfaction for not getting employment by local people in HAL & NALCO. He argued that Deomali Hill should not be given to NALCO.

**17. Sri Ranjit Kumar Pangl, Turia, Karanjaguda**

Sri Pangl informed that Gramsabha was conducted in 06 Gram Panchyat & decision was taken not to hand over the Hill to NALCO for mines. He suggested that this hearing could be conducted for asking the people for their consent. Referring to PESA Act, 1996, he told that the decision of Gramsabha cannot be changed & the Forest, land & water resources belong to local peoples. He strongly argued that the hill can be given with consent of Gramsabha. Citing the example of Niyam Giri hill he appealed to the public that being educated weather they will stop it or not. Again he expressed that poor people are getting exploited & urged to postpone the meeting.

The Regional Officer, SPCB, Rayagada read over the issues raised by the public in the hearing with certain interruption.

The issues raised by the public and corresponding comments of the applicant were prepared in Odia and English and it is annexed with the proceedings as Annexure-I & II respectively, list of the participants and oral deliberators in the hearing is annexed as Annexure-III & IV respectively. One written representation (Same copy also received through E mail by RO SPCB, Rayagada, dtd 16.11.2019) received during public hearing, another received at venue after hearing & one more written representation received through E mail by RO SPCB, Rayagada, dtd 15.11.2019 is annexed as Annexure-V. The videography of proceedings are recorded and submitted as DVD (I&II).
