In the reference 6th cited, the Executive Engineer, Public Works Department, WRD, Mining and Monitoring Division, Trichy has submitted three copies of Mining Plan, for approval of sand quarry an extent of 20.00.0 Hectares, in S.F.No 217(Part) of Mangammalpuram Village, Lalgudi Taluk, Tiruchirappalli District along with the areas belongs to Tiruchirappalli District.

As per the Rule 41 & 42 of Tamil Nadu Minor Mineral Concession Rules, 1959, the Mining Plan is hereby approved subject to the following conditions for the area belongs to Tiruchirappalli District only.

- I. The Mining Plan is approved without prejudice to any other Law applicable to the quarry lease from time to time whether such laws are made by the Central Government, State Government or any other authority.
- II. This approval of the Mining Plan does not in any way imply the approval of the Government in terms or any other provisions of the Mines and Minerals (Development and Regulation) Act, 1957, or any other connected laws including Forest (Conservation) Act, 1980, Forest Conservation Rules, 1981, Environment Protection Act, 1980, Explosives Act, 1884 (Central Act IV of 1884) Minor Mineral Concession and Development Rules, 2010 and the Rules made there under and the Tamil Nadu Minor Mineral Concession Rules, 1959.
- III. The Mining Plan is approved without prejudice to any other order or direction from any court of competent jurisdiction.
- IV. Quarrying shall be done as per the approved Mining Plan and that the Mining Plan is approved without prejudice to any other law applicable to the quarry lease from time to time whether such laws are made by the Central Government, State Government or any other authority.
- V. If anything is found to be concealed as required by the Mines Act in the contents of the Mining Plan and the proposal for rectification has not been made, the approval shall be deemed to have been withdrawn with immediate effect.

In view of the above a new sand quarry proposed in Coleroon river in SF.No 217 (Part) to the extent of 20.00.0 Hect., in Mangammalpuram Village, Lalgudi Taluk, Tiruchirappalli district mining plan is hereby approved for a quantity of 5,00,000 CBM of Sand for a period of Two (2) years.
