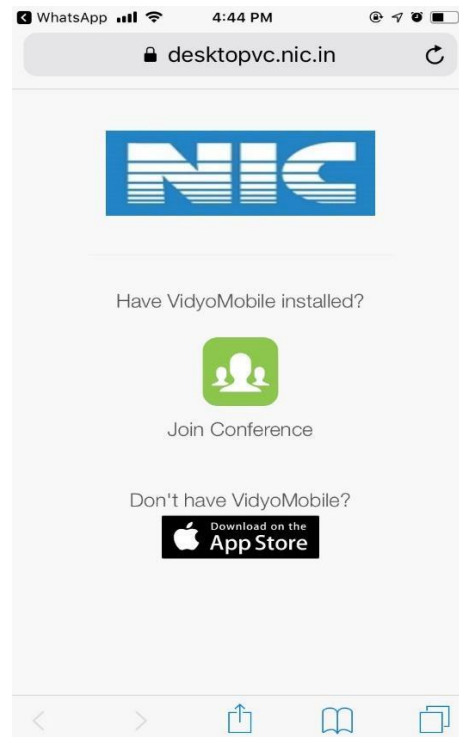
3. Enter your name. select the audio and video devices being used and join video conference.
