Authority. Further, it was appraised that said Project Proponent (PP) has failed to submit the

compliance in spite of reminder stretched over a period of four months. Accordingly, the

Authority has decided to initiate suitable legal action as mandated in the EIA Notification,

2006 (as amended).

Further, in response to the complaint received from Colva Civic and Consumer Forum

(CCCF), Colva, as regard to the issuance of the environmental clearance (EC) to M/s Akar

Creations Pvt. Ltd., Margao, the Authority has decided to invite both the parties to appear

before the Authority for personal hearing during its next meeting.

In addition, Authority has decided to forward communication to the Town and

Country Planning (TCP) Department with a request to send information (preferably taluka-

wise) about proposed developmental activities / construction projects exceeding 20,000

sq.mts. of Built-up Area (BUA) in the State which have been received / processed / in the

process of consideration by the TCP since last six months. This will enable the EIA Goa State

Secretariat to screen / appraise such projects and issue suitable directives to the TCP as per

the provisions of the EIA Notification, 2006 (as amended).

Meeting concluded with a vote of thanks to the Chair.
